









South Street South Reconstruction Project From Old Slip to Fulton Street

Logistics:

- Construction Schedule: January 2015 through November 2015
- Construction work will be performed 2 blocks at one time
- Work will begin on the West side of South Street then move to the East side.
- South Street will be shut down to 2 lanes of traffic, one lane in each direction,
 North and South
- No parking will be allowed on South Street
- The Bike lane will remain open and relocated onto the Esplanade
- Sidewalks will be a minimum of 5 feet wide and will remain open at all times
- Pedestrian Crossings on South Street will remain open at all times within the 2
 block work zone and will be guided by Flag Persons

South Street South Reconstruction Project From Old Slip to Fulton Street

The Work:

West Side of South Street

- Existing curbs will be removed and replaced with new granite curb and drainage catch basins will be installed.
- 2. Removal and replacement of the roadway.
- 3. Removal and replacement of the sidewalk.
- 4. Installation of the street lights, traffic signal poles and tree openings.

Once the West side is complete the work will move to the East side of South Street working North to South.

East Side of South Street

- 1. Installation of new drainage line, catch basins and manholes. Con Ed and ECS relocation work will also begin.
- 2. Installation of new granite curb.
- 3. Removal and replacement of the remaining roadway.
- 4. Installation of street lighting and traffic signals.
- 5. Installation of the final asphalt roadway over the concrete roadway and completion new striping.








CLIMATE DANGER
