Rank Choice Voting Primer - Kathleen Daniel Civic Engagement Commission, NYC (2 min)

- Chief Democracy Officer Encouraging those to vote.
 - Democracy NYC NYC non-partisan initiative to "Stop the Drop" between registration and actual voting.
 - Do "Teach-ins" to help people understand candidates and voting.
 - What's on the ballot? Our budget: Closed ballot; meaning only those that are signed up as a Dem or Rep, they will vote in June in primaries. Everyone else will vote on it in Nov.
 - Mayor, Comptroller, City Council, Public Advocate, MBP, DA, Judge positions, county positions; All of the major roles.
 - Rank choice voting
 - You don't have to rank
 - Vote NYC to find your poll site.
 - Free translation services
 - Transportation available
 - You do not have to show ID to vote unless you did not complete it when you registered.

 - No rank choice in Nov.

- 18yo is voting for the first time. What kind of ID?
 - School ID is fine if they're still in school. Get Real ID ASAP because it's harder to get after graduating.
 - Has to be photo ID
 - You can pre-register 16/17yo
- Alice
 - Early voting and mail in ballots
 - Anybody in NY State can request a mail in ballot
 - You can drop it off at the poll site or mail it back post marked by June 24th
 - Early voting starts June 14th
 - A link to register online is being emailed.
 - Early voting sites are different from election day. Hours are different.
- Richard
 - Online for mail in the ballot. What's the difference between absentee ballot
 - Absentee = is used you're going to be absent during the election cycle
 - Mail in = New law; anyone that is registered can ask for a mail in ballot; no reason needed.

- Christine: DOT meeting; street never repaved for over 20 years; Should property managers go?
- Rosa: Elaborate on resilience funding.
 - They do believe the shortfall would be covered by the city budget.
- Why not go after sellers and organizations.
 - This would go after both.
- Alice: Thank you for the support of the park, Barnett Newman, took 11 years. June 10th, soft launch.
- Bob: Want to mention that the plan for city hall called for expansion over 3 years, those slots do not come to CB1. Afterschool for all is not going to happen.
 - Bring back to the office.
- Assembly Member Deborah Glick office In transit; report submitted electronically
- Assembly Member Grace Lee office -
 - Alex: In Albany, first meeting since the budget passed.
 - Lowest income tax rates
 - expands empire child tax credit, expands to \$ 1,000 per child under 4
 - Support settlement priorities, restored to \$4M
 - Two priority bills passed committee
 - Brownfields
 - Survey bill
 - AAPI summit on May 29th
 - May 30th Day of workshops. Bus space available.
 - Bob: No increase in city funding of DYCD to help those that support childcare.
 - John: Sr. are suffering with SCREE DREE issues. 40% of income being used for housing. It's hard. Sr. needs help.
 - Alex reach out to the office. Share bill number.
- Manhattan Borough President Mark Levine's office -
 - Sean Brannon
 - Congrats to new members
 - Maximum term limit info available on website.
 - Levine attended a press conference that introduced a bill to address fraud and not approved sellers.
 - Tricia:
- Congressman Dan Goldman -
 - Goldman in person

- Things are getting worse in DC re: Current Federal Administration. More aggressive on pushing his agenda and taking over the federal gov't.
- Trying to anticipate where he's going next
- Reconciliation bill bad for those that vote for it (Dems)
- Likely to come back from the Senate.
- Optimistic re: Supreme court decisions.
 - No real threat from the Current Administration; can't actually do anything.
 - Now it means whether the Supreme Court wants to hand over power. Likely not.
- Paying attention to funding and staffing cuts and coordinating on litigation
- Actively involved in legal strategy
- BBJ Met with Org to discuss a revised proposal to potentially relocate the jail re: Executive Comm video
 - $\circ\;$ recommending waiting for new administration after deconstruction is complete.
 - Funding is a separate issue
- Working aggressively on victim funds to make sure they're reinstated and funded.
 - Staffing cuts are really problematic. The director is reinstated.
 - Bipartisan support need to escalate advocacy with NY Republicans who have supported this.
- John S.: Srs nervous re: cutting vouchers by Federal Administration. I would like to meet with Goldman's office to understand what this means.
- Jarred: Resiliency funding on the west side North of North Moore, which is not covered by BPC. Is there any update?
 - Met with Army Corp leadership in NY and they are still moving forward without interruption on revised HATS study. The next focus is to get the city more engaged. That area is more complicated because it was recently renovated.
- Rosa C.
 - Re: Resiliency on East side funding at risk. Can you help us get these to a point of safety?
 - Goldman's strategy with this administration, figure out how to frame it to fit with this administration's approach.
 - Will likely have to litigate
- Richard C.: Horrific budget cuts, but the funding for USAID for overseas health protection. In NY, we're most endangered. Is there any discussion to restore those? How can NY be protected?
 - John Varasso (Republican in Senate) said that he recently traveled to Africa and the refugee camp and said the people need to be fed. Drawing distinction between the services USAID provides and some other programs. This is encouraging.
- Sean S. : Bipartisan opportunities to sponsor helicopter noise
 - Does a lot of work, but didn't co-lead because it didn't differentiate between electronic and non-electronic helicopters. EVOLs wouldn't be available for tourist flights.
 - Working on a different bill with Menendez that is more comprehensive.
- Alice B.: What do you see in store for NYC over the next four years? Any qualities we should elect to help address this?
 - The Mayor and Governor have a different job and they should be more strategic on how they approach the federal government.
 - Shouldn't just run to oppose the current administrator.

- Justine C: Thank you because she's very frustrated with the back and forth of WTC funding.
- Cody 1: re: Higher Education; Do you foresee the banning of international students expanding to other schools
 - Congress had a hearing and learned more about issues on campus. Using Harvard as a threat for other schools. Using Harvard and Anti-semitism to attack Harvard. Focused on where he can get the biggest splash.
- Christine D: On Bill and what's hidden in it. Forcing courts; do we have any power over that?
 - The hardest part about the bill is that there are so many bad parts, so not addressing them individually. This clause makes it harder to enforce contempt orders. We can get it removed on the Senate side.
- Morton: Treatment of legal permanent residences at borders. They're going after non-criminal people. Is there opposition to this across the aisle?
 - Yes, there's opportunity because there are Republicans against immigration issues.
 - DHS is moving to dismiss their own cases, so asylum cases are dismissed and have to reapply.
- The policies being pushed through are terrible for their own constituents and NY. The more we can be talking to people and be engaging; it matters.
- Alice: How many people applied to CB 1
 - will follow-up
