- Paul Elkos Sailor at North Cove Sailing since 2017. Since joining the club, have shared Battery Park with family and friends. Run a sailing camp. Urge to please help keep sailing alive in North Cove.
- Sam Han Resident of BPC since 2003, member of North Cove Sailing club. Has enhanced the community to expand connections with the club to other parts of the community and club.
- Melanie Moore Part of Sailing club, but with resiliency planning this would be removed. (reach 5, phase construction to keep part of the Marina open. Bring in a qualified mariner to keep the sailing club running. According to the revitalization program, access to the water must be maintained and enhanced. State law and city law support this. Asking for solution that supports both resilience and the marina
- Brendan Clark on a sailboat, calling from North Cove Sailing Club. Keep the marina open during the 4 year construction for resiliency. Member for five years. Family and friends have leveraged this amenity. This was one of the large reasons he moved to the area. The laws support community access for sailing.
- Alise van der berg Member of North Cove and a resident of BPC. in BPC since 2010.
 The sailing community is important to the community. Encourages socialization in the community.

<u>Topic: Feasibility Study for a Contiguous East River Waterfront Park</u> - David Ludwig CB1 Community Planning Fellow

- Eric Yu: When non-profits are created, does the Parks department still contribute the same amount?
 - In Central Park, it's all on the conservancy.
 - o Contribute horticulturalists and other services.
 - Laura Starr: Parks could not reduce the formula of money going to Central Park.
 - CHair: How the city allocates funding has to due with expense and capital. Doesn't make it easier to get things done. Helps to streamline. E.g. Gotham park would have had bathrooms the day they opened. But they don't, eventually they will. Another organization to bring the problem forward. DOT has a lot of focuses, so having an organization allows you to be able to focus funding. Gotham Park and Rosa Chang are good examples of advocating.
- Morton: Fan of tennis and has a great community downtown. Appreciate the additional courts. Heard they plan to build more courts. Park is continuous and difficult finding the courts.
 - Request information from Parks Dept.
 - David: The idea is to connect the spaces for walking and to make it so that people have an easier time getting to other amenities.
 - Difficult for city agencies to connect.
- Richard: Cited tremendous variance between different parks. Sense as to what a minimum or target number provides for a vital park?
 - David: Wouldn't go as far as an actual number, \$4M in revenue is generated today in part of the East River, so that's already a great starting point. \$235K/Per acre assuming 17 acres of land.

 - vii. Justine: Falls office email, on July 17th and 24th were at Battery Place.

 - i. The deputy mayor took a tour last month.
 - ii. After the tour, considering time and effort, there were many on the tour, and the second week in June.
 - iii. Response from the city received by the board: The community has asked for a 1:1 meeting and still haven't gotten it after asking for a year. We got 10min. Requested the meeting being held at or near school, that was not allotted. Brought up some things, but not covering all. Letters will be shared and distributed to the community. Discrepancies between what providers said and what is documented. No change in
 - iv. Mariama: Suppose to come to QoL two days later and said the 10 min should suffice.
 - v. They've declined to come and talk to us about anything.
 - vi. Robin: The letter from the administration talked a lot about the administration and has questions about federal support and otherwise. The Deputy Mayor is taking a city-wide approach. The time frames have not been established. Nothing is imminent.
