#### March 2023 Full Board Minutes

Meeting of Community Board 3 held on Tuesday, March 28, 2023 at 6:30pm via Zoom.

#### **Public Session:**

Amy Chin, from Think! Chinatown. Speaking on street co-naming Corky Lee Way, Moscow Street corner of Mott Street. The co-naming would honor his contribution to life in Chinatown through his photography and his advocacy.

Daniel Lewis, from OCA Asian Pacific American Advocates in support of street co-naming Corky Lee Way – We lost Corky during the pandemic. In the process of requesting this co-naming, we collected over 1000 signatures in support of the co-naming of Moscow Street at the corner or Mott to Corky Lee Way. Naming the street will inspire others to serve the community as Corky did.

John J Lee from Corky Lee Estate speaking on street co-naming Corky Lee Way – Thank you for taking the opportunity to honor my brother. We were the American born children of Chinese speaking parents. They instilled a since of service to our community in their children. Through his photography, He captured the synergy of not just Chinatown but the nation. Through his eyes we saw ourselves. Mr. Moscow who championed fair housing and fought unfair evections. The Moscow family said they would be honored to share the street name with Corky.

Jan Lee – Thank you for taking the time to consider the street name. Corky is an icon in Chinatown. Co-naming the corner of Moscow and Mott is honoring two immigrant men who did so much for the two communities that occupied this area – Italian and Asian communities. This will be a permanent reminder to understand the unity of downtown NY.

Vincent Jenkins, JBFCS Tanya Towers Inc, regarding public safety - Here on the LES we want to make sure we have enough housing for ppl w/ disabilities and the elderly. We want to make sure they are cleaned up and no drugs. The cops are not doing anything in a long time. It seems like the communities need to be more cleaned up. Mayor Adams has done nothing for the LES. He ignores homeless deaf. They have rights to have interpreters in the shelters. If the shelter continues to ignor this law the shelter can be sued for lack of interpreters.

David Troutman, speaking against SLA item #7 – I live on Orchard Street. This street is overloaded with bars. The quality of life is not good. Three new locations are coming to the area next month that were previously unlicensed. Something must be done limit the number of these locations in oversaturated area.

Patricia Walsh LES Dwellers, against SLA item #5 - I am trying to raise my family here. It is impossible. In over 20 years of attending SLA meeting. I have never seen such poor treatment of residents. I plead with you to not allow this to continue.

David Meclonis, LES Dwellers, speaking against SLA items 5, 6, 7 – As we have often found, out of 48 signatures collected for the new licenses on Stanton Street only 2 are valid residents. For Orchard only 9 were valid. Most were from nonresidents. We feel like these licenses are being rubber stamps. We have two pot stores in the area. The residents will have to deal with these locations catering to the drunks and drug users during all hours Jeanne Mullen, LES Dwellers, speaking against SLA item # 5, 6 - All past tenants who have occupied this space have been an acoustic nightmare. It's too much. It doesn't matter how nice the food is or how nice they want to be. It's just too much. We don't even have a laundry mat.

Jill Graves, speaking against SLA item #7 - I live on Suffolk street and there have been a few violent incidents. It's a real problem.

Marcell Rocha, Orchard Street Block Association, speaking against SLA item # 7 – Oversaturation is an overstatement. One big concern is the hours that were suggested. Establishments need to prove themselves first before being granted a full liquor license.

Pamela Primi – We are seeing luxury units increasing in new buildings in our area. There is a zoning loophole that allows only a few units of affordable housing to be included in these new builds. This is affecting the ability of middle and low income residents to remain in our area.

Juan Rivero – From Village Preservation – The 100th Business of the Month has been named. Please visit our website to learn about this business. Our organization si currently advocating to have the PS 64 building returned to the community. We held a rally in opposition to lift the FAR cap to prevent the displacement of residents.

Laryssa Shainberg – Razom, the organization aiding the resettlement of Ukrainian refugees is happy to announce the opening of their new office at 98 2nd Ave. The office hours are Tuesday – Friday 10-3. During office hours you may drop off donations of clothing, hygienic items, or household items. The hygienic items are in short supply and would be most helpful

Tamara Daily – None of our oppositions to the SLA resolutions were added to the resolution. There seems to be a double standard for those who support and oppose the resolutions.

# State Senator Brian Kavanagh, Patricia Olan:

It is budge season. We are working toward finalizing. We are looking to adequately fund the MTA and adjust the minimum wage for inflation. Increase funding for public schools.

We are emphasizing increasing affordable housing in the areas surrounding the city. Good cause eviction is a huge issue in our community. This will protect a lot of these tenants. WE are working on addressing the illegal cannabis shops with legislation. All residents except those in public housing have been covered under the covid emergency housing funding act. I am working to add those in public house to be included in this as well. We've proposed legislation for same day registration / voting on the first day of early voting. We are committed to getting the Rivington house bill passed shortly.

# Councilmember Christopher Marte, Jennifer Chiao:

47 Mott St.: We were able to contact all tenants. 19 units are free of structural damage. 2 units have structural damage. All have temp housing.

We are Introducing a bill to tackle scaffolding abuse.

The councilmember is oppose to raising the FAR cap. It would not guarantee affordability.

We are asking that 1 percent of city budget be set aside for city parks in the Play Fair bill.

WHEREAS, the basis of the design intent is to preserve the remaining two-story street facades onto Mulberry Street and Bayard Street and the six-story stair tower facades; and

WHEREAS, geotechnical information and input from the Construction Manager are required to verify the technical strategy and that the cost is within the budget; and

WHEREAS, the project will have six floors above grade, with the sixth floor set back from the property line, and the stair tower will be prominent as the original Snyder design; and

WHEREAS, the design will celebrate the historic facades and distinguish the new and the old envelopes; and

WHEREAS, the new building will provide three elevators and three egress stairs for code compliance and accessibility; and

WHEREAS, the flexible spaces can be adapted to new program needs over time; and

WHEREAS, six street trees will be planted along Mulberry and Bayard streets; and

WHEREAS, the stoops and egress stairs currently protruding to the pedestrian will be removed to provide a better pedestrian experience for the community.

THEREFORE IT BE RESOLVED CB 3 supports the above-described preliminary design of 70 Mulberry Street, which will be brought back to the Community Board for the next phase.

Community Board 3 Support for Street Co-Naming of Mosco Street Between Mott Street and Mulberry Street as "Corky Lee Way 李揚國路"

**WHEREAS**, Corky Lee was widely recognized and celebrated nationally and internationally as the "Undisputed, Unofficial Asian American Photographer Laureate"; and

**WHEREAS**, Corky Lee tirelessly served New York City Chinatown and other Asian-American communities throughout his prolific career as a photographer, journalist, activist, advocate and leader for over 50 years; and

**WHEREAS**, Corky Lee, a lifelong New Yorker and community organizer, has mentored and continues to inspire many generations of Asian American students and fellow activists; and

**WHEREAS**, Corky Lee's unparalleled body of work consisting of an estimated 800,000 photo images chronicling over half a century of Asian-American history and life in New York City and beyond has filled in significant gaps and omissions in American history; and

**WHEREAS**, Corky Lee attended virtually every Asian American event in New York during his lifetime, camera in hand, and had a major impact as a photojournalist who relentlessly pushed for greater representation for and exposed injustices to Asian Americans across the United States; and

WHEREAS, Corky Lee was pivotal in the founding and/or establishment of several New York cultural and civic groups including the Basement Workshop, Asian American Arts Alliance, New York Chapter of the Asian American Journalists Association, the Sons of American Legion-Lt. B.R. Kimlau Chinese Memorial Post 1291, 21 Pell Street, and many others; and

**WHEREAS,** in his self-proclaimed "Act of Photographic Justice", Corky Lee remade history at the 145th anniversary of the transcontinental railroad at Promontory Summit, Utah, by gathering over 250 Chinese Americans to recreate the historic commemorative photo and correct the fact that 12,000 Chinese who completed the railroad in 1868 were literally left out of that picture; and

**WHEREAS,** Corky Lee advocated for and helped create a Chinese language voting ballot that increased Chinese American electoral participation in New York City; and

**WHEREAS,** Corky Lee lobbied with other AAPI activists for Congressional gold medals for the more than 25,000 Chinese American World War II military veterans and succeeded in getting S.1050 - Chinese-American World War II Veteran Congressional Gold Medal Act passed by the 115th Congress; and

**WHEREAS**, Corky Lee was a beloved, respected and leading presence in Manhattan's Chinatown, including serving as a Sons of American Legion commander at The American Legion, Lt. B.R. Kimlau Chinese Memorial Post 1291 on Canal Street; and

**WHEREAS**, Corky Lee's contributions were recognized by then Manhattan Borough President David N. Dinkins in 1988 by proclaiming May 5th 1988 to be Corky Lee Day and Corky is well known throughout the United States and other countries; and

**WHEREAS**, the iconic newsstand on Mosco Street, at the intersection of Mott Street in the middle of Manhattan's Chinatown, is the site of Corky Lee's final photography exhibition where he pioneered a joyful place for community gathering, public celebration and healing that continues today for current and future generations; and

**WHEREAS**, the intersection of Mosco and Mott Streets is home to some of Corky Lee's regular Chinatown 'haunts' where he would often work, hold court and chat with friends and strangers alike over coffee or a meal; and

WHEREAS, Mosco Street is named in honor of Frank Mosco - another legendary and celebrated community hero, and co-naming Mosco St for his friend and fellow activist Corky Lee would be a significant reminder of the historic relationship between Italian-American and Chinese-American communities in this neighborhood and their common efforts to make the world a better place for current and future generations; and

**WHEREAS**, a petition for co-naming the one-block-long Mosco Street "Corky Lee Way" demonstrated substantial neighborhood awareness and support with 941 petition signatures including 20 businesses and residences on Mosco Street, 251 from the adjacent Chinatown area, and 670 from the rest of CB 3 and beyond, and

**WHEREAS**, over two dozen community letters supporting the co-naming of Mosco Street "Corky Lee Way" were submitted to Community Board 3;

THEREFORE BE IT RESOLVED, Community Board 3 supports a "Corky Lee Way 李揚國路" sign beneath the Mosco Street sign on the northwest corner of Mott and Mosco Streets commemorating the life of an outstanding New Yorker, Corky Lee, former Unofficial Asian American Photographer Laureate, Asian American historian, advocate and activist, who spent over 50 years tirelessly serving the Chinatown and broader Asian American communities thereby improving the lives of countless Asian American New Yorkers and other Asian Americans.

WHEREAS, Meltzer Towers, being a NYCHA senior residence located in Community District 3 at 94 East 1st Street; and

WHEREAS, vehicles loading and unloading packages and merchandise, as well as other vehicles, block the entrance to the building—a "No Parking Zone"—creating obstacles for its elderly residents; and

WHEREAS, in New York City, "No Parking Zones" restrict waiting but allow stopping to load or unload packages and merchandise, and stopping to pick up or drop off passengers; and

WHEREAS, the entrance to Meltzer Towers being blocked by the "No Parking Zone" has been a particular problem in not allowing emergency vehicles from accessing the building; and

WHEREAS, "No Standing Zones" restrict waiting and unloading and loading packages and merchandise, but allow passengers to be picked up or dropped off; and

THEREFORE BE IT RESOLVED, that the signs be changed from "No Parking" to "No Standing" to prevent delivery vehicles from blocking its entrances while still allowing vehicles to pick up and drop off passengers.

**WHEREAS,** Tea Bistro Inc. doing business as Basement formally known as Cha Chang Tang, is seeking an alteration and change to the method of operation for the current on-premise license, in the premises located at 45 Mott St., between Pell and Bayard St., New York, New York; and

**WHEREAS**, this is an application for an establishment with a certificate of occupancy of 116 people, 22 tables and 29 seats with 1 bar and 6 bar stools on the ground floor and 1 bar in the basement, serving international casual cuisine during all hours of operation, 4 televisions and DJs in the basement; and

**WHEREAS**, the alteration and change to the method of operation include moving the bar from the right side to the left side of the premises, remove karaoke rooms to replace with seating, reconfigure seating and change the method of operation to include DJ,

**WHEREAS**, this applicant recently resolved a violation with SLA of the 200 ft rule and stated that the school is not used exclusively as a school,

WHEREAS, there are 6 full on-premises liquor licenses within 500 feet per the SLA LAMP map; and

**WHEREAS,** this location has been operating with an on-premise license since 2014 with the following stipulations:

- 1) it will operate as a full-service restaurant, serving Hong Kong cuisine, with dining on its first floor and two (2) karaoke rooms in its basement, and with a kitchen open and serving food to within one (1) hour of closing on both floors,
- 2) its hours of operation will be 7:00 A.M. to 2:00 A.M. Sundays through Wednesdays and 7:00 A.M. to 4:00 A.M. Thursdays through Saturdays,
- 3) it will play ambient background music only, consisting of recorded music, in the first-floor dining room and will have live karaoke in the two (2) basement karaoke rooms but will not have other live music, DJs, promoted events, scheduled performances, except any fee associated with the karaoke rooms, or any event at which a cover fee will be charged,
- 4) it will not commercially use any outdoor areas,
- 5) it will have a closed fixed façade with no open doors or windows and will close any façade or rear doors by 10:00 P.M. every night,
- 6) it will employ a security guard Thursdays through Saturdays who will be located at the entrance to its basement and will ensure that no one under the age of twenty-one (21) enters the basement,
- 7) it will not apply for any alteration in its method of operation without first appearing before Community Board #3,
- 8) it may have "happy hours" to 7:00 P.M. each night,
- 9) it will not host pub crawls or party buses,
- 10) it will ensure that there are no wait lines outside and designate an employee to oversee patrons and noise on the sidewalk, and
- 11) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints; and

WHEREAS, the applicant has been an on-premise license holder at this location since 2014; and

**WHEREAS**, there were 15 commercial 311 complaints at this location with NYPD action necessary since 2018; and

**WHEREAS,** 1 community resident asked for clarifying questions about where the DJs are going to be located, and why the current ground floor location is not being used, how they will address crowding in the future, and 1 community resident spoke in favor; and

**WHEREAS,** 33 residents who live on Mott St. and within two blocks of the location signed a petition in favor of the application; and
