VOTE: TITLE: Resolution to support and advocate on behalf of the NYC retirees to preserve their earned healthcare benefits as outlined and promised in the statute in New York Administrative Code §12-126 when they were hired by the city of NY

WHEREAS, the issue of healthcare is extremely important, and must be protected for the 250,000 NYC retirees, who worked for their health care rights; and

WHEREAS, the proposed administration plan proposes to remove these 250,000 NYC retirees from their current healthcare plan; and

WHEREAS, some of the currently available plans for retirees and their dependents serve as "Medigap" policies, in that they pay for 20 percent of the cost of a medical appointment or service after Medicare pays for its statutorily-required 80 percent. A retiree is then able to see any healthcare provider throughout the United States (including its possessions and territories), as long as the provider accepts Medicare. More than 95 percent of healthcare providers throughout the United States accept Medicare. Medigap policies entrust medical decisions to the physician or other healthcare providers of retirees; and

WHEREAS, the proposed administration's plan would require city retirees to decide whether or not to opt out of the new Medicare Advantage Plan (MAP) run by Aetna, which would save the City roughly \$600 million per year; and

WHEREAS, Int. 1099 of 2023 would require the City to offer Medicare-eligible city retirees and their Medicare-eligible dependents at least one Medigap plan with benefits equivalent to or better than those already available to city retirees and their dependents as of December 31, 2021; and

WHEREAS, the administration's proposed plan would decrease city retirees access to the same level of health care held previously, by requiring pre-approvals and co-payments and will limit the current list of doctors available; so

THEREFORE BE IT RESOLVED, that Community Board 3 supports intro 1099 in City Council to ensure that the City maintain the choice of at least 1 Medigap plan, equivalent to or better than those already available to city retirees and their dependents as of December 31, 2021, and not force retirees into a privatized Medicare Advantage plan.

2. Kid A LLC, 9-10 Chatham Sq (op)

VOTE: TITLE: Community Board 3 Recommendation To Deny Unless Stipulations Agreed To—Stipulations Attached

WHEREAS, Kid A LLC, is seeking a full on-premises liquor license, in the premises located at 9 Chatham Square, between Mott and Pell Streets, New York, New York; and

WHEREAS, this is an application for an establishment of 74 people, 15 tables and 50 seats with a 20 foot long bar and 10 bar stools, a full kitchen serving contemporary French food during all hours of

operation, hours of 5PM to 12AM all days, with ambient background music only, and a closed fixed façade;

WHEREAS, there are 6 full on-premises liquor licenses within 500 feet per the SLA LAMP map; and

WHEREAS, this location was previously an unlicensed restaurant; and

WHEREAS, the applicant has never previously been a license holder but has worked in the restaurant business both in New York and Internationally for 30 years combined; and

WHEREAS, one resident of Chinatown sent an email in support of this application. Six residents spoke in support of this application and one spoke in opposition at the meeting; and

WHEREAS, The Chinatown Core Block Association spoke and requested that they start with beer and wine and did not support the outdoor space for this application and Think Chinatown spoke to request a beer and wine license; and

WHEREAS, 80 residents who live within two blocks of the location signed a petition in favor of the application; and

THEREFORE, BE IT RESOLVED that Community Board 3 recommends the denial of the application for a full on-premises liquor license for Kid A LLC, for the premises located at 9 Chatham Square, New York, New York, unless the applicant agrees to the following signed notarized stipulations that

- 1) it will operate as a French Restaurant, with a full kitchen serving food all hours,
- 2) its hours of operation will be opening no later than 5:00 P.M. and closing by 12:00 A.M all days,
- 3) it will not use outdoor space for commercial use including Open Restaurants,
- 4) it will install soundproofing,
- 5) it will have a closed fixed façade with no open doors or windows except my entrance door will close by 10:00 P.M. or when amplified sound is playing, including but not limited to DJs, live music and live nonmusical performances, or during unamplified live performances or televised sports,
- 6) it will play ambient background music only, consisting of recorded music, and will not have live music, DJs, promoted events, scheduled performances or any event at which a cover fee will be charged. It will have up to 20 private parties per year,
- 7) it will not apply for any alteration in its method of operation or for any physical alterations without first appearing before Community Board 3,
- 8) it will not host pub crawls or party buses,
- 9) it will not have unlimited drink specials, including boozy brunches, with food,
- 10) it will not have "happy hours,"
- 11) it will ensure that there are no wait lines outside [and will designate an employee for ensuring no loitering, noise or crowds outside],
- 12) it will conspicuously post this stipulation form beside its liquor license inside of its business, and
- 13) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints.
- 3. Oti (E3 Hospitality LLC), 40 Clinton St (wb)

VOTE: TITLE: Community Board 3 Recommendation To Deny Unless Stipulations Agreed To—Stipulations Attached

WHEREAS, E3 Hospitality doing business as Oti, is seeking a wine beer license, in the premises located at 40 Clinton Street, between Clinton and Stanton Streets, New York, New York; and

WHEREAS, this is an application for an establishment of 74 people, 11 tables and 23 seats with a bar that includes 8 seats, Romanian-style tapas prepared in a full kitchen and food prep area, serving food during all hours of operation, and recorded music at background levels; and

WHEREAS, there are 15 full on-premises liquor licenses within 500 feet per the SLA LAMP map; and

WHEREAS, the location does not have a current license and has never been licensed before; and

WHEREAS, the applicant has never been a license holder before but has experience working as a chef; and

WHEREAS, there were 2 commercial 311 complaints at this location with NYPD action necessary since 2020; and

WHEREAS, one resident spoke in opposition to the application, specifically the backyard; and

WHEREAS, 19 residents who live within two blocks of the location signed a petition in favor of the application; and

THEREFORE, BE IT RESOLVED that Community Board 3 recommends the denial of the application for a full on-premises liquor license for E3 Hospitality, for the premises located at 40 Clinton Street, New York, New York, unless the applicant agrees to the following signed notarized stipulations that

- 1) it will operate as a restaurant, with Romanian Tapas prepared in full kitchen and food prep area and serving food during all hours of operation,
- 2) its hours of operation will be opening no later than 4:00 P.M. and closing by 12:00 A.M. all days Monday-Sunday.
- 3) it will close all outdoor dining allowed under the temporary Open Restaurants program and any other outdoor uses by 10:00 P.M. all days and not have any speakers or TV monitors,
- 4) it will have a closed fixed façade with no open doors or windows except my entrance door will close by 10:00 P.M. or when amplified sound is playing, including but not limited to DJs, live music and live nonmusical performances, or during unamplified live performances or televised sports,
- 5) it will play ambient background music only, consisting of recorded music, and will not have live music, DJs, promoted events, scheduled performances or any event at which a cover fee will be charged,
- 6) it will not apply for any alteration in its method of operation or for any physical alterations without first appearing before Community Board 3,
- 7) it will not host pub crawls or party buses,
- 8) it will not have unlimited drink specials, including boozy brunches, with food,
- 9) it will not have "happy hours,"
- 10) it will ensure that there are no wait lines outside,
- 11) it will conspicuously post this stipulation form beside its liquor license inside of its business, and
- 12) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints.
- 4. Cozy Cafe (Cozy Cafe Corp), 43 E 1st St (upgrade to op)

VOTE: TITLE: Community Board 3 Recommendation to Deny

WHEREAS, Cozy Cafe Corp, is seeking an upgrade to a full on-premises liquor license, in the premises located at 43 E 1st St, between First and Second Ave, New York, New York. This application is an upgrade from a beer/wine license for this business/location that was used in June 2005; and

WHEREAS, this is an application for an establishment with 12 tables and 52 seats, with a bar with 6 bar seats, with 4 seats at 2 outdoor tables within the building lines, a food prep area preparing Mediterranean, serving food during all hours of operation, 3 televisions, background music with volume control speakers from streaming services/playlists and with DJs on the weekends, with no live music, and no promoted events, no scheduled events, and no events at which a cover fee is charged; and

WHEREAS, there are 11 full on-premises liquor licenses within 500 feet per the SLA LAMP map and 2 on the same block; and

WHEREAS, the applicant is a license holder at several businesses in CD 3:

- A beer/wine license for this business, Cozy Cafe, at this same location since June 2005
- A beer/wine license for 45 First Ave Corp (Aziza Cafe & Lounge), at 45 First Ave, since June 2013
- A full liquor license for Foundation Lounge Corp (Mazaar Bar & Lounge), at 137 Essex St, since April 2015. The SLA disciplinary history shows Case No: 152077 with a \$1,500 penalty on 2/1/2022, and Case No: 117030 with a \$20,000 penalty on 7/21/2017.
- A full liquor license for Cocktail Art LLC (Sanatorium), at 14 Ave C, since May 2016. The SLA disciplinary history shows Case No: 124002 with a \$12,000 penalty on 8/10/2018, Case No: 126668 with a \$1,000 penalty on 6/7/2018, and Case No: 120644 with a \$7,500 penalty on 3/9/2018; and

WHEREAS, there were 15 commercial 311 complaints at this location with NYPD action necessary between April 2016 thru March 2019. The police precinct has reported that there have been 3 311 complaints with police action in the past 12 months, these were all for Cozy Cafe; and

WHEREAS, the First Street Block Association opposed this application for the same reasons they opposed upgrades in 2018 and 2020, primarily complaints about noise related to Cozy Cafe - loud

music coming from inside Cozy Cafe when the front door is open, loud drunk customers exiting Cozy Cafe last at night, and music blasting from cars parked and double-parked in front of Cozy Cafe; and

WHEREAS, the First Street Block association met with the applicant and came to an agreement that the applicant would reduce their hours immediately and if they operate with no problems, when their license is up for renewal in 18 months the Block association would agree to an upgrade at that time. At the meeting, the applicant would not agree to those stipulations; and

WHEREAS, 24 residents who live within two blocks of the location signed a petition in favor of the application; and

WHEREAS, 2 residents spoke in support of this application and 2 residents spoke in opposition,

WHEREAS, the SLA listed the method of operation as tavern serving beer/wine/ cider but they have been operating as a hookah bar with belly dancing,

WHEREAS, given the history of complaints at this location, as well as the applicant being noncompliant with their stipulations and method of operation, this applicant does not appear to be a candidate to comply with SLA regulations; and

THEREFORE, BE IT RESOLVED that Community Board 3 recommends the denial of the application for a full on-premises liquor license for Cozy Cafe Corp, for the premises located at 43 E 1st St, New York, New York.

5. San Marzano (Evir Corp), 117 2nd Ave (upgrade to op)

VOTE: TITLE: Community Board 3 Recommendation To Deny because stipulations were not signed

WHEREAS, Evir Corp. doing business as San Marzano, is seeking an upgrade to a full on-premises liquor license, in the premises located at 117 Second Ave., between East 6th and 7th Street, New York, New York; and

WHEREAS, this is an application for an establishment with 74 people, 22 tables and 62 seats with a bar with 8 seats, with 7 tables with 14 seats outdoors, with a full kitchen serving Italian food during all hours of operation, no televisions, and ambient background; and

WHEREAS, there are 21 full on-premises liquor licenses within 500 feet per the SLA LAMP map; and

WHEREAS, the location is currently Evir Corp. doing business as San Marzano which had the original beer wine license since 2012, effective since 2021; and

WHEREAS, the applicant has been operating San Marzano since 2012; and

WHEREAS, there were no commercial 311 complaints at this location with NYPD action necessary since 2018 there was a DOB violation for the outdoor dining shed attached to the building; and

WHEREAS, 21 residents who live within two blocks of the location signed a petition in favor of the application; and

THEREFORE, BE IT RESOLVED that Community Board 3 recommends the denial of the application for an upgrade to an on-premises liquor license for Evir Corp. doing business as San Marzano, for the premises located at 117 2nd Ave. because the applicant did not agree to the following signed notarized stipulations that

- 1) it will operate as a restaurant, with a full kitchen serving Italian food during all hours of operation,
- 2) its hours of operation will be opening no later than 11:00 A.M. all days and closing by 11:00 P.M. Sun Thurs and 12:00 A.M. Fri Sat,
- 3) it will close all outdoor dining allowed under the temporary Open Restaurants program and any other subsequent uses by 10:00 P.M. all days and not have any speakers or TV monitors,
- 4) it will close any front or rear facade doors and windows at 10:00 P.M. every night or when amplified sound is playing, including but not limited to DJs, live music and live non-musical performances, or during unamplified live performances or televised sports,
- 5) it will play ambient background music only, consisting of recorded music, and will not have live music, DJs, promoted events, scheduled performances or any event at which a cover fee will be charged,
- 6) it will not apply for any alteration in its method of operation or for any physical alterations without first appearing before Community Board 3,

- 7) it will not host pub crawls or party buses,
- 8) it will not have unlimited drink specials with food,
- 9) it will not have "happy hours,"
- 10) it will ensure that there are no wait lines outside,
- 11) it will conspicuously post this stipulation form beside its liquor license inside of its business, and
- 12) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints.
- 6. Two Doors Down (Two Doors Down LLC), 159 E Houston St (op)

VOTE: TITLE: Community Board 3 Recommendation To Deny Unless Stipulations Agreed To—Stipulations Attached

WHEREAS, Two Doors Down LLC, is seeking a full on-premises liquor license, in the premises located at 159 E Houston St, between Eldridge St and Allen St, New York, New York; and

WHEREAS, this is an application for an establishment with a maximum of 148 people, with 12 tables and 55 seats, with 25 bar seats at 2 bars (a 25-foot bar upstairs and a 20-foot bar downstairs), French bistro food in a full kitchen, serving food until 2AM. There will be ambient recorded background music playing on 4 small speakers upstairs and 5 speakers downstairs. There will be no televisions; and

WHEREAS, Security personnel will be hired for the location, every day from 8:00 P.M. until closing - 3 doormen on Fri and Sat, 2 on Thur, and 1 on Sun-Wed; and

WHEREAS, there are 37 full on-premises liquor licenses within 500 feet per the SLA LAMP map, and 7 within one block (per the applicant); and

WHEREAS, This application is a sale of assets of an existing business, 159 Huntington Holdings, Inc, (dba The Late Late), licensed since June 2014, with 4 AM closing hours all days; and

- Case No: 140053 Apr 27, 2022 Sale to a minor on Jan 24, 2020 Civ Penalty Paid: \$5,000
- Case No: 121846 Oct 2, 2019 Non bono fide and failure to conform to application (2 counts) -Civ Penalty Paid: \$11,000
- Case No: 114346 June 21, 2017 failure to comply-unlicensed cabaret on Oct 28, 2016, and failure to conform to application (6 counts) - Civ Penalty Paid: \$7,500

WHEREAS, one of the principals for this application, David Doyle, is also a principal with 90 Wythe LLC, which has had a full o/p liquor license at 44 Berry St in Brooklyn (dba Cafe Balearica) since April 2022; and

WHEREAS, there were 14 commercial 311 complaints at this location with NYPD action necessary since 2018 as well as 5 at the applicant's location in Brooklyn since they began operating in 2022; and

WHEREAS, One resident spoke in regards to problems with live music and open windows; and

WHEREAS, 14 residents who live within two blocks of the location signed a petition in favor of the application; and

THEREFORE, BE IT RESOLVED that Community Board 3 recommends the denial of the application for a full on-premises liquor license for Two Doors Down LLC, for the premises located at 159 E Houston St, New York, New York, unless the applicant agrees to the following signed notarized stipulations that

- 1) it will operate as a bar/tavern, with French bistro food prepared in a full kitchen and served during all hours,
- 2) its hours of operation will be opening no later than 5:00 P.M. Mon-Thur, 2:00 P.M. Fri-Sun, and closing by 2:00 A.M. Sun-Wed, 3:00 A.M. Thur, and 4:00 A.M. Fri-Sat,
- 3) it will not use outdoor space for commercial use, including Open Restaurants,
- 4) it will close any front or rear facade doors and windows at 10:00 P.M. every night or when amplified sound is playing, including but not limited to DJs, live music and live non-musical performances, or during unamplified live performances or televised sports,
- 5) it will employ security every night from 8:00 P.M. until close,
- it will play ambient background music only, consisting of recorded music, and will not have live music, DJs, promoted events, scheduled performances or any event at which a cover fee will be charge,
- 7) it will not apply for any alteration in its method of operation or for any physical alterations without first appearing before Community Board 3,
- 8) it will not host pub crawls or party buses,

- 9) it will not have unlimited drink specials, including boozy brunches, with food,
- 10) it may have "happy hours" until 8:00 P.M. each night
- 11) it will ensure that there are no wait lines outside and will designate an employee for ensuring no loitering, noise or crowds outside,
- 12) it will conspicuously post this stipulation form beside its liquor license inside of its business, and
- 13) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints.
- 7. Vital Lower East Side LLC, 180 Broome St (op)

VOTE: TITLE: Community Board 3 Recommendation To Deny Unless Stipulations Agreed To—Stipulations Attached

WHEREAS, Vital Lower East Side LLC, doing business as Vital Climbing Gym, is seeking a full on-premises liquor license, in the premises located at 180 Broome Street, between Suffolk & Clinton St, New York, New York; and

WHEREAS, this is an application for an establishment with a certificate of occupancy of 150 people. The plans show 12 tables, 48 seats, and one bar with 9 seats. There will be less than a full kitchen, but food will be served during all hours of operation. There are no TVs listed, and music will be ambient, recorded background music only. They are only licensing the second floor; and

WHEREAS, there are 5 full on-premises liquor licenses within 500 feet per the SLA LAMP map; and

WHEREAS, the location is in a new build - Essex Crossing - currently housing Essex Market. The Market Line, Gutter, Regal Cinemas, The ICP, Trader Joes, and over a dozen independent vendors. and

WHEREAS, the applicant currently operates climbing gyms in California, Washington, and New York the Brooklyn location opened in April 2021 with a rooftop cafe. It is unclear if there are any F&B components to the other locations.

VOTE: TITLE: Support for the Certificate of Appropriateness application to leave the basement windows without guards

Whereas, 104 East 10th Street is one of two contributing buildings comprising the St. Marks Historic District Extension, designated in 1984; and

Whereas, 104 East 10th Street was built in 1879 as one of Rutherford Stuyvesant's speculative ventures. The three-story brick residence adopted an austere version of the neo-Grec style that was popular in the 1870s, continuing the brick facades, raised basements, steep stoops, and uniform fenestration patterns of its neighbors; and

Whereas, the designation report notes that much of the original ironwork is retained, calling out "as especially notable the basement window guards whose geometric pattern is repeated in the iron door grille beneath the stoop." And

Whereas, the original window guards were replaced with very ordinary-looking guards in 2009 (without a permit); and

Whereas, as part of the restoration of 104 East 10th Street, the ornamental newel posts, which had previously been removed, were replaced and the ordinary, unpermitted window guards were removed; and

Whereas, the application is to permit the basement windows to be left without guards; so

Therefore be it resolved, Community Board 3 supports approval of the application to permit the basement windows to remain without guards.
