WHEREAS, The Bronx Brewery East Village, LLC. doing business as The Bronx Brewery, is seeking to upgrade to a full, on-premises liquor license, in the premises located at 64 Second Avenue, between E. 3rd Street and E.4th Street, New York, New York; and

WHEREAS, this is an application for an establishment with of 74 people, 18 tables and 69 seats with a stand-up bar, full kitchen and prep area, serving food during all hours of operation, 5 televisions, background/ambient music; and

WHEREAS, there are 20 full on-premises liquor licenses within 500 feet per the SLA LAMP map; and 8 licensed establishments within 1 block; and

WHEREAS, prior to the Bronx Brewery's arrival at 64 Second Avenue in early 2022, the space had been vacant since the spring of 2016; and

WHEREAS, applicants, The Bronx Brewery, LLC, have been in operation since 2011 and has separate locations in the South Bronx and Hudson Yards in Manhattan; does not have any other businesses in the area; has not had any SLA reports or actions in the past 5 years;

WHEREAS, Cadillac Ranch NYC LLC is seeking a full on-premises liquor license, in the premises located at 86 Orchard Street, between Broome and Grand New York, New York; and

WHEREAS this is an application for an establishment with 30 tables, 87 seats, and 2 additional bars with 16 seats in total. There is a full kitchen, with a menu of Spanish Cuisine, and the business plans to serve food during all hours of operation. There will be one TV, and music will be played at conversational level. There will be DJs curating music, as well as streaming services.

WHEREAS, the applicant is currently also a license holder of Mansions of Glory Hospitality LLC DBA Beyond The Pale, located in CB2 at 53 Spring Street. They have been licensed at that location since January 2023; and

WHEREAS, there were 7 commercial 311 complaints at this location with NYPD action necessary since 2018;

WHEREAS, 4 members of the community sent in letters of objection to this application, a representative from the Orchard St Block Association and a representative from the Lower East Side Dwellers, as well as two residents spoke in opposition; and

WHEREAS, 15 residents who live within two blocks of the location signed a petition in favor of the application, three letters of support were received, and three residents spoke in support; and

WHEREAS, 79 residents who live within two blocks of the location signed a petition in favor of the application and two residents spoke in support of this application; and

- 2. MTA: Projected impacts from the implementation of Congestion Pricing and possible mitigation to offset the expected increases in traffic on the FDR Drive between the Brooklyn Bridge and 10th Street
 - VOTE: TITLE: Request for Remediation Funds for Congestion Pricing Related Environmental Impacts in Community District 3

WHEREAS, the MTA is proposing its Central Business District ("CBD") Tolling Program, also known as congestion pricing, which aims to charge drivers for entering Manhattan below 60th Street; and

WHEREAS, according to the CBD Tolling Program Environmental Assessment ("EA"), under Subchapter 4B, unlike the other areas of the CBD which is projected to have a reduction in traffic congestion and pollution, the area of the FDR Drive between the Brooklyn Bridge and 10th Street along the East River ("the subject area") is projected to have an increase in traffic and pollution; and

WHEREAS, every census tract in the subject area is designated as an Environmental Justice area (Census Tracts 2.01, 2.02, 6, 10.02, 20, and 24), save for one between Grand Street and Delancey Street; and

WHEREAS, Environmental Justice is founded on the principle that all individuals, irrespective of race, disability status, age, or socioeconomic background, have a right to live, work, and play in communities that are safe, healthy, and free of harmful environmental conditions; and

WHEREAS, Environmental Justice Areas ("EJA") are defined by NYC's environmental justice laws as lowincome or minority communities located in the City of New York based on US Census data; a lowincome community is defined by the New York State Department of Environmental Conservation as having a low-income population equal to or greater than 23.59% of the total population of their census block group while minority communities are those where the minority population is equal to or greater than 51.1% of the total population; and

WHEREAS, significant portion of Community District 3 is identified as an EJA by the NYC Department of Health and Mental Hygiene(DOHM) with 42.20% of the total subject area population below the poverty level (14,752 out of the 34,960 people), 45.41% of seniors in the subject area are below poverty level (3,316 out of the total 7,303 people), and 44.33% of minorities in the subject area are below poverty level, while the total percentage of minorities living in the subject area is 80.68%; and

WHEREAS, the EA considers seven different alternative traffic tolling patterns, and all seven are projected to have a 5% or greater increase in traffic in the subject area; and

WHEREAS, at least three alternatives (D, E, F) project Southbound Traffic at certain hours in the subject area to increase traffic by between 19 and 26%; and

WHEREAS, 18% of the subject area (6,279 out of the total 34,960 people) is living with a disability, which the American Community Survey defines as having hearing, vision, cognitive, ambulatory, self-care, or independent living difficulties); and

WHEREAS, the subject area has some of the highest rates of asthma and other respiratory diseases and heart diseases and had a higher-than-average Covid infection and death rate, and such increased pollution will only exacerbate the health and welfare of those living next to the FDR Drive; and

WHEREAS, the subject area has and will continue to experience a net loss of mature trees due to the East Side Coastal Resiliency Project. For the next several decades, until the projected trees and other green plants currently planned for the future East River Park, the areas of community district 3 adjacent to the FDR will not have a mature tree canopy to help lower the increased pollution, and

WHEREAS, the subject area is a recognized Transportation Desert, in that most of the area is located over a mile from the nearest subway; and

WHEREAS, none of the subways in the subject area are accessible, resulting in a higher reliance on individual transport; so

WHEREAS, the MTA provided plans outlining how it will spend \$\$155 million to mitigate potential negative environmental impacts from congestion pricing in the Bronx including direct avoidance of truck/traffic increases, emissions and greenspace initiatives, health initiatives and street and traffic initiatives, and other impacted neighborhoods including Community District 3 considered environmental justice areas,

THEREFORE, BE IT RESOLVED, that Community Board 3 requests that environmental mitigation resources be directed to the areas in Manhattan Community District 3 adjacent to the FDR, which is mostly in an environmental justice area, and which will experience congestion pricing-related environmental impacts, and

THEREFORE, BE IT FURTHER RESOLVED, the Community Board 3 requests that the MTA allocate funds to mitigate increased pollution along the FDR in community district 3. The mitigation should include but not be limited to:

- Prioritize ADA accessibility for all subway stations in the district and set firm construction deadlines;
- Increased public transportation options within the district;
- Fund other mitigation measures that will be identified through a process to include our elected officials working with the community board and constituents/local stakeholders to set up a dedicated task force to look at pollution, noise, traffic, etc. overall and find solutions to reduce/mitigate with funding from the CBDTP.

4. Raphael Sadonte Ward Way co-naming on the westside corner of Columbia and Rivington Streets

VOTE: TITLE: Raphael Sadonte Ward Way Co-naming of Columbia and Rivington Streets

WHEREAS, Raphael Sadonte Ward was born on the Lower East Side of Manhattan on August 18th, 1996, a vibrant soul who embodied the dreams and aspirations of countless children in our community. These streets were not just the backdrop to his life but an integral part of his identity. Raphael Sadonte Ward's dreams were as grand as the city itself.

As a young boy, he envisioned himself wearing the iconic pinstripes of the New York Yankees, a testament to his determination and adaptability, and his love for baseball and the city he called home. Transitioning from shortstop to the outfield as he grew to about 6'2", he displayed not only his athletic prowess but also his ability to embrace change and evolve. Raphael's unique comedic talent and his signature behind-the-back throw to make a double play left an indelible mark on all who had the privilege to know him. His humor and creativity were as boundless as his dreams, and

WHEREAS, Raphael Sadonte Ward's dream came to a heartbreaking end on the evening of Friday, January 4th, 2013. At 16-years old, he was tragically shot and killed at the intersection of Columbia Street and Rivington Street by another 16-year-old while simply on his way to grab a slice of pizza at Makabely's pizza restaurant. The location just down the street from his residence at 110 Columbia Street in Baruch Houses where Sadonte lived with his mother and 6-year-old brother.

His passing marked the first NYC homicide of 2013, serving as a stark reminder that the grip of violence knows no boundaries. This was a senseless act of violence that claimed the life of a young person who was not a thug or gangster, who had no record, and even though he was in his own community, he was still in the wrong place at the wrong time.

Even in the face of this tragedy, Raphael Sadonte Ward's character shone through. Hundreds of mourners, including strangers and supporters, turned out to remember him, a testament to the impact he had on our community, and

WHEREAS, two months after his untimely murder, his mother, and LES resident of 30+ years, Arlene Delgado, founded The Sadonte Foundation in his memory. The 501c3 organization is dedicated to the elevation, empowerment, and education of our youth and is committed to reducing gun violence in our communities. The Sadonte Foundation has been unwavering in its mission, hosting annual awareness events, rewarding college scholarships, and facilitating anti-gun violence training. Reaching over 1,600 teenagers, the foundation continues to embody the values and dreams that Raphael Sadonte Ward cherished, and

WHEREAS, the untimely death of Raphael Sadonte Ward led to his mother creating an organization committed to reducing gun violence and continues to this day to work with vulnerable teenagers.

According to the Gun Violence Archive, there have been 77 shootings within a mile of Columbia Street and Rivington Street since 2013, 20 fatal and 69 nonfatal, with the most occurrences of 17 happening just last year in 2022. Gun violence in our community is on the rise. The Sadonte Foundation continues to display their unwavering dedication to our community and their commitment to reducing the number of tragic incidents, so
