Meeting of Community Board 3 held on Tuesday, December 19, 2023 at 6:30pm at PS 20, 166 Essex Street.

Public Session:

Tony Correa – Small Business Design Brand Company (DBC) in affiliation with the SBS NYC. Legal assistance from Brooklyn Legal - BK Legal

Juan Rivers – Village Preservation – Evacuation on 14th Street between B and C. Calling for developers and landlords to have oversight on construction. All fighting to keep the Eye and Ear facility.

Roisin McKown – Baruch Bathhouse, Cuala Foundation – asking to make a presentation about the plans for the Bathhouse.

Borough President Mark Levine, Yiyi Wang: Happy Holidays Two Information Session for Budget, February 27th is the deadline. Public Meeting on Open Meeting Law open public comments. Behavior Health Problems – plan has five key priorities 1. More Beds 2. Staffing Shortage 3. Housing 4. Behavioral Treatment 5. Substance Use Treatment, can reach out to the team for more information. Congestion Pricing question to the office – Before removing the elevated ramps on the FDR, please look into what would happen if it is moved how would that effect the residents of Smith House residents.

District Attorney Alvin Bragg, Peter Tse: Not present

Congressmember Dan Goldman, Lingxia Ye: Office is calling NYS to reverse the to close Beth Israel, Mount Sinai. Calling to lift the cap of Medicaid payment for hospital that hold more than 16 beds. Call for more funding in our public school.

Assemblymember Grace Lee, Fannie Ip: Assemblywoman Grace Lee presented – Partnership with Henry Street Settlement and Ring, Seniors will get cameras for the door, launching in January 2024. Henry Street will work with the program to hire youth to install the cameras. Assemblywoman and Sheriff's office confiscated illegal cannabis products in illegal cannabis shop. Sent out 30,000 letters to landlords notifying the landlords can be fined for illegal cannabis stores. Holiday schedule, remote the rest of the year. 421-a question?" Do not support giveaways for developers..." Tenant protection is also a priority. Congestion Pricing – asking to advocate for the residents for the health and safety. Councilwoman Grace Lee will be a part of the feedback to the MTA, Councilwoman Lee stated there is an open public comment period through March 2024. Lee's office will make public how to make comments during the public comment period. A1559A Climate Education Bill will be presented and was asked if she will support the bill. Councilwoman will look into supporting the bill.

Assemblymember Deborah J. Glick, Roy Ruiz: Not present

Assemblymember Harvey Epstein, Chanel Elliott: Joanna Sanchez presented, collecting clothes and coats for migrant families, advocating to keep Beth Israel open, Justice for tenants at East 14th Street.

State Senator Brian Kavanagh, Patricia Olan: Dan presented for Patrica Olan, bill was passed that required a notification 45 days before a subscription is billed to a consumer.

Councilmember Christopher Marte, Jennifer Chiao: Councilman Marte – City of YES proposal, carbon neutrality. Priority of the YES proposal to advocate: A cap on the square footage of a home business, clear regulations on bars and entertainment. Protection of residential use, decision on what commercial space is used for, Mandated affordable housing. Partipatory Budget is still open in the office. Banning solitary confinement. Advocating to keep Beth Israel Hospital. Clothing drive for migrant. Councilmember Carlina Rivera, Julio Rivas: Councilwoman Carlina Rivera presented about Migrant Crisis, closure of Beth Israel Mount Sinai, Councilwoman presented about the recent bill Intro 95 that tracks vacant units, Cannabis Shops, increased fines to \$10,000, a bill to declare the shops as a public nuisance. DA Braggs is keeping track of owners of illegal cannabis shops, Emergency Rental Assistance, amended the law to assist NYCHA tenants with rental assistance. Is ERAP available of Mitchell Lama residents- Councilwoman will get back with an answer. NYCHA vacant units are not included in the Intro 95. Intro 95 are for only vacant units that are having issues like trash not for warehoused units.

WHEREAS, On and after September 11th, more than 35,000 people younger than 21 years old were exposed to toxic dust and smoke from the World Trade Center (WTC) disaster; and

WHEREAS, In December 2022, Congress amended section 3341(c) of the Public Health Service Act (42 U.S.C. § 300mm–51(c)) to include a Research Cohort for Emerging Health Impacts on Youth (individuals who were 21 years of age or younger on September 11, 2001), and this act instructs the

World Trade Center Health Program (WTCHP) Administrator, in consultation with the Secretary of Education, to establish this research cohort to track this population's health longitudinally; and

WHEREAS, The Youth Research Cohort must be of sufficient size to conduct future research studies on the health and education impacts of 9/11 exposures, and must be sufficiently representative of those who were 21 years old or younger at the time of exposure, and reflect the diversity of the communities exposed in Manhattan below 14th Street and into the borough of Brooklyn; and

WHEREAS, The Youth Research Cohort must include large numbers of individuals who have symptoms linked to 9/11 (Certified-eligible WTC survivors) and large numbers of individuals who do not (Screening-eligible Survivors); and

WHEREAS, The WTC Scientific / Technical Advisory Committee (STAC) was convened at the request of Dr. John Howard, WTCHP Administrator, for a June 21, 2023 meeting where it heard from scientists, young survivors and other stakeholders, and discussed recommended approaches for the new Youth Research Cohort to be established by the WTCHP; and

WHEREAS, A June 29, 2023 letter from the STAC Chair put forward the STAC's recommendations addressing how the WTCHP should support and facilitate the process for reaching, recruiting and retaining a cohort of young survivors. [See: https://www.cdc.gov/wtc/pdfs/stac/LTR_Ward_STAC_23_June_2023_Sta mped-508.pdf];

WHEREAS, The WTCHP has issued a Request for Information (RFI) seeking feedback from the 9/11affected community, as well as researchers, educators, etc. on the preferred approach for establishing a Youth Research Cohort, and on which health conditions are research priorities; so

THEREFORE BE IT RESOLVED that Community Board 3 recognizes that the new 9/11 Youth Research Cohort is essential for tracking the health of young survivors who lived or attended school or daycare in Lower Manhattan on 9/11 or in the weeks and months after, and that a successful cohort will yield key findings re: unmet 9/11-related health needs of young survivors, as well as the survivor community; and

BE IT FURTHER RESOLVED that Community Board 3 pledges its support for this critical endeavor so that the process of assembling the cohort will benefit from the productive engagement of residents who experienced the 9/11 attacks and their aftermath and who committed to and accomplished the successful rebuilding of their neighborhoods and their lives; and

BE IT FURTHER RESOLVED that having reviewed the STAC Chair's letter, Community Board 3 endorses the STAC's recommendations, including but not limited to: the need for community involvement in building the cohort and partnerships with a broad range of researchers, clinicians and stakeholders; the need for incentives to recruit young survivors and the hiring of young adults for peer-to-peer/ recruitment work, the need to leverage innovative technologies and social media to conduct outreach, recruitment and retention; a national outreach campaign to raise awareness and recruit young survivors who are no longer in the NYC Metro area, among other recommendations; and

BE IT FURTHER RESOLVED that Community Board 3 joins the STAC in supporting the inclusion in the cohort of young survivors whose exposures to the WTC disaster occurred in utero. Research over decades has demonstrated that toxic pollutants to which the mother is exposed can impact the developing fetus. Studies led by Dr. Frederica Perera of the Columbia Center for Children's Environmental Health found that children prenatally exposed to the WTC disaster were more likely to be born small for gestational age, and to have exposure-related 'DNA adducts' which can increase lifetime cancer risk. CB 3 calls for people who were in utero and whose mothers were present in the disaster area for sufficient time during the period from September 12, 2001 to July 31, 2002 (as set forth by the Zadroga Act) to be eligible for the cohort; and

BE IT FURTHER RESOLVED that Community Board 3 supports the WTCHP revisiting the use of the NYC Department of Education's directory lists from 2001/2002 (following an unsuccessful effort by the WTC Health Registry's vendor), but with the proviso that better methods for recruitment be used, including use of communication tools targeted to the relevant age groups (social media, text messaging) and leveraging existing stakeholder partnerships, both local and national. Communications and materials should be multilingual and include Spanish and Chinese. We agree that the WTCHP cannot rely solely on the DOE lists, because many 9/11-exposed people were too young to be in school in 2001/2002 or attended private schools at the time. These individuals must be fully represented in the cohort and will need outreach/recruitment; and

BE IT FURTHER RESOLVED that in order to build a cohort that is sufficiently large and representative, the WTCHP must activate the extensive community support infrastructure of Lower Manhattan – the community centers, settlement houses, tenants associations, faith based associations, health care clinics, and not for profits that span Lower Manhattan and are directly engaged with residents and other survivors; and

BE IT FURTHER RESOLVED that CB 3 recommends that the WTCHP create several tiers of grant opportunities of different funding amounts through which groups like these can fund their outreach using records and relationships that only they have. For example, community centers that ran day care, pre-school and after-school programs on 9/11 and in the subsequent months, often have long term relationships with the families they served. In addition, we emphasize the importance of a more streamlined, accessible process with plain language instructions for small organizations to apply for grants. It is important for WTCHP to avoid excessive reporting requirements which pose a burden to smaller groups for these opportunities; and

BE IT FURTHER RESOLVED that the WTCHP is requesting feedback regarding which health conditions and potential social and education impacts should be priorities for future research on the WTC Youth. CB 3 agrees with young survivors, parents, and the Survivors Steering Committee that these impacts should be research priorities: reproductive health problems, autoimmune disease, neurocognitive problems, metabolic disorders related to exposures to endocrine disrupting chemicals, cancers, delayed-onset PTSD or other psychological impacts triggered or exacerbated by serious WTC-related illness of a parent. We also ask how some of these physical and/or psychological impacts have affected educational attainment. If the WTC Survivor Data Center is detecting increased frequency of a condition in the patient population of people exposed as children, that condition may become a research priority; and

BE IT FURTHER RESOLVED that CB 3 requests that the WTCHP immediately set up on its website a means for young survivors to sign-up for the cohort. In addition, we recommend that the WTCHP send out letters to survivor members explaining what the Youth Research Cohort is and how young survivors can sign up; and

BE IT FURTHER RESOLVED that the entire Youth Research Cohort process, from planning to recruitment to research, must entail community engagement. Finally, it will be important that findings be shared by the WTCHP with young survivors and the broader community, with ample opportunity for Q&A.

2. Hanoi House (King Me Kong LLC), 119 St Marks Pl (alt/op/expansion onto municipal property)

VOTE: TITLE: Community Board 3 Recommendation To Deny Unless Stipulations Agreed To—Stipulations Attached

WHEREAS, King Me Kong LLC doing business as Hanoi House, is seeking to alter the method of operation to include the space next door for a private dining room, located at 119 St. Marks PI, as well as to allow the expansion to municipal property for outdoor dining, between Avenue A and First Ave, New York, New York; and

WHEREAS, this is an application for an establishment with of 74 people, 1 table and 22 seats serving Vietnamese food during all hours of operation; and

WHEREAS, there are 45 full on-premises liquor licenses within 500 feet per the SLA LAMP map; and

WHEREAS, This location has been operated by the applicant since 2016. The new space was previously operated by the applicant from 2019-2020 as Hanoi Soup Shop. The plan now is alter their method of

operation to include the space at 115 St. Marks Place for private dining and catering events. Prior to that, this location was licensed to Mr Bing of 115 St Marks LLC, who held a beer & wine license, and had hours from 10am-12am all days; and

WHEREAS, this business was using the outdoor space under the open restaurant program, however their original stipulations did not allow outdoor use. This application is bringing them into compliance.

WHEREAS, there were 2 commercial 311 complaints at this location with NYPD action necessary since 2021; and

WHEREAS, 21 residents who live within two blocks of the location signed a petition in favor of the application; and

THEREFORE, BE IT RESOLVED that Community Board 3 recommends the denial of the application for an alteration to the method of operation for King Me Kong LLC, for the premises located at 119 St. Marks Place, New York, New York, unless the applicant agrees to the following signed notarized stipulations that

- 1) it will operate as a Vietnamese restaurant with food served during all hours,
- 2) its hours of operation will be opening no later than 12:00 P.M. and closing by 12:30 A.M. all days,
- 3) it will close all outdoor dining allowed under the temporary Open Restaurants program and any other outdoor uses by 10:00 P.M. all days and not have any speakers or TV monitors,
- 4) it will close any front or rear facade doors and windows at 10:00 P.M. every night or when amplified sound is playing, including but not limited to DJs, live music and live non-musical performances, or during unamplified live performances or televised sports,
- 5) it will play ambient background music only, consisting of recorded music, and will not have live music, DJs, promoted events, scheduled performances or any event at which a cover fee will be charged,
- 6) it will not apply for any alteration in its method of operation or for any physical alterations without first appearing before Community Board 3,
- 7) it will not host pub crawls or party buses,
- 8) it will not have unlimited drink specials, including boozy brunches, with food,
- 9) it will not have "happy hours,"
- 10) it will ensure that there are no wait lines outside and will designate an employee for ensuring no loitering, noise or crowds outside,
- 11) it will conspicuously post this stipulation form beside its liquor license inside of its business, and
- 12) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints.

VOTE: TITLE: Community Board 3 Recommendation To Deny Unless Stipulations Agreed To—Stipulations Attached

WHEREAS, Brenmck LLC, doing business as TBD, is seeking a full on-premises liquor license, in the premises located at 16 First Avenue, between East 1st and East 2nd Streets, New York, New York; and

WHEREAS, this is an application for an establishment of 185 people, 19 tables and 58 seats with one bar with 21 and bar with 21 seats, and a rear bar with 11 seats, pub fare prepared in a full kitchen and prep area, serving food during all hours of operation, 20 TVs, and live music, DJs, and recorded music at background levels; and

WHEREAS, there are 15 full on-premises liquor licenses within 500 feet per the SLA LAMP map; and

WHEREAS the location is currently licenses to Allyn LLC, doing business as the Grayson, and there is a long history of noise complaints at this location; and

WHEREAS, the applicant is the owner of the Hairy Lemon at 28 Avenue B, Triona's at 237 Sullivan Street, and Trionia's at 192 Third Avenue; and

WHEREAS, The location has received 175 311 complaints in the past two years, with 71 non crime corrected (on 34 separate dates) the applicant has one SLA violation in the last five years for a COVID-related violation; and

WHEREAS, Although this location has a serious history of problems for over 15 years, including noise, open doors and windows, wait lines, participating in pub crawls, etc, we are approving it based on the current applicant's history at the locations on 3rd avenue and Sullivan street,

WHEREAS, 18 residents who live within two blocks of the location, including 10 who live in the same building, signed a petition in favor of the application; and

THEREFORE, BE IT RESOLVED that Community Board 3 recommends the denial of the application for a full on-premises liquor license for Brenmck LLC, for the premises located at 16 First Avenue, New York, New York, unless the applicant agrees to the following signed notarized stipulations that

- 1) it will operate as a Tavern with pub fare with kitchen open and serving food during all hours of operation,
- 2) its hours of operation will be opening no later 2:00 P.M. Monday-Friday and 11 A.M. on Saturday and closing by 4:00 A.M. all days,
- 3) it will not use outdoor space for commercial use,
- 4) it will have security Thursday Saturday,
- 5) it will install soundproofing in order to ensure sound is not audible in residential apartments,
- 6) it will have a closed fixed façade with no open doors or windows except my entrance door will close by 10:00 P.M. or when amplified sound is playing, including but not limited to DJs, live music and live nonmusical performances, or during unamplified live performances or televised sports,
- 7) it will play ambient background music only, consisting of recorded music, it will have DJs at entertainment level Friday and Saturdays, and live music consisting of acoustic instruments not more than 10 times per year, DJS and live music will be in the rear of the space, and will not have scheduled performances or any event at which a cover fee will be charged,
- 8) it will not apply for any alteration in its method of operation or for any physical alterations without first appearing before Community Board 3,
- 9) it will not host pub crawls or party buses,
- 10) it will not have unlimited drink specials with food,
- 11) it may have "happy hours" until 8:00 P.M. each night,
- 12) it will ensure that there are no wait lines outside and will designate an employee for ensuring no loitering, noise or crowds outside,
- 13) it will conspicuously post this stipulation form beside its liquor license inside of its business, and14) it will provide a telephone number for residents to call with complaints and immediately address any resident complaints.

WHEREAS, Brad Schwartz doing business as Paulie Gee's Slice Shop, is seeking a full on-premises liquor license, in the premises located at 107 1st Avenue, between East 6th and East 7th Streets, New York, New York; and

WHEREAS, this is an application for a Pizzeria with 16 indoor tables and 71 seats with one bar on the ground floor, roadway seating with 5 tables and 20 seats, with food preparation area serving a range of Neapolitan style pizzas, serving food during all hours of operation, 6 TVs, with background music from streaming services/playlists; and

WHEREAS, there are 30 full on-premises liquor licenses within 500 feet per the SLA LAMP map;

WHEREAS, previously, for nearly a decade this location operated as a restaurant with a full, onpremises liquor license;

WHEREAS, this applicant has never previously held a license for the sale of alcohol, and does not have any other businesses in the area; and

WHEREAS, 22 residents who live within two blocks of the location signed a petition in favor of the application; and

THEREFORE, BE IT RESOLVED that Community Board 3 recommends the denial of the application for a full on-premises liquor license for Brad Schwartz for the premises located at 107 First Avenue, New York, New York, unless the applicant agrees to the following signed notarized stipulations that

- 1) it will operate as a restaurant/bar tavern, serving various Neapolitan types of pizza at all hours of operation,
- 2) its hours of operation will be opening no later than 11 a.m. all days and closing by 1 a.m. Sunday to Wednesday and 2 a.m. Thursday to Saturday,
- 3) it will close all outdoor dining allowed under the temporary Open Restaurants program and any other outdoor uses by 10:00 P.M. all days and not have any speakers or TV monitors outdoors,
- 4) it will close any front or rear facade doors and windows at 10:00 P.M. every night or when amplified sound is playing, including but not limited to DJs, live music and live non-musical performances, or during unamplified live performances or televised sports,
- 5) it will play ambient background music only, consisting of recorded music, it will have DJs at entertainment level Friday and Saturdays, and live music consisting of acoustic instruments not more than 10 times per year, DJs and live music will be in the rear of the space, and will not have scheduled performances or any event at which a cover fee will be charged,
- 6) it will not apply for any alteration in its method of operation or for any physical alterations without first appearing before Community Board 3,

- 8. Sammy's Roumanian Steak House, 112 Stanton St (op)

VOTE: TITLE: Community Board 3 Recommendation To Deny Unless Stipulations Agreed To—Stipulations Attached

WHEREAS, DML Hospitality Group LLC, DBA Sammy's Roumanian Steak House, is seeking a full onpremises liquor license, in the premises located at 112 Stanton Street, between Essex & Ludlow Street, New York, New York; and

WHEREAS this is an application for an establishment with a maximum occupancy of 74, with 6 tables, 66 seats, and one bar, approximately 5' x 6'10. The premises has a full kitchen, and food will be served during all hours of operation. There will be one TV that will have picture montages, and if playing sporting events will be muted, and there will be live music, DJs, and usage of streaming services. The sound system is described as 'small speakers'; and

WHEREAS, there are 38 full on-premises liquor licenses within 500 feet per the SLA LAMP map; and (only for full liquor and if there are more than 3 full op licenses). This info comes from questionnaire

WHEREAS, Location was previously Sushumai Asian Fusion, which had a wine and beer license, and hours from 11am-12am; and

WHEREAS, Applicant is the original owner of Sammy's Roumanian, originally located at 157 Chrystie Street from 1975-2020 when it closed due to the Pandemic; and this is an iconic lower east side restaurant that was open for 47 years.

WHEREAS, The LES Dwellers submitted a letter in support of this application based on an agreement with the applicant, however at the meeting the applicant stated they were not signing the agreement, and

WHEREAS, the applicant is a long-standing business owner having been a license holder for Sammy's Roumanian Steakhouse at 157 Chrystie Street from 1975 until 2020 and has no history of SLA violations; and

WHEREAS, the applicant preserves and promotes the Lower East Side's Jewish culture, history, and heritage, and the proposed location is proximate to other historic Jewish-American historical sites and businesses; and
