7. I will not have a happy hour. Or Happy hour will end by 8:00 PM
8. I will not have wait lines outside. There will be a staff person outside to monitor sidewalk crowds and ensure no loitering. on Fri and Sat from 8:00 PM unless a greater need occurs.

Plan for Vehicular Traffic/Crowds and Noise Control

The premises are only 12 feet across, have less than 40 seats and very limited space to move around. Except for 5 bar seats, all seating is on couches and hassocks. As this is also a hookah lounge (fruit flavored tobacco), the intent of both the owner (myself) and my patrons is to sit comfortably, relax, drink wine and beer, smoke hookah and eat some light Middle Eastern food.

As the owner of expensive hookahs, I will personally insure that people generally remain seated for the sake of not breaking the hookah, if nothing else.

I will employ a door/security person on Friday and Saturday nights, as experience in this business (as a worker, not an owner) has shown me that it's not especially busy at other times. I will always be there. The door person, and/or myself will tell car drivers they must move. The door person and/or myself will tell persons attempting to congregate in front of my small lounge (12 feet across) they must either come in (if over 21) or move from my storefront. If I see that I need another person for the weekends, or even during the week, I will hire him immediately.

I am already open (without serving alcohol, of course). I am not having any problems with traffic/crowd or noise control.

To insure low noise levels I currently, and will continue to have only taped (I-pod or CD) Music and no DJ. I will not use a sound system. My music is only background/ambient music. I close and will continue to close my doors by 10:00 P.M.
