Rice & Salt LLC will use six Polk audio 6.5" driver speakers connected to a Sonos wireless system and iPod.


2. *How do you plan to manage vehicular traffic and crowds on the sidewalk caused by your establishment?*

Rice & Salt LLC will implement the "NoWait" text message restaurant wait list app. This app notifies patrons when seating is available via text message, allowing them to wait off premises. Additionally, employees will be designated to actively manage any crowds that may develop. Waiting areas will be designated for patrons as well.

3. *How do you plan to manage noise inside and outside your business so neighbors will not be affected?*

Rice & Salt LLC will mount speakers away from walls and ceilings and will install homasote sound barriers in the walls. The company will also use volume limiters on speakers and sound system equipment, and the volume will be continually monitored by the principals and managers to ensure that it is not disruptive.

We are not sure if you have signed a lease yet but there are a couple of important things you should be aware of before proceeding with a lease or an application for full liquor with the use of the rear courtyard at this location:

171 Avenue A is in what the Community Board and the NY State Liquor Authority recognize as a "saturated area". This is defined as an area with an overabundance of full liquor licenses. Community Board 3 adheres to the 500 foot rule for applications and there are over 10 licenses within 500 feet of 171 Avenue A. "CB 3 believes these areas are problem areas because of over saturation, and have a policy to not approve new licenses or expansions in these areas. . ."

An exception to this policy is applications for beer wine licenses for businesses that will close by midnight, agree to never apply for a full liquor license, not use any outdoor areas (including backyards or sidewalk seating) and meet other requirements, including to operate as a full service restaurant.


