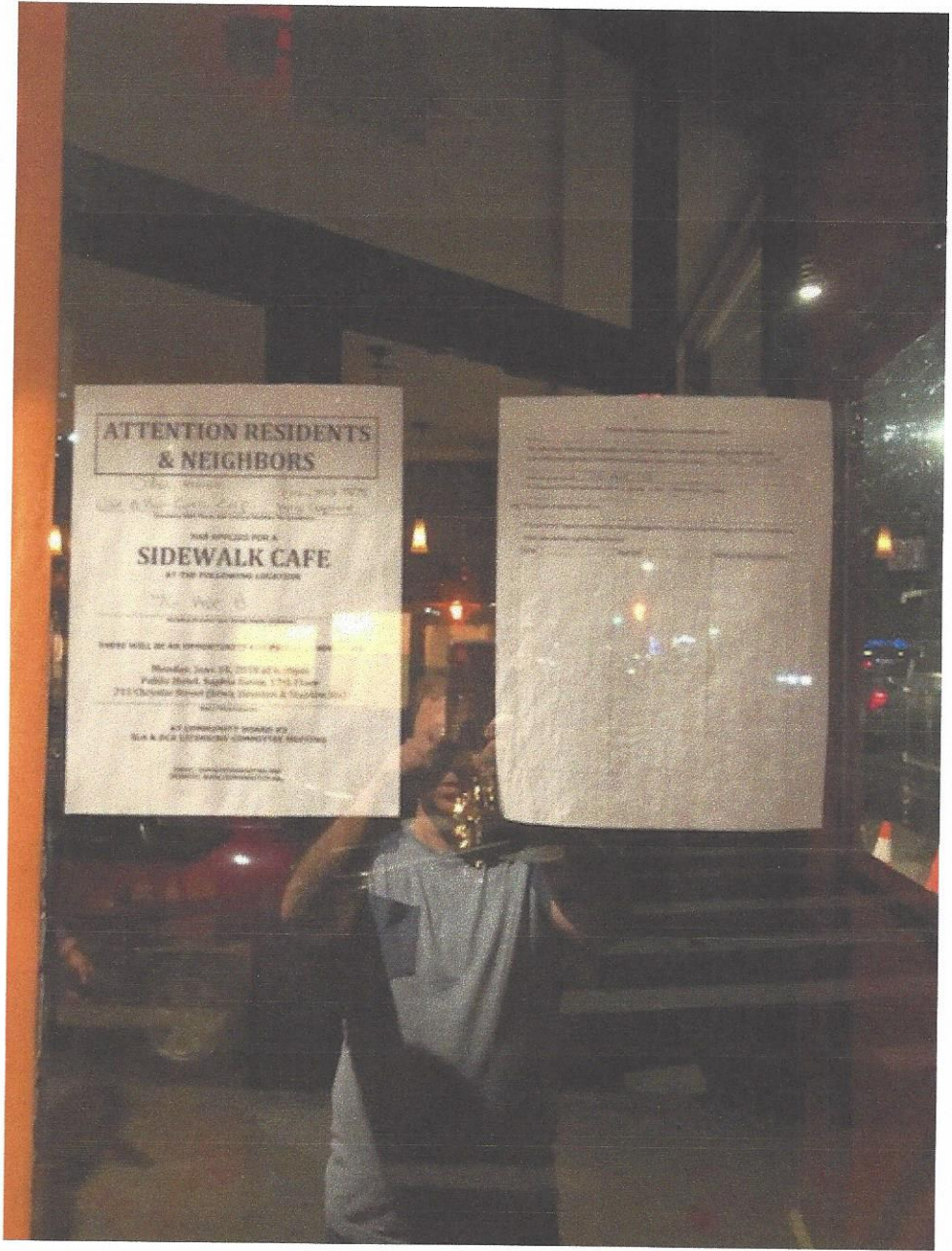
2 PLAN 5th St

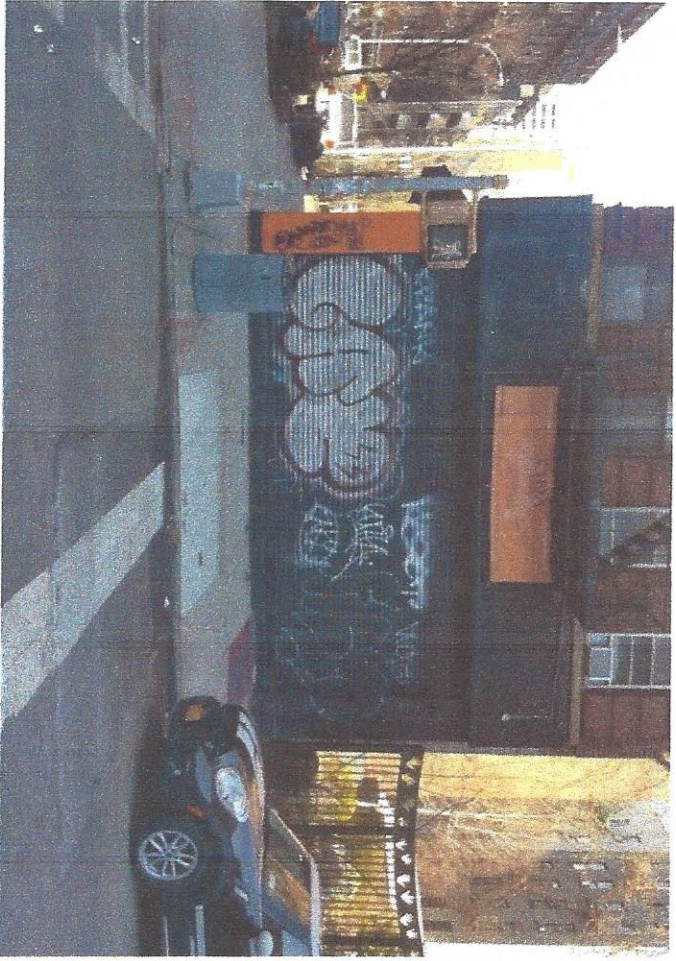
