



Hachi Enterprises Inc. - Description of proposed alterations to premises located at 185 Orchard Street

Hachi Enterprises Inc. (the "Licensee") makes this Application for Permission to Make Alterations at its premises located at 185 Orchard Street, New York, NY 10002 (the "Premises") in order to enlarge its current premises to incorporate the following additions:

- 1. Toilets. Licensee proposes to enlarge its toilet/wash area in the northwest corner of the Premises to include additional two toilets, including a Unisex ADA Toilet.
- Kitchen/Raw Bar Area. Licensee proposes to remove the Raw Bar area located just east of the kitchen area and install booth seating along the southern and north walls of the same area; no changes will be made the existing kitchen area.
- 3. Bar Area. Licensee proposes to remove the southern wall behind the existing bar area, starting from the eastern wall of the premises to the existing staircase located next to the existing raw bar area, in order to enlarge the bar area from an L-shaped bar to a U-shaped bar (approximately 30 feet long) and will include added seating along the whole bar area.
- 4. Coat Check Area & New Entryway. As the removal of the southern wall behind the existing bar area will enlarge the premises, Licensee proposes to install a separate coat check room along the eastern wall of the premises, south of the existing entry/exist, and also proposes to install an additional entry/exit on the eastern wall of the premises and south of the proposed coat check room.
- 5. Food Warming Area. Licensee proposes to add a food service area where food will only be kept warm, no cooking, in the southwest corner of the premises, immediately south of the existing kitchen.
