FRONTAL ELEVATION



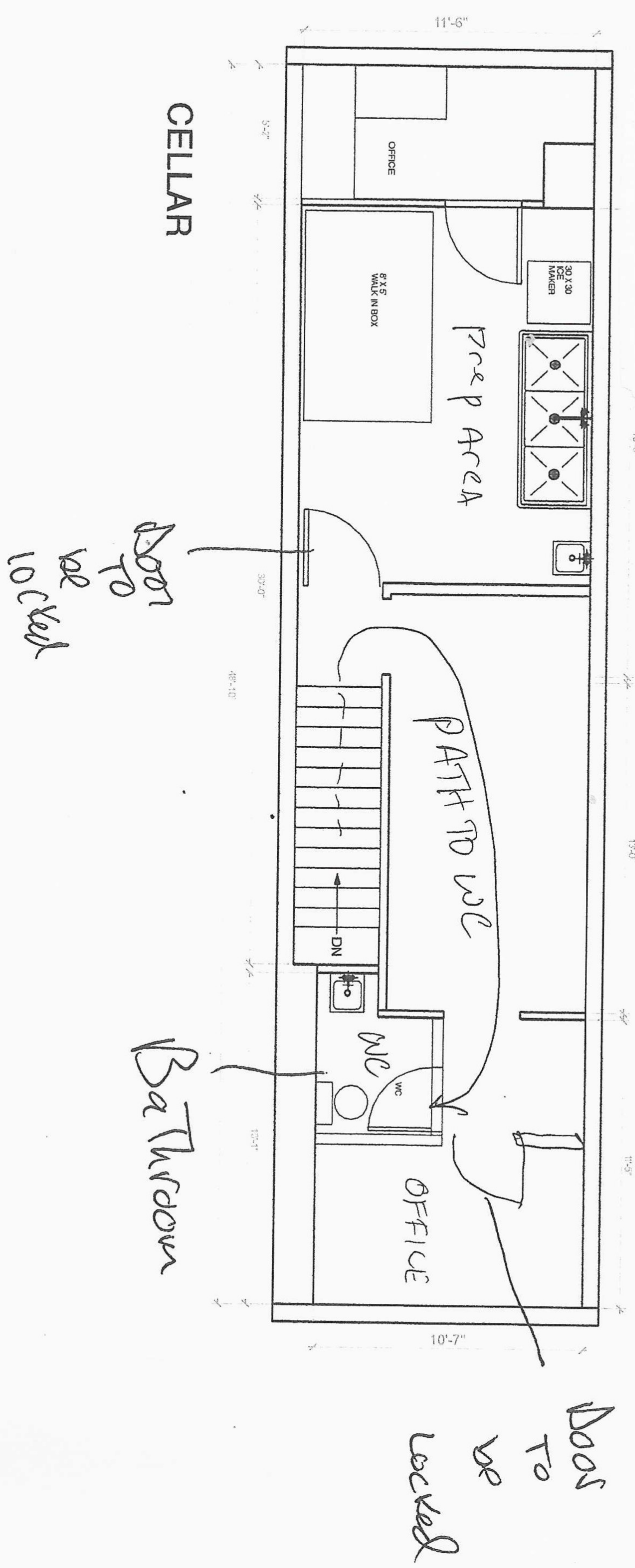


