Unfortunately, the website/portal does not provide access to any details of 311 complaints from 2020. Specifically, the relevant period of time for our purposes in regards to the 311 complaints is July 16th 2020 through August 6th 2020. The former is the first day that we were open since being forced to shut down dine-in services on March 15th 2020 after a national

emergency was declared and executive orders were put in place. The latter is the night that the SLA and a COVID task force raided Cloister Café twice and subsequently suspended the liquor license the following morning, coercing us to shut down.

However, thankfully the SLA did provide details on the 311 complaints in their memorandum of law in opposition to our motion for a preliminary injunction in one of their exhibits that was filed on August 24th 2020. I have attached pertinent pages of the aforesaid memo of law to this email as a PDF titled "311 complaints.pdf. There are significant details that I will outline below which I want to draw your attention to:

As shown on page 3, the search for 311 jobs at 238 East 9th Street yielded 35 complaints/service requests. Please note the date range on the upper left hand corner of page 3, which shows that the 311 search encompassed all complaints from 01/01/2020 through 08/16/2020. We can deduce that Cloister Café received 0 complaints while it was open from 01/01/2020 through 03/15/2020, the day that dine-in services were suspended due to the executive order surrounding the virus. It is vital to note that the level of ambient music played during the above-mentioned period with 0 complaints was at the same level, through the same sound system, as the music played after Cloister Café re-opened on July 16th 2020 for a period of 3 weeks, which is when all 35 of the complaints were submitted.

Please note the time stamp of every complaint, specifically the time "occurred," "received," and "last updated at." You can see that every single complaint was investigated by the NYPD and updated the same night that the complaint occurred and was received. Given that I was managing the café every night, I can attest to the NYPD visiting us almost every night that we received a complaint. They would stop by and say that they received a complaint about noise, and almost always they would comment on the fact that they couldn't hear anything from the entrance to the cafe. There were numerous occurrences where I either invited the officers into the garden to check out the level of noise, or they asked if they could come into the garden and see/listen for themselves. Every single time, the officers would say that there was no issue with the level of music and the complaints likely stemmed from the fact that the entire city was shut down for upwards of 5 months and people got used to the silent nights.

It is important to note that there was never an instance that Cloister Café received any sort of fine/ticket/summons for excessive noise or noise pollution as a result of a noise complaint. Please take a look at the "resolution action" of each noise complaint. An overwhelming majority were labeled "10-90X" (meaning that the complaint was unfounded/unproven), or "10-90Y" (meaning the complaint was unnecessary). Again, if the level of noise was egregious, it would have been reflected in the updated 311 complaint after the assigned NYPD unit performed their visit/inspection and the business would have received a fine/ticket/summons. However, this was never the case.

If you take a look at the caller information on each of the 311 complaints, we can see that Cloister Café had multiple complaints from 4 different people over the relevant time period. A majority of the complaints came from 3 individuals: Chad Uy, Chris Zitelli, and Tristain Bourassin. Now, if the level of noise was so excessive as to cause public/neighborhood outrage,

as is being purported by the SLA, then surely there would be multiple complaints from way more than 4 people. This "public outrage" line of reasoning utilized by the SLA to try to justify cutting Cloister Café's liquor license hours significantly is not supported at all by the facts and details from these 311 complaints.

One possible underlying reason to consider for these complaints is the notion that the callers sincerely thought that Cloister Café was not legally allowed to operate past 11PM during the period of time in question. This was the case multiple times when Cloister Café was visited by the NYPD and Sheriff's Office on multiple occasions during the 3 week span. I had to explain to officers on various occasions that the rules put forth by the Mayor's Office and the NYC Office of Nightlife in conjunction with the Open Restaurants Program, the Department of Transportation and the Department of Health and Mental Hygiene specifically stated the following: "NYC Open Restaurant application does not cover usage that falls within private property (i.e. backyard, patio etc). This language can be found on page 8 of the "NYC Restaurant-bar-reopening-toolkit-july-2020.pdf" which I have attached to this email. More importantly, on page 11, the toolkit explicitly states that "If you are utilizing private outdoor space for dining to which you previously had rights, then the closing time for that space remains the same as it was pre-COVID-19 as stipulated by your Community Board agreement or county hours and all municipal ordinances."

Proceedings having been duly instituted pursuant to the provisions of the Alcoholic Beverage Control Law, (Chapter 478 of the Laws of 1934, as amended) to cancel or revoke the above license issued to the licensee for premises located at the address stated above and the licensee having duly pled "no contest" to the charges contained in the Notice of Pleading or a hearing having been duly held by the State Liquor Authority in connection with said proceedings, and

The matter having been duly considered by the State Liquor Authority at a meeting held on 01/20/2021, and the Authority having found:

- 1. That on or about August 7, 2020, the licensee violated rule 54.3 of the Rules of the State Liquor Authority [9 NYCRR 48.3], in that it did not conform with all applicable building codes, and/or fire, health, safety and governmental regulations Governor's Executive Order 202.43 regarding violations of social distancing and open container laws and associated posted NYSLA and NYDOH Guidance within 100 feet from the licensed premises]; all cause for revocation, cancellation or suspension of the license in accordance with rule 36.1(f) of the Rules of the State Liquor Authority [9 NYCRR 53.1(f)].
- 2. That on August 7, 2020, the licensee violated rule 54.3 of the Rules of the State Liquor Authority [9 NYCRR 48.3], in that it did not conform with all applicable building codes, and/or fire, health, safety and governmental regulations; FAILURE TO MAINTAIN ROLL DOWN GATE IN LOCKED OPEN POSITION WHEN BLDG OCCUPIED NYC BC 1008.2, all cause for revocation, cancellation or suspension of the license in accordance with rule 36.1(f) of the Rules of the State Liquor Authority [9 NYCRR 53.1(f)].
- 3. Dismissed.
- 4. Dismissed.
- 5. That on August 7, 2020, the licensee violated rule 54.3 of the Rules of the State Liquor Authority [9 NYCRR 48.3], in that it did not conform with all applicable building codes, and/or fire, health, safety and governmental regulations; EXIT SIGN OBSTRUCTED BY BRANCHES NYC AC27-541) all cause for revocation, cancellation or suspension of the license in accordance with rule 36.1(f) of the Rules of the State Liquor Authority [9 NYCRR 53.1(f)]. 6. Dismissed.
- 7. That on 08/07/2020, the licensee violated rule 54.3 of the Rules of the State Liquor Authority [9 NYCRR 48.3], in that it did not conform with all applicable building codes, and/or fire, health, safety and governmental regulations; CURTAIN PLACED OVER EXIT DOOR NYC FC 1028.5) all cause for revocation, cancellation or suspension of the license in accordance with rule 36.1(f) of the Rules of the State Liquor Authority [9 NYCRR 53.1(f)]. 8. Dismissed.
- 9. Withdrawn.
- 10. That on August 7, 2020, the licensee violated rule 54.3 of the Rules of the State Liquor Authority [9 NYCRR 48.3], in that it did not conform with all applicable building codes, and/or fire, health, safety and governmental regulations; USING EXTENSION CORD FOR PERMANENT WIRING, NYC FC 605.5) all cause for revocation, cancellation or suspension of the license in accordance with rule 36.1(f) of the Rules of the State Liquor Authority [9 NYCRR 53.1(f)].
- 11. Dismissed.
- 12. Dismissed.
- 13. That on August 7, 2020, the licensee violated rule 54.3 of the Rules of the State Liquor Authority [9 NYCRR 48.3], in that it did not conform with all applicable building codes, and/or fire, health, safety and governmental regulations; UNSECURED COMPRESSED GAS TANKS NYS FC 3003.3.3, all cause for revocation, cancellation or suspension of the license in accordance with rule 36.1(f) of the Rules of the State Liquor Authority [9 NYCRR 53.1(f)].

 14. That on 08/07/20, the licensee used the trade name "Cafe Tucano," in connection with the licensed business without the
- permission of the Authority first obtained; all cause for revocation, cancellation or suspension of the license in accordance with rule 36.1(p) of the Rules of the State Liquor Authority [9 NYCRR 53.1(p)].
- 15. That on and before August 7, 2020, in violation of subdivisions 1 and 3 of section 118 of the Alcoholic Beverage Control Law there has existed a sustained and continuing pattern of noise, disturbance, misconduct or disorder on or about the licensed premises, related to the operation of the premises or the conduct of its patrons, which adversely affects the health, welfare, or safety of the inhabitants of the area in which the licensed premises are located. 16. Dismissed.

Summary of Due Process Failures in the Proceedings

The Individual Charges

210. Each charge sustained by the ALJ and affirmed by the Board is riddled with errors, either in process, support, logic, or all three. The result is sixteen arbitrary and capricious charges.

Charge 1: Governor's Executive Order

- 211. Governor's Executive Order 202.43 was put in place for the new phenomenon of people drinking on the street outside the establishment **and** where the establishments were serving such people to drink outside.
 - 212. The use of the word "and" is intentional.
- 213. During the hearing, the ALJ seemingly agreed that Respondents would have to prove both elements of this clause, in order to sustain the charge.
 - 214. Unsurprisingly, in his Findings, the ALI failed to engage with this at all.
- 215. Respondents did not provide any evidence of violations of open container laws, any service of people to drink outside, or anyone drinking on the street outside the premises.
- 216. Instead, based on the ALI's own initiative to interpret the order strictly, the ALI determined that Stravalle's word (contradicted by the bodycam footage) that people were gathering outside the establishment was sufficient to take away Petitioners' license.
 - 217. This is arbitrary, capricious, and irrational.

Charge 2: The Roll Down Gate

218. The ALI wholly disregarded the evidence before him.

- 219. Mr. Drobenko testified as to the fact that the subject roll-down gate was open until Stravalle arrived with a camera crew from "Inside Edition," at which point the licensed Fire Safety Guard stationed at the door rolled down the gate in the interest of safety as a result of the camera crews blinding lights.
- 220. Indeed, the prior inspection, which did not determine there to be any issues with the gate, was entirely ignored.
- 221. The ALJ ignored the prior investigation as hearsay, despite being corroborated by Stravalle, and inserted his own opinion as to the balance of safety measures between having patrons blinded by the camera lights and having the gate open.
- 222. In the face of the various facts before him, the ALJ blindly accepted Stravalle's word, rendering this decision arbitrary, capricious, and irrational.

Charge 5: The Exit Sign

- 223. At p. 30, the ALI determined that the use of the word clearly in Admin Code Sec. 27-541 meant free from "any and all obstruction" and that the presence of "leaves and branches" interfered with the clear viewing of the exit sign.
 - 224. To interpret the word "clearly" as the ALJ has is beyond his authority.
- 225. This interpretation imbues the administrative code with an interpretation beyond the legislative intent, as the use of the word "clearly" is related to the ability to view it from "all parts of the assembly space."
- 226. Had the legislative intent been that there would be no obstruction at all to a sign, it would have been written as such.

- 227. There is no evidence that the sign, even with branches and leaves nearby, was not "clearly visible from all parts of the assembly space."
- 228. Thus, it is irrational, arbitrary, and capricious to find that ""clearly" implies the absence of any and all obstruction and the leaves and branches shown in the subject photograph."

Charge 7: The Curtain

- 229. The ALJ cites Fire Code 1028.5, finding that it "provides that 'furnishings, decorations or other objects shall not be placed so as to obstruct exits, access thereto, egress therefrom, or visibility thereof.'"
- 230. There is no Section 1028.5 in the New York City Fire Code, yet the ALJ found "substantial evidence" to sustain the charge for a violation of 1028.5.
- 231. Having not addressed any of these rules throughout the proceeding, sustaining the charge is clearly arbitrary and capricious.
- 232. The quoted language is from Fire Code 1027.3.5, a charge not made against Petitioners.
- 233. Even so, "obstruct," "access," and "egress" each, by definition, relate to the act of passing through the door.
- 234. This is furthered by the continuation of Section 1027.3.5, which states "[h]angings and draperies shall not be placed <u>over</u> exit doors or otherwise be located to <u>conceal</u> or obstruct an exit."
- 235. Petitioners' presented evidence that the door could be walked through without obstruction from the curtains.

- 236. There was no evidence that the door was, in any way, concealed.
- 237. Ignoring the same, the ALI found "[t]he curtain in question, even if pinned on the sides, constitutes an obstruction and, potentially, if unpinned a total barrier to visibility."
- 238. First, the hypothetical situation cited flies in the face of the ALJ's own insistence that every witness, violation, photograph, or statement must be discounted if it was not the state of affairs on the night in question.
- 239. Second, like the ALJ's definition of "clearly" in relation to the exit sign, it goes well beyond the intent of the code.
- 240. The code could have said "nothing shall be hung in a doorway," but it did not. Instead, logically, the code focuses on actual obstruction.
- 241. As such the finding of this charge being sustained is irrational, arbitrary and capricious.

Charge 10: The Extension Cords

- 242. The ALI determined that Petitioners' use of extension cords to power portable fans violated the code.
- 243. Section 605 prohibits using extension cords "as a substitute for permanent wiring."
- 244. The ALJ states "[t]he portability of the scanner does not undercut the violation created by the fans."
- 245. It appears that the ALI failed to read the entirety of Section 605, which clearly states that "[e]xtension cords shall be used only with portable appliances."

246. Therefore, having found that the extension cords were being used to supply power to portable fans, they are statutorily permissible, and the ALJ's failure to find such is arbitrary and capricious.

Charge 13: The Gas Cannisters

- 247. While discussed above, the charge levelled at Petitioners related to these cannisters was that they were not secured properly.
 - 248. The ALJ has this finding at the forefront of his statement on this charge.
- 249. To date of this filing, the actual violation that Petitioners were charged with remains unclear.
- 250. Section 3003.3.3 of the NYC Fire Code 2014 relates to securing the cannisters, and provides 5 permissible methods.
 - 251. Section 3003.3.3 of the NYS Fire Code 2020 does not exist.
- 252. Section 3003.3.3 of the no-longer operative NY Fire Code 2010 relates to the sizing of "pressure **relief** devices."
- 253. Section 3003.3.4 of the same inoperative 2010 code relates to the pressure relief devices arrangement; namely, that they are arranged upward.
- 254. The ALI is undeterred by any of this confusion, because he could just say the Petitioners violated them all without any support.
- 255. According to the ALJ, Stravalle's statement that the cannisters were not arranged upright wins the day, despite the cannisters being clearly shown as upright in Stravalle's bodycam footage.

- 256. Mr. Drobenko's testimony confirming what is shown in the bodycam video is dismissed as "inaccurate, irrelevant and self serving." It truly begs the question of how could a statement directly on point to the charges being made be considered "irrelevant."
- 257. From the ALI and SLA's failure to even find the correct provision of the code to charge Petitioners with to the ALI's willful disregard of the evidence, sustaining this charge was arbitrary and capricious.

Charge 14: Use of the Name Café Tucano

- 258. The ALJ stated that there was substantial evidence to sustain the Charge for using the trade name Café Tucano without the permission of the SLA in violation of Rule 36.1(p) of the Rules of the State Liquor Authority.
- 259. The ALI utterly ignored the evidence presented by Petitioners that Café Tucano was the name of the outdoor street dining area that was partially built but yet to be in operation when Stravalle's investigation took place.
- 260. The ALI ignored that the "sign" outside of the premises that said Café Tucano was actually a mural on the wall that continued onto the street dining structure, and that all actual signage, including a large canopy above the entrance, indicated that the establishment was "The Cloister Café."
- 261. Finally, the ALJ, in the face of the evidence, ignored Petitioners' legal arguments that the rule prohibits, in essence, changing the name of a licensed premises, not using a different name for certain areas within the premises, as the exterior space would have been considered under the street side program.

262. Having ignored both fact and law presented by Petitioners in favor of the scant evidence presented by the SLA, the ALJ's finding was clearly arbitrary and capricious.

Charge 15: Sections 118(1) and (3) of the ABC Law

- 263. The ALJ's findings in relation to Section 118 exemplify his unwillingness to consider any evidence other than the SLA's.
- 264. Nicholas Drobenko testified as to the 30 years of unblemished record of Cloister Café, and that neighbors rarely, if ever, complained about noise from the Café. The ALJ found "[t]he more compelling evidence is that the Licensee simply disregarded them."
 - 265. This is not evidence. It is an opinion.
- 266. Mr. Drobenko's testimony was also dismissed as self-serving, because in the ALI's opinion, a party cannot defend itself with facts.
 - 267. Worse, the ALJ dismissed Petitioners' witness, Mr. Petrillo and his testimony as:
 - a. self-interested According to the ALJ, any witness testifying on behalf of Petitioners was self-interested, but those testifying on behalf of Respondents were credible without scrutiny
 - b. incompetent According to the ALJ, this law enforcement officer with over 31-years experience working alongside the FDNY, NYSO, DOB, DOH, DOT, and even the participating in COVID investigation with the SLA, was incompetent to testify as to 3-1-1 complaints
 - be hearsay It is unclear how Mr. Petrillo's own analysis of 3-1-1 calls could be hearsay under any legal standard, nor is it clear how, if Mr. Petrillo's testimony is hearsay, Respondents' witnesses' testimony is not

- d. "questionably motivated since he likely received remuneration to testify"
 There is no evidence that this was true as to Mr. Petrillo, but it can certainly be presumed that Respondents' witnesses, as employees of the SLA, were remunerated for their time in testifying.
- 268. It is clear that the ALI was determined to find in Respondents' favor and was unwilling to consider any evidence that would rebut the allegations, making this finding arbitrary and capricious.

Charge 17: Live Music

- 269. Despite not having a single witness that was at the premises on the night testify to seeing live music, the ALJ found that live DJ/disco type music was being played.
- 270. Stravalle "saw what appeared to be a DJ station with an individual stationed there."
- 271. According to the ALJ, an individual selecting music to be is "Live Entertainment" and requires a special license. If this is the scope of the rule, nearly every bartender in New York City has violated it.
- 272. Further, the ALJ has invented a concept unknown to law: that a witness not present on the night alleged can attest to the existence of not having seen live music but having "heard" live DJ/Disco-type music. This is not the law, it is the playing that must be live, not the type of music that is the gravamen of the violation.
- 273. As such the finding of this charge being sustained is irrational, arbitrary and capricious.

Charge 18: Indoor Service

- 274. The most fundamental error in all of the ALJ's findings is that the outdoor, openair space was, on the night, in one corner, transformed into, "for all intents and purposes," into an indoor space, based on Stravalle's misperception.
- 275. The law is not whether the structure reasonably appeared to look violative but whether it actually was.
- 276. Over and over, the ALJ rejected properly adduced, credible testimony form eminently qualified witnesses in favor of one who was untrained in the relevant regulations and did not carry out a proper investigation.
- 277. Further, the inferences and contradictions are illogical. Petitioners' were fortunate enough to have a unique outdoor establishment in New York City during the summer in a pandemic. Per the ALJ's logic, Petitioners then decided to transform it into an indoor space for all intents and purposes. Then, despite this transformation, neighbors complained about seeing activity therein and hearing the noise therefrom, making the transformation not for "all intents and purposes." It is a leap too far.
- 278. Had the ALJ considered this evidence, it would be clear that corner area of the rear yard was not transformed such that it could be deemed indoors because it did not have three walls and a fixed roof. As every piece of evidence, other than Stravalle's recollection of the night, shows that any service was made in the outdoor rear yard.
- 279. As such the finding of this charge being sustained is irrational, arbitrary and capricious.

Charge 19: Outside Service and Social Distancing

- 280. Charge 19 relates the Governor's Executive Order 202.3 which related to social distancing procedures for outdoor dining.
- 281. The ALJ's finding on this point is remarkable, and his insistence on focusing on what he did is disturbing.
- 282. The ALJ focused his finding on Stravalle's observation of two women kissing, stating that "[w]hatever the reason or circumstance surrounding the kissing, momentary or otherwise, its very occurrence is a serious violation of COVID-19 Rules and Regulations."
 - 283. This is flat wrong.
- 284. The ALJ, in his insistence to find guilt, refused to acknowledge that the two individuals were in the same party, that only those in the party were unmasked, and those people were seated or within the bounds of their seating area. In each instance, the individuals were adequately distanced from other parties.
- 285. In any case, the Rules and Regulations do not prohibit kissing, and the ALJ's findings are irrational, arbitrary and capricious.

Charge 20: Ceasing to Exist as a Bona Fide Premises

- 286. The ALJ sustained this charge on the basis of the purported dissolution of the entity "The Cloister East, Inc." in 1993.
- 287. The SLA has renewed Petitioners' license and accepted all necessary fees since 1993, yet now attempts to use the dissolution as a sword.
- 288. First, nowhere in the SLA rules does it say that a corporation which is dissolved is incapable of holding a license. It is a fundamental principle of administrative law that an

administrative agency has no authority to create rules and regulations without a statutory predicate. *Rotunno v. City of Rochester,* 120 A.D.2d 160, 163, 507 N.Y.S.2d 924, 926 (4th Dept.1986) *aff'd,* 71 N.Y.2d 995, 529

- 289. Second, for "all intents and purposes," as the ALI deems sufficient for some legal showings, The Cloister East, Inc. has continued to exist as an entity since the dissolution. It has paid its taxes, it has renewed its licenses, and it has paid its fees. The sole exception is an unpaid assessment from a 2016 audit which Petitioners have been working to resolve.
- 290. To sustain this charge after such an extensive history of compliance is irrational, arbitrary, and capricious.

Charges 21, 22, and 23: Willful and Deliberate Failure to Inform within 10 Days in 1993

- 291. Each of these charges relate to Petitioners' failure to inform Respondents about the dissolution in 1993.
 - 292. Each requires a degree of scienter.
- 293. There was no evidence presented that Mr. Drobenko knew in 1993 that the corporation was dissolved and further that such failure to inform in 1993 was willful and deliberate, so each charge fails.
 - 294. §110 (4) ABC Law is clear that revocation can occur only if willful and deliberate.
- 295. With no evidence showing why Mr. Drobenko knew of the dissolution, his statement that he did not remained uncontested. It is bolstered by his continued payment of taxes and continued compliance with all rules and regulations related thereto.
- 296. Rather than weigh the evidence and take Mr. Drobenko at his word, the ALI found "that Drobenko's denial and assertion strain credulity and are clearly self-serving."

297. This finding is clearly arbitrary and capricious


Charge 24: Failure to Exercise a High Degree of Supervision

- 298. The ALJ acknowledges that this Charge is, in essence, a catch-all; yet, his approach to this charge is fundamentally incorrect.
- 299. The ALI reasoned to sustain this charge predominately on the basis of numerous unreasonable adverse inferences against Petitioners. The ALI infers that because Mr. Drobenko, whose first language is not English, acknowledged that Stravalle was writing citations for what Stravelle believed to be violations, Drobenko, in essence, admitted to the charges.
 - 300. The bodycam video shows otherwise.
- 301. Furthermore, as the above Findings on the other charges were fundamentally flawed, the finding of this charge being sustained is irrational, arbitrary and capricious.

<u>The Cancellation of the License Far Exceeded the Normal Punishment for Such First-</u> <u>Time, Minor Violations</u>

- 302. Even if the Charges were to stand, and even if they were reached through a fair and proper hearing, cancellation of the License far exceeds any punishment issued by the SLA for such minor violations by a longstanding licensee with no previous violations.
- 303. For example, on November 9, 2020, Governor Cuomo announced the temporary suspension of the license of a venue that hosted a wedding on October 17 with 113 guests, more than double the permitted amount. Governor Cuomo's Press Release related to the incident is attached hereto as **Exhibit F**.
- 304. According to the announcement, the wedding led to over 30 confirmed cases of COVID-19, several school closures, and nearly 160 quarantines.
