- My sidewalk café hours or other outside hours (including Open Restaurants) will be ground floor 12:00 A.M. 11th floor 2:00 A.M.
- 5. I will employ a doorman/security personnel: maximum of five guards on all days, on the ground floor at 3 Freeman Alley and 225 Bowery; and on the 11th floor
- 7. I will close any front or rear façade doors and windows at 10:00 P.M. every night or when amplified sound is playing, including but not limited to DJs, live music and live nonmusical performances, or during unamplified live performances or televised sports.
- I will have a closed fixed façade with no open doors or windows except my entrance door will close by 10:00 P.M. or when amplified sound is playing, including but not limited to DJs, live music and live nonmusical performances, or during unamplified live performances or televised sports.
- 8. I will not have \square DJs, \square live music, \equiv promoted events, \equiv any event at which a cover fee is charged, \equiv scheduled performances, \equiv more than 2 DJs per week, \equiv more than 3 private parties per week

 DJs may play ambient recorded music in the 11th floor indoor space on Friday and Saturdays ONLY it may have incidental live unamplified music on the 11th floor indoor space no more than 3 times a week
- 10. 🗵 I will not apply for an alteration to the method of operation or for any physical alterations of any nature without first coming before CB 3.
- 11. I will not seek a change in class to a full on-premises liquor license without first obtaining approval from CB 3.
- 12. I will not participate in pub crawls or have party buses come to my establishment.
- 13. I will not have unlimited drink specials, including boozy brunches, with food.
- 14. ☐ I will not have a happy hour or drink specials with or without time restrictions <u>OR</u> I will have happy hour and it will end by 8:00 P.M._.
- 15. I will not have wait lines outside. I will have a staff person responsible for ensuring no loitering, noise or crowds outside.
