Urgent Response Is 5 Decades in Making

WASHINGTON — In 1969, President Richard Nixon's adviser Daniel Patrick Moynihan wrote a memo describing a startling future. The increase of carbon dioxide in the atmosphere caused by burning oil, gas and coal, Mr. Moynihan wrote, would dangerously heat the planet, melt the glaciers and cause the seas to rise. "Goodbye New York," Mr. Moynihan wrote. "Goodbye Washington, for that matter."

Fifty-three years later, Congress is on the cusp of finally responding to what Mr. Moynihan termed "the carbon dioxide problem."

On Sunday, Senate Democrats muscled through a \$170-billion bill designed to move the country away from fossil fuels and toward solar, wind and other renewable energy. If the House passes the measure later this week as scheduled, it will be the nation's first major climate law, coming at a critical moment when nations have entered a low-emissions era to make deep enough cuts in carbon dioxide to avoid planetary catastrophe.

Once enacted, the new law is projected to help cut the nation's greenhouse pollution by roughly 40 percent below 2019 levels by the end of this decade. That is not the end of the fight, but it would be a notable down payment on a way to avert the worst impacts of a warming planet, one that would be a "catastrophic event" ever in the history of the United States.

"Finally, now we have crossed a threshold," said former Vice President Al Gore, who as a lawmaker held the first congressional hearing on the subject in 1987. "We have passed the point where we can no longer ignore the science and the need to act."
