Slowing China Adds to Plunge in Price of Oil

But Market for Energy Can Quickly Reverse

When Russia invaded Ukraine in February, energy experts were predicting that oil prices would reach \$100 a barrel, a price that would send the costs of shipping and manufacturing into the stratosphere and bring the global economy to its knees.

Now oil prices are lower than they were when the war began, having dropped more than 50 percent in barely two months. The Monday news of a slowing of the war, however, and a rise in the price of oil, have sent prices down further, to just above \$80 a barrel, for the American benchmark.

Crude prices have fallen even further over the last few weeks, to an average of less than \$80 a barrel, and analysts at the time thought that would be the end of the price plunge.
