

I work in Architectural sales by day and on the side am a licensed NYC tour guide, hosting tours across the city for the Bowery Boys podcast. I lead guided tours that cover historic landmarks all across the city but my most popular tour, "Gay Bars That Are Gone," focuses on the East Village, an area drenched in history that is popular with tourists and historians alike. One of the most historical locations that we stop at is 82 East 4th Street, the location that once held Club 82 (and hopefully will again.)

Standing at 82's iconic door, I tell the history of this pioneering cabaret and drag performance theater, that created a space for drag performers before it became a household term. Club 82 provided a home to many important artists and personalities who otherwise would have been outcast by society at the time. This space was one of the earliest homes to the LGBTQ+ community and a place of true artistic expression and performance.
