I am writing this letter in support of the 82 E 4th Street Theater project. I have lived in NYC for the past 22 years and am a major supporter of our city's unique culture that has been fostered by our restaurants, theaters, arts and entertainment spaces. I work in Architectural sales by day and on the side am a licensed NYC tour guide, hosting tours across the city for the Bowery Boys podcast. I lead guided tours that cover historic landmarks all across the city but my most popular tour, "Gay Bars That Are Gone," focuses on the East Village, an area drenched in history that is popular with tourists and historians alike. One of the most historical locations that we stop at is 82 East 4th Street, the location that once held Club 82 (and hopefully will again.)

Standing at 82's iconic door, I tell the history of this pioneering cabaret and drag performance theater, that created a space for drag performers before it became a household term. Club 82 provided a home to many important artists and personalities who otherwise would have been outcast by society at the time. This space was one of the earliest homes to the LGBTQ+ community and a place of true artistic expression and performance. I, and many fellow New Yorkers and members of the community would be incredibly excited to see this iconic establishment reopen its doors to continue nurturing the city's greatest talents, be them brand new to the city, or seasoned professionals.

Not only was Club 82 home to cabaret and drag performance for decades during the mid-century, by the late 1960's it became home to many now world-famous musicians who began their careers in the club such as The New York Dolls, Iggy Pop, Lou Reed, and Debbie Harry to name just a few. From my extensive research, I learned that this was a beloved arts space valued by artists, and performers of the East Village community, that drew in luminaries during its heyday from uptown Manhattan, including Frank Sinatra, Judy Garland, Kirk Douglas and Elizabeth Taylor.


