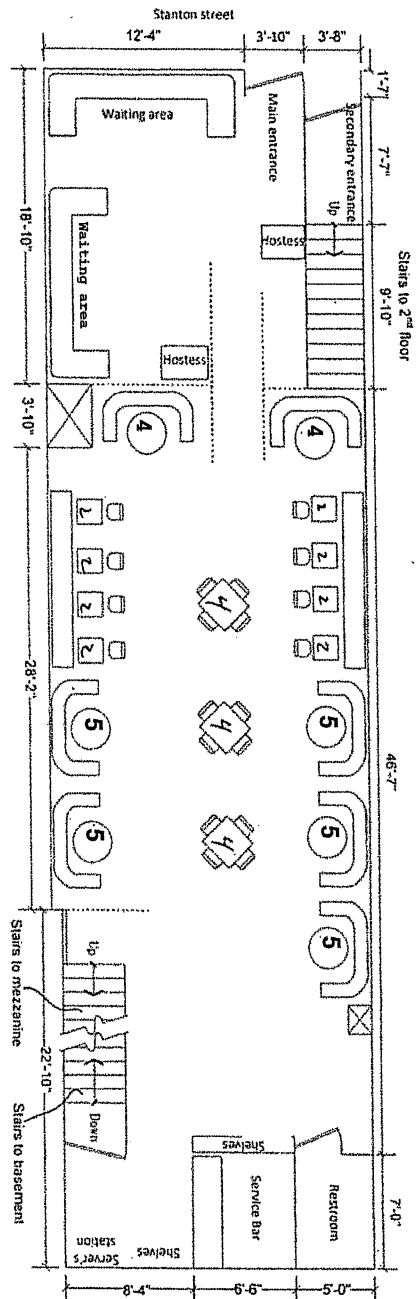

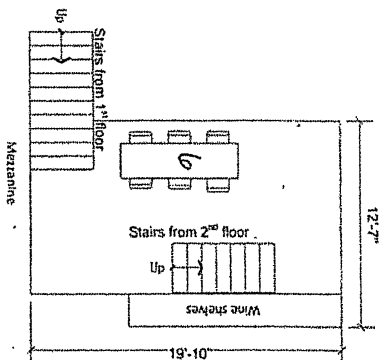

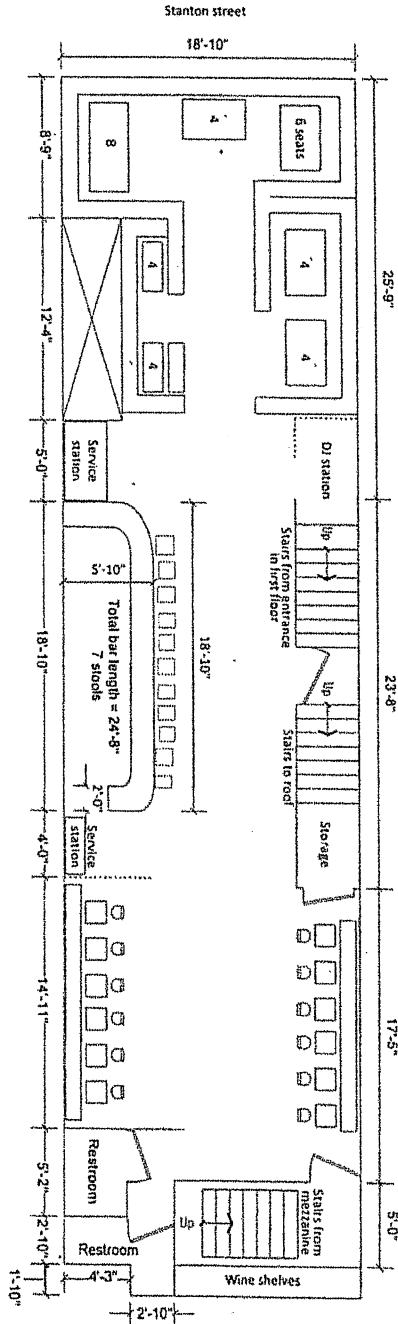


First Floor: 16 Tables/60 Seats

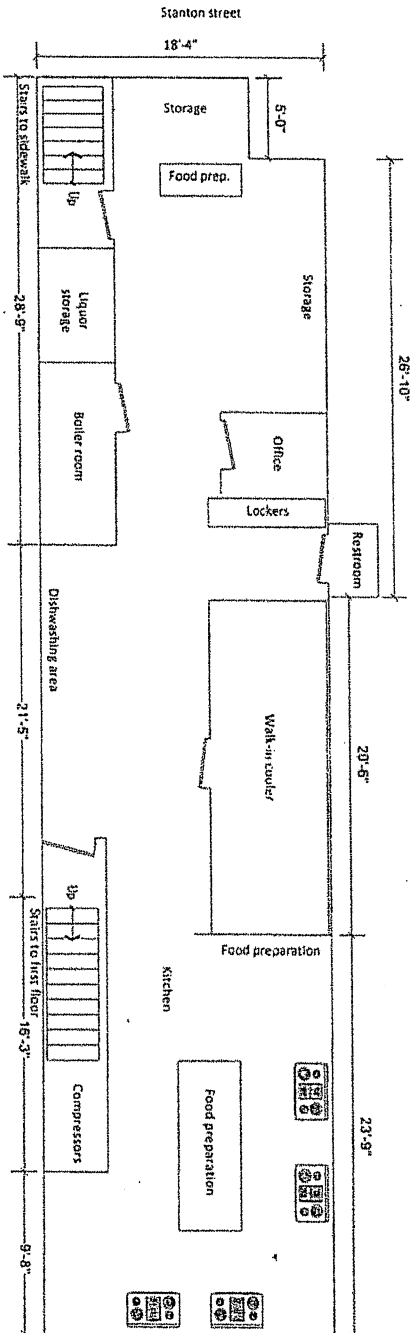




2nd Floor: 19 Tables/58 Seats
