### About Tacombi

Tacombi, as a company, began in 2005 when the founders purchased a 1963 Volkswagen Kombi bus in Mexico City, drove it through the Yucatan to Playa del Carmen, and used it to start selling tacos as a food truck. The one food truck soon became two, and the menu expanded from traditional tacos to *tortas* (Mexican sandwiches) and *agua frescas* (refreshing fruit drinks).


Around 2009, Tacombi came to New York and opened their first restaurant on Elizabeth Street in the Nolita neighborhood of Manhattan. In the decade since arriving in New York Tacombi has expanded to more than a dozen restaurants in New York and other states.

Beyond the signature colorful interiors of their restaurants, Tacombi is known for its family-friendly atmosphere, excellent cuisine – positively reviewed by many publications, including the *New York Times* and *Eater* – and high quality ingredients: Tacombi sources locally and ethically from farmers and fisherman who raise and catch hormone- and antibiotic-free meat and fish, as well as from American and Mexican companies that operate under fair trade principles. Tacombi, with its traditional cuisine, house-made tortillas, salsas, and juices, has been a welcomed addition to each neighborhood in which it has opened a restaurant and the operators are excited to join and contribute to the community.



Dario Wolos - Founder/CEO

Combining a passion for Mexican Food and Culture, Tacombi was created to share a unique perspective on the Mexican Lifestyle experience with the local consumer. Prior to launching Tacombi in Mexico's Yucatán Peninsula in 2006, Dario worked in the financial services sector, joining a startup to build their Latin American division, primarily focusing on Mexico and Brazil. Dario then moved to London where he was responsible for opening the London office, building a team and successfully launching their services in the European financial markets. Dario worked closely with the executive team as the company grew from a startup to a \$150M dollar company in 5 years when it was sold to Thomson Reuters.



Dieter Wiechmann - Chief Creative Officer

Dieter directs the design, experience and style of Tacombi properties and has directed the company's brand since it's U.S. inception. Prior to joining Tacombi full-time, Dieter served as a designer and consultant to the brand while he was also creative director at Mekanism's New York office, one of the nation's leading advertising and branding agencies, where past clients included Nike, Sony, Samsung, Charles Schwab, and Pepsi. Before that, Dieter spent 5 years in London & Berlin working on retail experience, special projects and installations for Nike.

### <u>Principals' Previous Violations</u> (per Applicant History Question)

- 1. Nine of the Company's locations were subject to separate SLA Disciplinary Proceedings which were resolved with a civil penalty fine. These disciplinary proceedings were for an inadvertent failure to disclose individuals that had invested in a holding company and/or failing to update ownership information on file with the New York State Liquor Authority. Notices of Pleading and Amended Notices of Pleading were dated July 20, 2021 and August 19, 2021. These matters were settled via Conditional No Contest pleas with a collective civil penalty of \$15,000.
- 2. The Company's Montauk location (NYCPR & Associates LLC at 752 Montauk Highway, Montauk, New York 11954 (Serial 1270864)) Had a notice of pleading dated June 21, 2019 for a sale to a minor at the restaurant. This matter was settled via a Conditional No Contest plea and \$3,000 civil penalty. Please note that NYCPR & Associates LLC is no longer part of the Tacombi organization, has been dissolved, and the liquor license surrendered.
