
Rajesh Bhardwaj - Resume as Restaurant Operator

Rajesh Bhardwaj is a New York based experienced entrepreneur and restauranteur. He is the founder of RB Hospitality Group which amongst its ventures owns Junoon New York, an award-winning fine dining restaurant in New York redefining Indian gastronomy and elevating it to unprecedented heights. Earning a "Michelin star" for eight consecutive years since opening in 2010, Wine Spectator "Best of Award of Excellence" and Forbes list of "Three Star Eateries." For ten consecutive years.

He did his Hospitality Management from the Institute of Hotel Management Pusa New Delhi, and under graduation from New Delhi University. He earned his master's degree in Hospitality Management from the International School of Tourism Sciences in Rome, Italy. Rajesh began his hospitality career in his native India with India Tourism Development Corp and Taj Hotels Group, where he was part of the Food & Beverage team.

He then moved to the United States in 1990 and opened his first venture, a small Indian restaurant in Queens, New York. Rajesh then co-founded the highly successful Café Spice Restaurant Group, which launched the first restaurant in 1998 at University Place and 11th street, New York and changed the landscape of Indian cuisine in the U.S. It realized his vision of introducing a modern bistro-style of Indian dining, which was unprecedented at the time, and ultimately expanded to 12 locations in the Northeast. He then co-founded Zaika – flavors of India which was first of its kind state of the art facility producing ready to eat packaged Indian entrees now available country wide at upscale retail stores. Rajesh served as Co-founder & COO of Café Spice until 2009 when he left to start RB Hospitality Group.

Since 2010, Rajesh has been the Founder and CEO of Junoon Restaurants and RB Hospitality Group. He has opened restaurants nationally in Orlando, Philadelphia, Maryland, Boston and internationally in India and Dubai. He has over four decades of experience in restaurant operations.
