

The applicant principal, Grant Reynolds, was a former managing partner of three wine focused restaurants: Charlie Bird, Pasquale Jones, and Legacy Records.


ILSS Wine LLC Current ground floor plan


KSS Wine LLC Proposed Ground Floor Plan
