## Trump to Stay On the Ballot in Michigan State Election

### Top State Court Leaves Room for New Supreme Court Decision

The Michigan Supreme Court on Wednesday gave Donald Trump an important victory in a legal battle over his eligibility to return to the White House by allowing the former president to appear on the state's primary ballot in February.

But in a narrow ruling, the court left the door open for a new challenge to bar Mr. Trump from the general election ballot in the battleground state over his attempts to overturn the 2020 election.

The decision was the latest in the high-stakes efforts to block Mr. Trump from returning to power. It follows the bombshell ruling by the Colorado Supreme Court, which on Dec. 19 determined in a 4-to-3 opinion that Trump should be removed from the state's 2024 Republican primary ballot for his role in the Jan. 6 attack on the U.S. Capitol.
