#### TRAFFIC AND CROWD MANAGEMENT

Traffic and crowd management will be essential to running a smooth operation. To ensure this smooth flow for both pedestrians and diners, Our restaurant will implement a multi-pronged approach.

Reservations and Wait Management: We will encourage patrons to make reservations in advance through a user-friendly online platform or by phone. This will allow us to anticipate guest volume and manage seating accordingly. Furthermore, we will politely request that guests arrive no more than 15 minutes before their reservation time to help avoid congestion on the sidewalk as patrons wait for their tables.


Walk-in Policy: During off-peak hours and when tables are available, we will accommodate walk-in customers. Our staff will efficiently communicate wait times and seating options, ensuring a positive experience for both those with reservations and those who choose to walk-in.

In the event of a short waitlist during peak hours, we will implement a clear and organized queue management system, utilizing a digital waitlist or designated waiting area inside the restaurant to minimize any sidewalk congestion. There will be no standing wait lines on the sidewalk itself. A staff member on duty will always be responsible for ensuring there is no loitering or crowds gathering outside the restaurant. We are confident in our ability to maintain a pedestrian-friendly environment on 103 1st Avenue.

#### NOISE MANAGEMENT

We will implement a comprehensive noise management plan to remain respectful of the surrounding neighborhood. Our music selection will be curated to serve as a pleasant background element. Speakers will be strategically placed away from the street to minimize noise pollution outside. Music volume will be consistently monitored and lowered after 10pm to ensure a quieter atmosphere for our later guests and the surrounding community.

We will have a designated staff member on duty during all operating hours who is responsible for monitoring and adjusting music levels. This dedicated person will ensure compliance with our noise management plan, particularly the later volume reduction. Additionally, an on-duty manager will be present at all times, ensuring a prompt response to any potential noise concerns and quick adjustments as needed. We are good neighbors and remain committed to fostering a responsible and respectful environment for our diners and the neighborhood.
