Below are the stipulations which we have collectively agreed upon in order for SPaCE to back the SLA application for White Horse Concepts LLC, located at 167 East Broadway:

- 1. Closing hours for White Horse Concepts LLC
 - a. Sunday-Thursday 12 am
 - b. Friday-Saturday 2 am
- 2. Windows, doors, and outside spaces (gardens, sidewalk cafes) will close at 10pm or before.
- 3. Lines will not be permitted to form outside.
- 4. No DJs. Ambient background music only.
- 5. Patrons smoking cigarettes will be contained within the area directly in front of 167 East Broadway
