Community Board 3, Manhattan has no objection to the alteration of 162-4 Ave B Bar Inc. D/B/A Dream Baby, at 162-164 Avenue B, for adding municipal space as long as the agreed upon attached stipulations are added to the license.

- 1. Will close all outdoor seating by 10 pm.
- 2. All outdoor dining patrons will be seated at tables.
- 3. Will not have music, amplified sound, or TVs outdoors as per Open Dining Guidelines, and will remove all outdoor speakers.
- 4. For roadbed seating, will comply with DOT guidelines. Will have 10 tables and 20 chairs.
- 5. Will have a staff person responsible for ensuring no loitering, noise or crowds outside.
- 6. Will conspicuously post this stipulation form beside liquor license inside of business.
- 7. Residents may contact the manager/owner at the number below. Any complaints will be addressed immediately. Will revisit the above-stated method of operation if necessary in order to minimize establishment's impact on neighbors.
