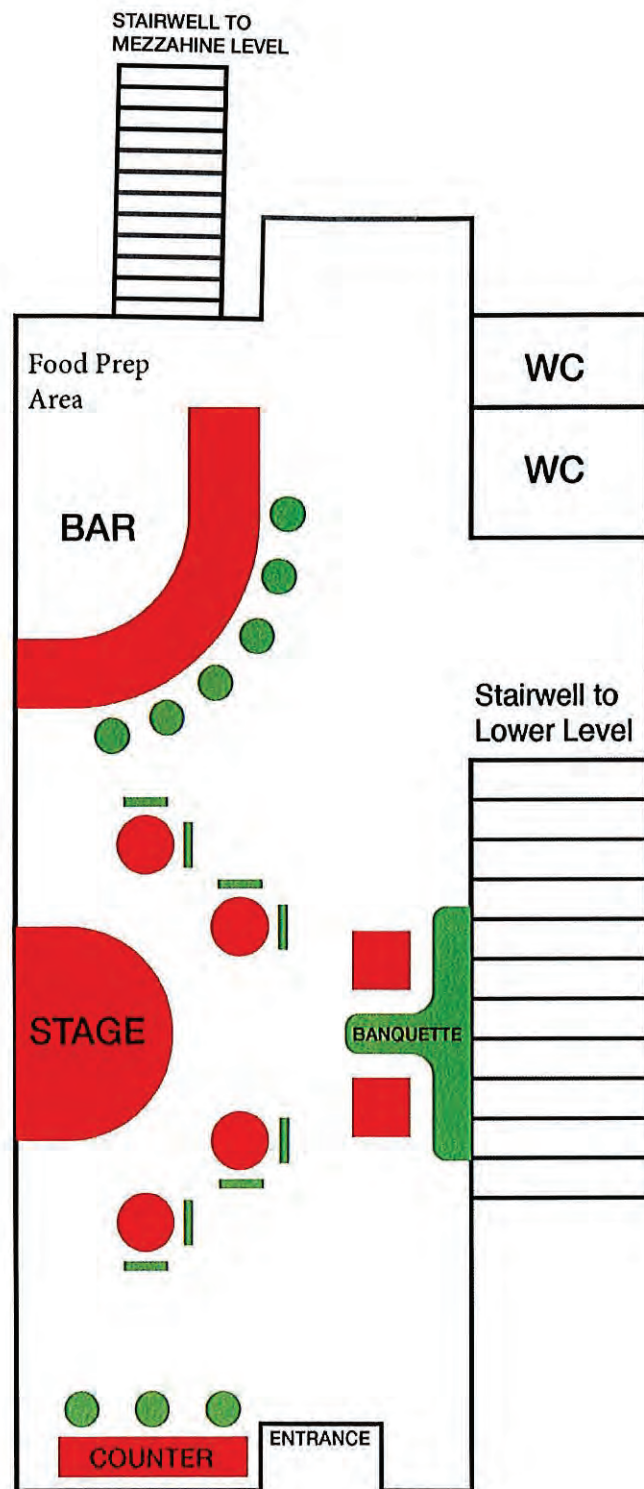

Ground Floor Diagram



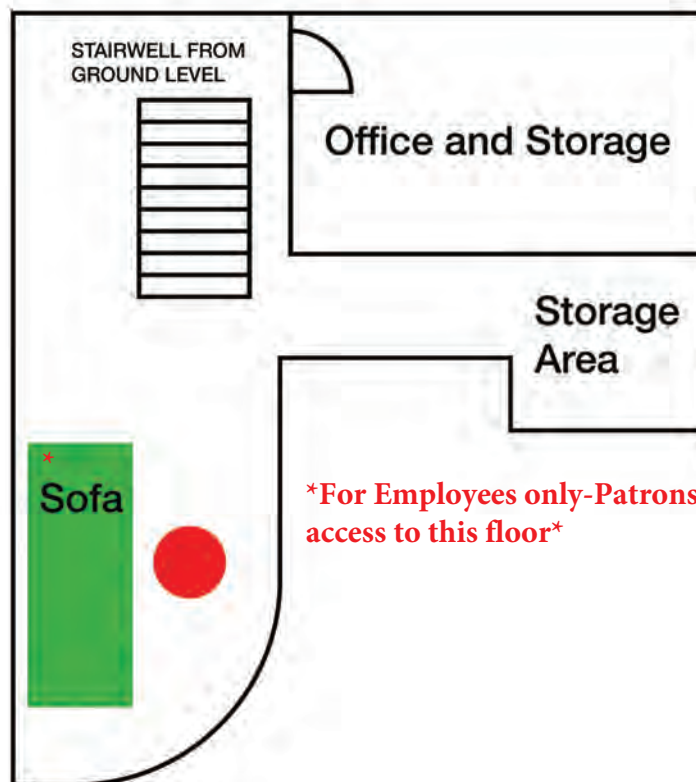

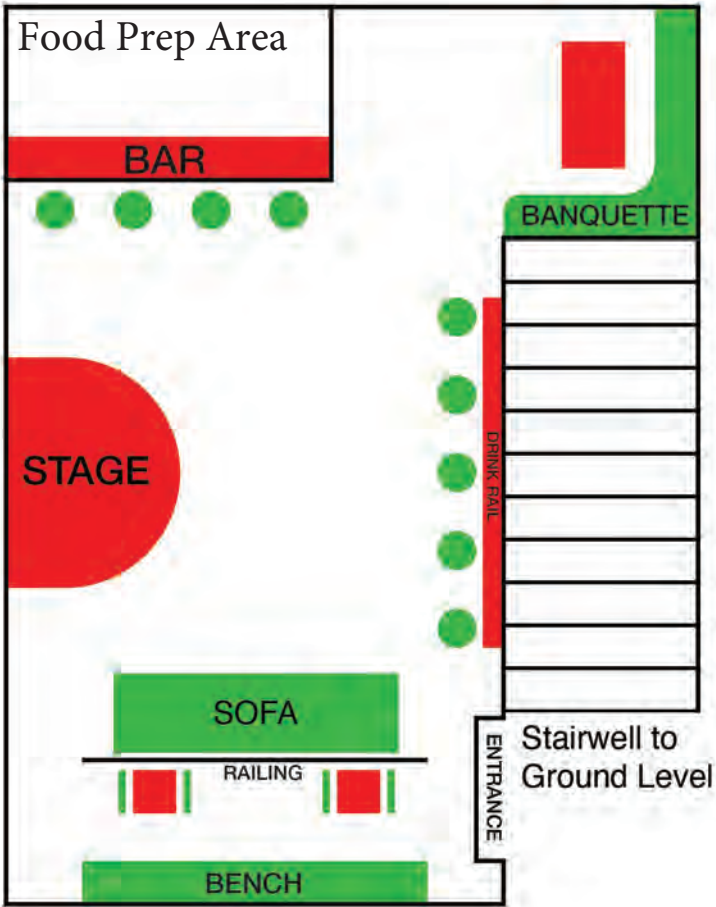
Mezzanine (Second) Floor Diagram
