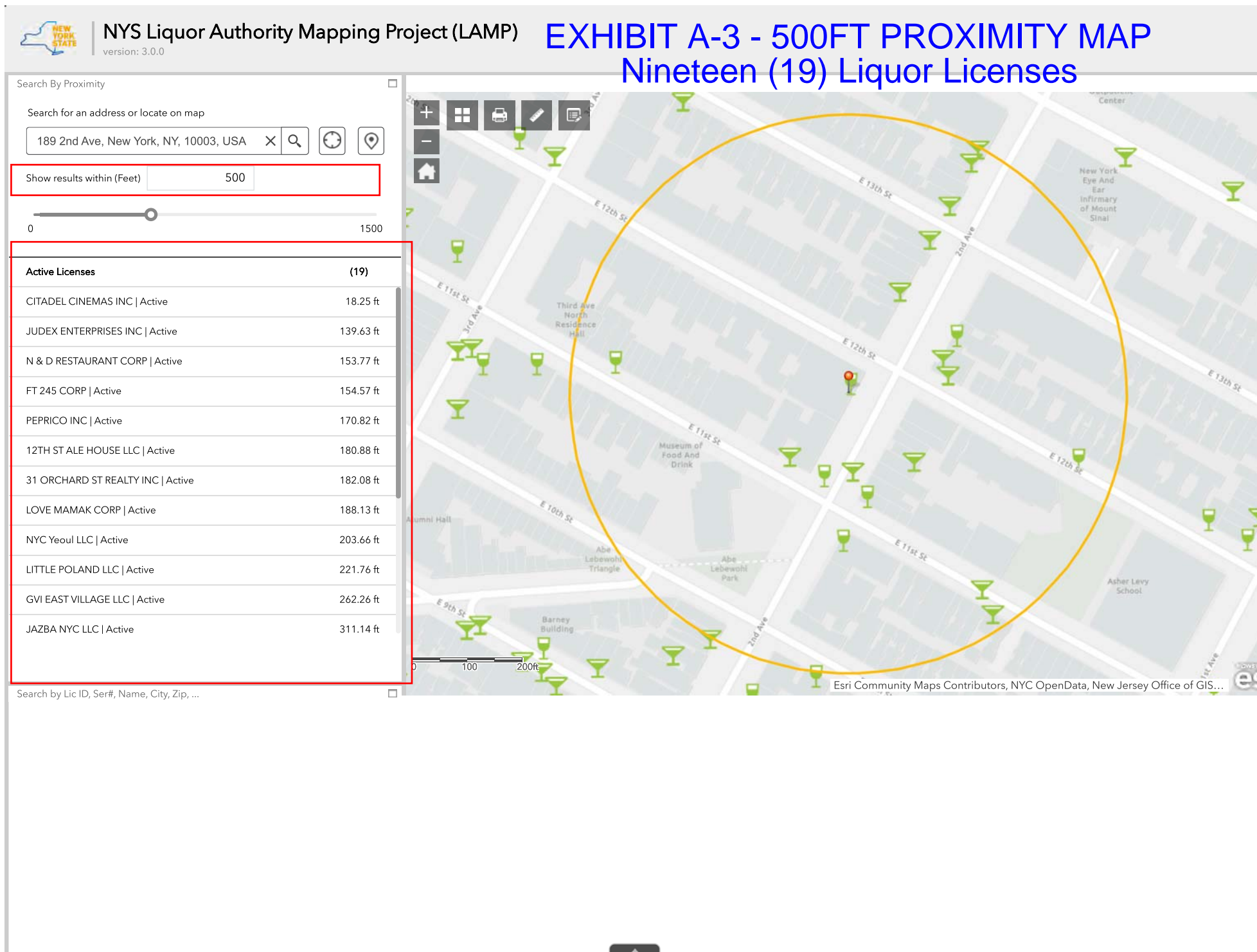

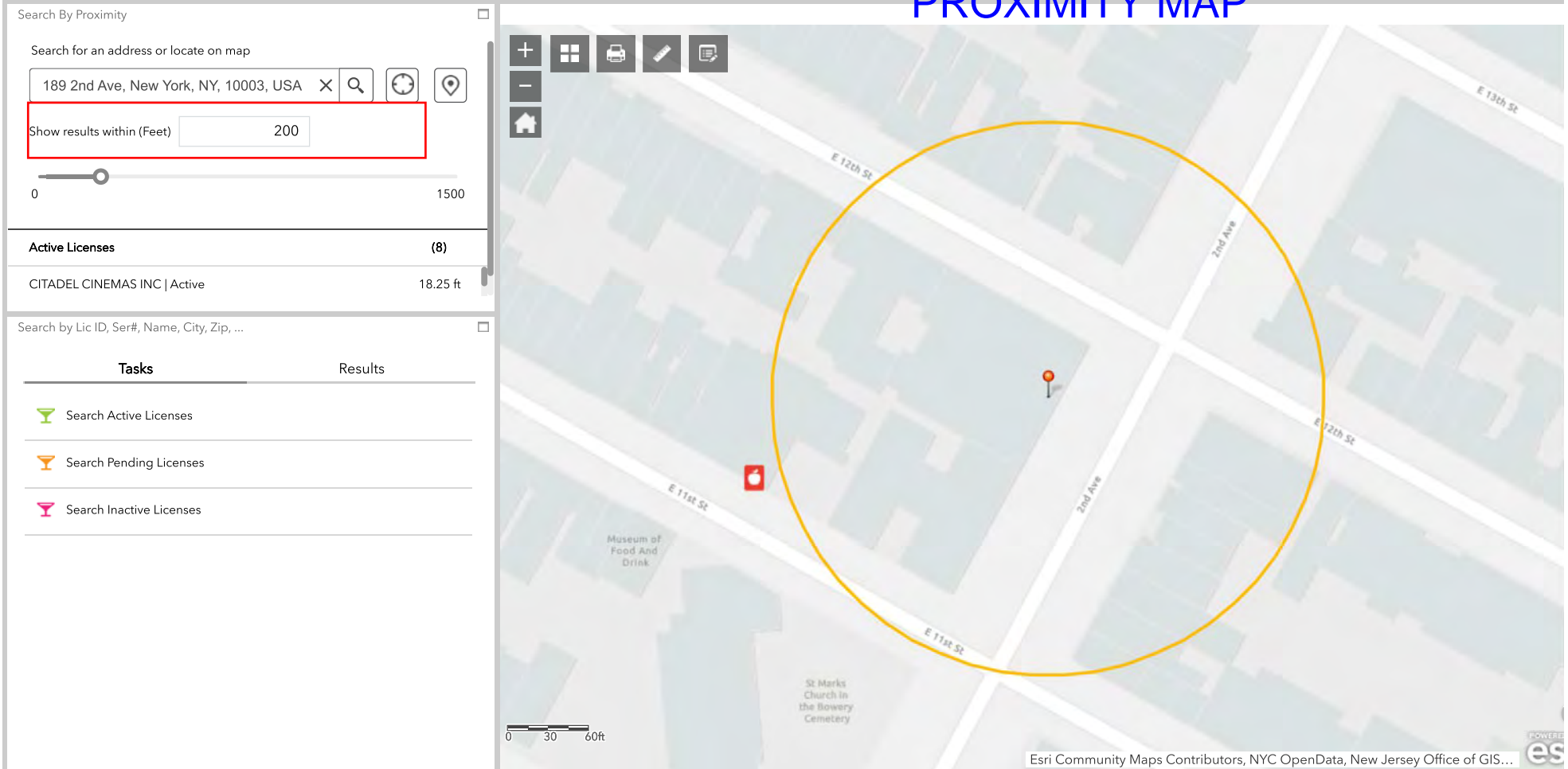

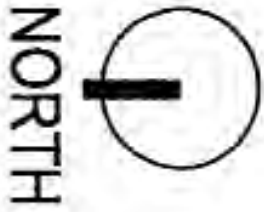

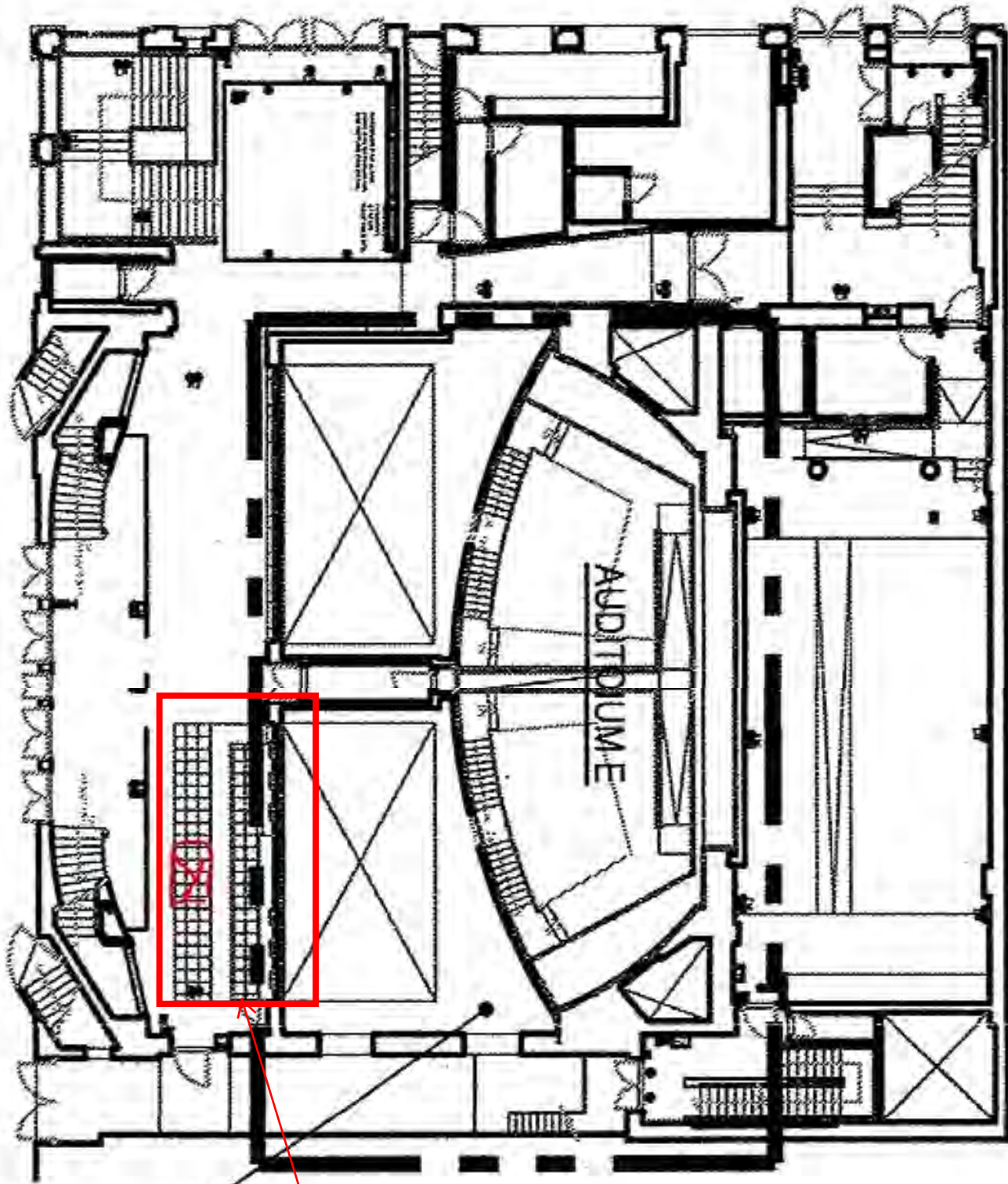


1ST FLOOR - Concession Counter and Main Auditorium
