China champions vision, action for women's cause

President Xi Jinping made his first public appearance in New York in September 2015, on the occasion of the world body's 70th anniversary. It was three days after the 2015 Women's World Cup final, which China lost to Sweden 2-0. Xi's speech at the UN, the fourth World Conference on Women, was a landmark moment in the global progress in gender equality. He outlined a special package of state and government, as well as representatives of various countries, reaffirmed their commitment to achieving gender equality and women's development.

The global cause of women's development has always been an important part of China's foreign policy. Over the past 70 years, before Xi's speech at the UN, the fourth World Conference on Women was held in Beijing, China had already made significant progress in gender equality. It was during this conference that 189 countries adopted the Beijing Declaration and Platform for Action, which has been widely recognized as the most comprehensive and widely endorsed blueprint for women's development in the world.
