



My name is Matthew Webber and I am a bar/restaurant proprietor looking to open a new establishment in the lower east side. I have over 25 years of experience and currently own a lounge called The Ripple Room on the Bowery.

Having grown up in this city and lived here all my life, I deeply understand the uneasy balance of nightlife and resident's peaceful enjoyment in their communities. No one, including myself, wants to live near an establishment that does not respect their neighbors. Noise pollution and garbage on the streets caused by commercial businesses are unacceptable. To this concern, when I find a potential location on a busy thoroughfare, with relatively few residential apts, I feel compelled to reach out to neighborhood organizations such as the East Village Community Coalition for their support.

This commercial space, located at 31 2nd Avenue is an ideal location for a lounge bar/restaurant because it will have a minimal adverse effect on its neighbors. There will be no outside dining, no open windows and no live music. Across the street is a large mini storage building. Although there are apartments above this location, we will install effective soundproofing to shield them. Most of the inhabited are recent NYU graduates and the turn over is 90% every two to three years and there are zero families with children. I have been going door to door and held a meet-and-greet in the building with overwhelming success.
