We want to let you know that Vaidstone Holdings LLC will be filing applications for a beer, wine and cider license and temporary retail permit for the premises located at 170 Avenue A aka 500 East 11th Street (on the southeast corner of Avenue A and 11th St). The former business at the space was a 7-Eleven store that operated with a grocery store beer license from around 2014 to 2024.

The new venue will be a café and bookstore. It is inspired by Parisian book cafes that are gathering places for guests who want to participate in intelligent conversations about history, current events and great works of literature past and present. The venue will offer events such as book clubs and author readings.

The cafe menu will feature items such as (but not limited to) breakfast pastries, sandwiches, cheese and charcuterie boards, and desserts.

The venue will occupy the ground floor (2,684 square feet) and will have 8 tables and 16 seats, together with an 18-seat, 34 foot long customer bar, for a total of 34 seats.

Background music will be played throughout the day and acoustic live music will be played on occasion. There are no outdoor spaces, or doors or windows that open. The hours of operation are to be 8am to 12am Sunday to Wednesday, and 8am to 1am Thursday to Saturday.

The owner of the café and bookstore is Marianna Vaidman Stone, a life-long New Yorker who received a JD from NYU Law School and has held senior roles in NYC government as well as at a number of nonprofit organizations that advocate for a more livable New York. She is dedicated to making the café and bookstore a welcoming establishment in the neighborhood.

The application for the beer and wine license will be presented at the Community Board at its meeting of December 8, 2025.
