Plans to Manage Vehicular Traffic and Crowds on Sidewalk

I plan to continue operating an establishment that will not negatively impact our neighbors. I do not anticipate large crowds on the street, and will ensure that the premises is maintained in an orderly fashion at all times. I will designate an employee to make sure that a crowd of patrons will not form in front of or adjacent to my establishment as I do not want to disturb the quality of life of my fellow neighbors.

I will have signs visibly posted inside and on the storefront reminding patrons to be courteous of the neighborhood and to keep noise to a minimum. However, should a crowd form in front of or adjacent to our establishment, I will immediately inform the crowd that they are not able to congregate in front of the establishment.

I understand that parking is limited in the area. I anticipate that the overwhelming majority of my patrons will be walking; I plan to serve a community that lives and works in the immediate vicinity.

Plans to Manage Noise Inside and Outside of Premises

I will be installing soundproofing at my establishment so that the conversations of patrons and music will not emanate to the residential apartments surrounding my establishment. My plans are to continue running a friendly neighborhood establishment. The entertainment to be provided will be for quality and not for volume with a set compressor limiter for a predetermined sound level that will be tested inside the residential units above and outside of the establishment as a warning to the staff should the noise become too loud.

The cell number of myself as well as the manager will also be given to the residents of the building should they feel the need to call immediately if any noise is disturbing their quality of life. I plan on keeping any noise to a minimum.

The principal, Abigail N. Ehman, has substantial prior experience owning and operating hospitality establishments in the immediate neighborhood of the proposed business. Her experience includes full operational responsibility for staffing, safety, customer management, and compliance with New York State and City regulations governing nightlife and food and beverage establishments.

Abby Ehmann has been a resident of Manhattan since 1985 and the East Village since 1989. She has dabbled in a dozen different careers, from the early internet, to advertising, event production to publishing, even working for Burning Man, all the while bartending as well. With a chameleon-like ability to vacillate between diverse worlds, Ms. Ehmann made contacts everywhere she went, which helped her launch both of her businesses.

In the Spring of 2016 Abby opened Lucky, a small, neighborhood bar. The community she created there inspired her to offer a similarly welcoming space for those who do not drink alcohol right across the street at Hekate Café & Elixir Lounge, New York City's first sober bar.

Drawing on all her previous experiences, Abby produces events, books musical acts, and schedules every imaginable celebration to keep both spaces fresh and interesting. As a board member of the small business organization East Village Independent Merchants Association, she has become involved in the local politics and events, bringing in family entertainment as part of the city's Open Streets Program.

She is currently juggling everything involved with running her two successful businesses.

There is another exit from this room to Exit 3 that takes you up to rear of 1st floor bar

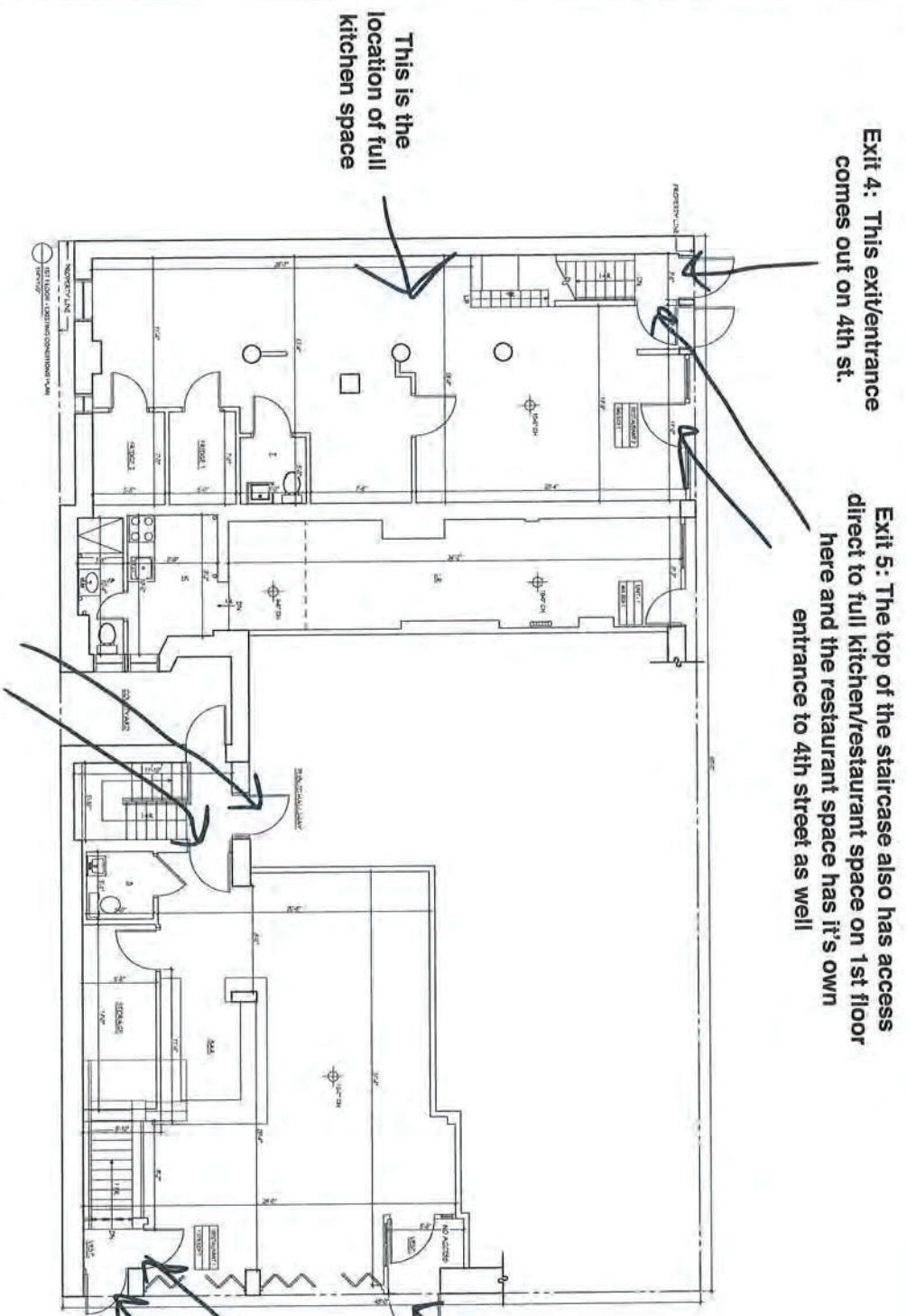
Exit 1: This staircase goes up from the basement Ave B exit. You also have another entrance to 1st floor bar at top of the staircase.
