# Full Board Meeting Larry Horowitz, Chair July 10, 2001

# **District Manager's Report**

Penny Ryan reported on the Department of Health's rat abatement project in CD7, proposed newsrack legislation, and other issues covered in the DSC minutes. She thanked ADM John Martinez and Community Associate Shanifah Rieara for their work on behalf of the Board.

# **Public Session**

Sandi Kamerman, St. Christopher's Inc. Family Day Care, discussed childcare services in CB7.

Rowena Daly, Parks 2001, announced that she has left the West Side WMCA and joined Parks 2001. She reported that the Y's affordable housing will be available in the fall.

Joyce Brown spoke about services to the middle-income elderly.

Brad Usher, State Senator Tom Duane's Office, reported on rent increase issues and the banning of cell phones while operating a vehicle.

Dan Golub, Assemblymember Gottfried's Office, reported that the MTA will consider an entrance to the 72<sup>nd</sup> Street IRT on the 70<sup>th</sup> Street. He also said the Assemblymember has requested public hearings on the MTA's changes in subway token booth staffing.

Sascha Purin, State Assemblyman Scott Stringer's Office, spoke about legislation requiring charities to spend at least 50% of contributions on services and announced a rally at PS 87 about the BOE budget cuts.

Linda Rosenthal, Congressman Jerrold Nadler's Office, cited the Congressman's press releases on faith-based initiatives and said that the Congressman wrote the law requiring the MTA to hold public hearings on matters such as staff changes.

Christine Argentina announced the Manhattan Borough President has submitted a letter against the renewal liquor license application for Moonlighting.

# **Landmarks Committee**

# Co-Chairs: Lenore Norman and Dan Cohen

1. The Abraham Joshua Heschel School, 270 West 89<sup>th</sup> Street.

Lenore Norman presented the background of the resolution, stressing that the purview of the committee is limited to what is visible from the street. Other issues, such as air and light, will be taken up by the Land Use Committee when the school submits an application to BSA.

# Public Speakers:

- Paul Cleremont, 251 West 89<sup>th</sup> Street, spoke against the application and requested that the school downsize the plans.
- Liz Newmark, spoke in support, saying the facade and the program would be improved.
- Allen H. Brill, Brill & Meisel, representing the Savannah Owners Corp, spoke against, commenting that the plan increases the building's size by 50%, affects light, air, and the rear yard; and is visible from 88<sup>th</sup> Street. He also asked for a reduction in size.
- Alice Lippman, 251 West 89<sup>th</sup> Street, representing the Heschel School Renovation Protest Group, spoke against the application based on size, questions about increases in the number of students, and light.
- John Casey, The Savanah, spoke against the application and distributed site-line photographs and petitions.

- David Lloyd, 251 West 89<sup>th</sup> Street, spoke against plans and objected to noise from the current rooftop playgroud.
- Sonja Noring, 267 West 89<sup>th</sup> Street, commented on the Landmarks Law and objected on the basis of architecture and preservation.
- Eyal Farage, 250 West 90<sup>th</sup> Street, spoke in favor of the application, mentioning the needs of the students.
- Alisa Doctorofe, 309 West 91<sup>st</sup> Street, a parent of a child at the school, said the plan will add character to the neighborhood and talked about meetings the school held with neighbors.

Mark Levine, attorney for the school, reviewed the two sets on photographs - one from the school and one from Mr. Casey. Ms. Norman described what was shown in the photos. She further commented that the committee's resolution was based on visibility from the street, appropriateness of materials, and LPC's view that additions should not replicate the original structure.

Application #01-4812 to the Landmarks Preservation Commission to construct a rooftop addition and create window openings was not adopted: 11-11-5-0. After discussion of how to proceed, the Board decided to send the resolution to LPC with the 11-11-5 vote.

# Uniformed Services and Environment Committee Melanie Radley and Hector Santana, Co-Chairs July 12, 2001

1. State Assembly Bill A09012 to establish local control of liquor licensing.

The committee concluded the bottom line on this pending piece of legislation is that in its current form it could neither be passed nor implemented. The resulting conflicts that the bill would create between existing state and local regulations and laws would create a legal quagmire necessitating the lengthy repeal of municipal and state statutes. The committee decided that no resolutions on the legislation are necessary.

2. NYC Council resolution to amend the administrative code of the city of New York to license promoters.

After considerable discussion, the committee determined that even though the resolution evolved out of recommendations from the borough president's nightlife task force report, that it would be more effective to advocate legislative initiatives to enforce and strengthen regulations that would hold the owner of venues rented to promoters accountable for actions of promoters. While attempting to strengthen enforcement of nightlife by licensing and fining promoters, the effect of the legislation would be to shelter the owners. Under the proposed legislation, the promoter, not the owner becomes responsible for anything that occurs outside the venue. Because the established cost for a promoter to go into or out of business is minimal, owners and promoters will collude to shift any responsibility. The committee agreed to draft a resolution for the September Board meeting recommending that city council amend current legislation to insure that owners be held accountable for the actions of the promoter and that the promoter adhere to all the regulations governing dance events proposed in the pending legislation.

3. Discussion of Letter from CO Raymond Spinella re: Violations at Valley Restoration Street Festival, 6/24/00.

The Committee reviewed the letter that cited several current violations by the promoter. Mardi Gras

The Committee reviewed the letter that cited several current violations by the promoter, Mardi Gras Production owned and operated by Joe Giovanni. Noting past difficulties with the promoter at this particular festival, Captain Spinella recommended to Manhattan North that Mardi Gras not be issued any future permits for street festivals in the confines of the 24<sup>th</sup> Precinct. Under CB7 street fair guidelines, the sponsor of the street fair is responsible for the actions of its employee, the promoter. The committee concluded that it will consider the suitability of Valley to host another fair in light of its continuing inability to supervise its promoter. Captain Spinella's letter will be added to Valley's file for discussion when applications for 2002 street fairs are reviewed. In the meantime, a letter will be drafted to the Department of Consumer Affairs and Mildred Duran in the Mayor's Office forwarding Captain Spinella's letter. The Board letter will state that the pattern of consistent violations by Valley and its promoters will be a serious consideration in reviewing any future Valley applications. CB7 anticipates that the Mayor's Office and the Office of Consumer Affairs will concur with the community. We will also recommend that the Department of Consumer Affairs and Mildred Duran arrange a meeting with Captain Spinella to review the violations and determine what steps the Department may wish to take in assisting the police with Mardi Gras Productions. A copy of this letter will be cc'd to the commander of Manhattan North, Captain Spinella, and Valley Restoration.

4. Resolution to support Councilmember Perkins' rat initiative.

The committee will draft a resolution supporting Councilmember Perkins' resolution and urging residents of CB7 to voluntarily switch to plastic garbage containers to prevent rats.

# Transportation Committee Co-Chair: Andrew Albert and Dan Zweig July 17, 2001

1. 636 West End Ave. (91<sup>st</sup> St): Application to the Dept. of Transportation by David Nahum and Anna Cypel for revocable consent to enlarge a front areaway. (Joint with Landmarks Committee).

The applicants presented plans for the reconstruction of the front entrance to their building featuring the enlargement of the front areaway, with new stairs and a planter over the garbage can area. The plans have been approved by the Landmarks Preservation Commission (at staff level). Transportation committee approval is required since the plans call for the extension of the building line onto public sidewalk. This was the second appearance by the applicants since there was an issue of adequate notice raised at the last meeting. The new structures would extend only as far as when the building previously had a stoop and

the last meeting. The new structures would extend only as far as when the building previously had a stoop and would bring it in line with the building lines on either side. Brendon O'Connor, a tenant in the building, raised objections to the notice and the process and generally, on the grounds that the tenants preferred to keep the front of the building "as is." Based on the improvement in the entrance stairs, the hidden location of the garbage cans and the general improvement to the streetscape to be accomplished by the renovations, the committee voted to approve.

Whereas, David Nahum and Anna Cypel, owners of 636 West End Ave. (91st St.), have applied to the NYC Dept. of Transportation for a revocable consent to enlarge the front areaway of their building, and

Whereas, the plans presented at the joint Landmarks and Transportation Committee meeting were previously approved by the NYC Landmarks Preservation Commission (at staff level) and generally showed that the new construction would improve the streetscape, by upgrading the building entrance, providing a planter and hidden area for garbage cans and bringing the entrance steps up to code,

Now, therefore, be it resolved that Community Board 7 approves the application of David Nahum and Anna Cypel to NYC Dept. of Transportation for a revocable consent to enlarge the front areaway of their building at 636 West End Ave., NYC.

Vote: Transportation Committee: 5-0-0-0. Landmarks Committee: 1-0-0-0. Public Members: 0-0-1-0.

2. 214 RSD (93<sup>rd</sup> - 94th Sts.): Application to Landmarks Preservation Commission by BAS Communications to legalize the installation of a curbside telephone pedestal without LPC permit and an application (#66969) to the Dept. of Information Technology and Telecommunications for a public pay telephone permit.

This application was approved by the Landmarks Committee in June 2001. The applicant was not present. The phone has been installed on RSD, on the service road, on the southeast comer. It is a pedestal phone. The permit specifically forbids the installation of any advertising on the phone. Although there are phones on WEA, at 93rd and 94th Sts., there are none on RSD for approximately six blocks. Alan Flacks spoke in favor, on the grounds of the safety and the absence of phones in Riverside Park. The committees voted to approve:

Whereas, BAS Communications has applied to the NYC Landmarks Preservation Commission to legalize the installation of a curbside telephone pedestal without LPC permit and an application (66969) to the NYC Dept. of Information Technology and Telecommunications for a public pay telephone permit, and

Whereas, the phone is a pedestal phone located on the service road on Riverside Drive between 93rd and 94th Sts., an area which is less heavily trafficked and with fewer public phones than other neighborhoods and consequently, is an area in which safety concerns are important,

Now, therefore, be it resolved that Community Board 7 approves the application to Landmarks Preservation Commission by BAS Communications to legalize the installation of a curbside telephone pedestal without LPC permit and an application (66969) to the Dept. of Information Technology and Telecommunications for a public pay telephone permit, and

Be It Further Resolved that Community Board 7 formally requests the NYC Dept. of Information Technology and Telecommunications to refrain from permitting the installation of pay phones in landmarked districts or adjacent to landmarked buildings without prior consultation with the community, Community Board and without prior approval of the NYC Landmarks Preservation Committee.

3. 44 West 106<sup>th</sup> St. (aka 142 Manhattan Ave.): Application to the NYC DOT by 142 Manhattan Ave., LLC for revocable consent to construct planted area with a fence, trash receptacle enclosure on sidewalk.

This was the second appearance before committee. Applicants were urged to meet with neighbors and members of block association, Duke Ellington Block and Neighborhood Association (DEBNA) who oppose the taking of the sidewalk and the installation of 60' long fence in front of the building. Applicants were represented by Lou Futterman and architect. No consensus was reached. Applicant agreed to present detailed landscape drawings, which were not done. Applicant to bring landscape drawings to CB7 prior to Steering Committee on July 25.

- 4. Request by Plant Shed, 309 West 96<sup>th</sup> St. to NYC DOT for truck loading zone, 8 a.m. to 8 p.m. on north side of West 96<sup>th</sup> St., between Broadway and Amsterdam.
- J. Casiano, one of the employee-owners of Plant Shed, appeared to discuss the application. His business has many delivery trucks, which are usually forced to double-park, thus creating traffic problems for westbound 96<sup>th</sup> St. traffic. The loading zone would require elimination of two parking spaces between the bus stop and Holy Name rectory. It would be used cooperatively by the Plant Shed, the bike shop next door and a restaurant and grocery tore across the street. Mr. Casiano has received promise of cooperation from the church and has posted signs in the neighborhood. Committee voiced concerns about enforcement and Mr. Casiano undertook to get a letter from 24" Precinct, promising serious enforcement, if application granted. He will return in September. He will continue to post notices in the neighborhood.
- 5. Application (B01736) to NYC Taxi & Limousine Commission by Limo Link, Inc. for luxury limousine base station at 250 West 61st St.

Meir Amir appeared on behalf of the applicant. The base station is being relocated from 28<sup>th</sup> St. Vehicles will be housed inside garage at site between Amsterdam and WEA. Mostly commercial trade; vehicles leave early in the morning and return to garage at night. Little impact on neighborhood traffic. Committee voted to approve.

Be it resolved that Community Board 7 approves the application of Limo Link, Inc. for a luxury limousine base station at 250 West 61st St.

6. Discussion of proposal by Peter Arndtsen, Executive Director of the Columbus-Amsterdam BID to the NYC Dept. of Parks and Recreation (Greenstreets Program) and DOT to create a greenstreet on the west side of Amsterdam and 110<sup>th</sup> St.

Amsterdam is 2-way on the north side of the intersection. As an aide to motorists, DOT has erected barriers and signage. The proposal is to erect more aesthetically pleasing barriers softened by trees and other appropriate plantings. The proposal is in planning stages but has tentative DPR and DOT approval, as well as approval from local merchants. Many details remain to be worked out, but committee gave tentative approval to the concept.

Be it resolved that Community Board 7 approves the concept of a Greenstreet on the west side of Amsterdam Ave., south of West 110<sup>th</sup> Street, with details to be provided at a later date. Vote: Transportation Committee: 4-0-0-0. Board member: 1-0-0-0. Public Members: 2-0-0-0.

Mr. Horowitz reported on the discussion at the joint committee meeting on the combined-sewer overflow problem and said there was insufficient information at this time to make a recommendation on developing marshland.

Hope Cohen said marshland was not an appropriate element in this neighborhood park.

Bill Crane, an area resident, spoke in support of the marshland, saying that it would help restore the river and set an example for other waterfront projects.

Matthew Harrison, RSS Planning Corp, stated that the rip-raft was chosen to make the phasing more efficient and the park design will continue to evolve and consider these issues.

An amendment to include the creation of marshland at the shoreline was not adopted.

The co-chairs presented the following resolutions.

- **12. 1 West 88<sup>th</sup> Street, Treavor Day School.** The resolution to approve application #016754 to the Landmarks Preservation Commission to install through-the-wall air conditioning units, was adopted: Melanie Radley stated that the applicant had not notified the local community. The Board will send a latter to the school on this matter.
- **13. 6 West 87**<sup>th</sup> **Street**. The resolution to approve application #016899 to the Landmarks Preservation Commission to construct a rooftop addition, was adopted:
- **14. 301 West 108**<sup>th</sup> **Street, Manhasset**. The resolution to approve application #016147 to the Landmarks Preservation Commission to establish a master plan governing the future installation of storefronts between West 108<sup>th</sup> and 109<sup>th</sup> Streets, was amended to read that the Board disapproves the proposed plighting of the business signs on the facade and recommends that the plans include historically appropriate lighting. The resolution, as amended, was adopted:

#### **Resolutions Re:**

- **15.** The resolution to approve Councilmember Bill Perkins' Intro 823 to require plastic containers for garbage storage was adopted: George Zeppenfeldt-Cestero asked about more effective enforcement by the Sanitation Department of garbage storage requirements. Richard Asche observed that solving the rat problem will require the commitment of residents and buildings as well as community organizations.
- **16.** The resolution on Councilmember Karen Koslowitz's Intro 960 to amend the Administrative Code to license promoters will be rewritten and considered at the September full Board meeting. The Board felt the Intro should

hold club owners responsible rather than promoters. Mr. Horowitz asked Eric Nelson and Bob Herrmann to help with the redraft.

# Committee reports and new business.

Barbara Van Buren and George Zeppenfeldt-Cestero reported on The AdvantAge Initiative, a project of the Center for Home Care Policy and Research of the Visiting Nurse Service of New York, which was presented at the July 24 Health Committee meeting. VNS will conduct telephone surveys in seven communities across the country to provide a "data snapshot" of the needs of older adults. VNS will conduct a random survey of seniors in the Lincoln Square Neighborhood Center NORC and the area between 72<sup>nd</sup> and 96<sup>th</sup> Streets, excluding Central Park West. The Federal government is providing names and numbers of Medicare recipients in the survey areas. The results will be published and made available to the public. VNS is seeking help from CBOs to let seniors know about the survey and encourage them to participate.

After considerable discussion, the Board decided not to endorse or support the Initiative.

Dan Zweig reported on two sidewalk cafes that are not in compliance with their permits. DCA inspectors determined they were in compliance since they did not take up more than one-half of the sidewalk. ADM John Martinez is talking with DCA about the need to inspect with plans that show what is permitted, which is usually not one-half of the sidewalk. Mr. Zweig recommended that the Board visit cafes and send letters to the operators if they are not in compliance, and to make this part of the cafe's file. Mr. Horowitz asked that this be taken up by the Land Use Committee.

Barbara Adler and Bob Herrmann reported that the Parks Committee was supportive of Parks 2001, which was presented to the committee on July 18. Mr. Horowitz said a committee should have full hearing on any election platform proposal, such as Parks 2001 and the Housing Initiative, and present a resolution to the full Board for its consideration.

There being no further business, the meeting was adjourned at 10:30 PM.

Note: Since the full Board does not meet in August, the Steering Committee acted on its behalf at its July 25<sup>th</sup> meeting. Resolutions adopted at the July 25 Steering Committee meeting will be ratified by the full board at the September 4 full Board meeting.

# Landmarks Committee Dan Cohen and Lenore Norman, Co-Chairs July 19, 2001

# 1. Treavor Day School, Michael Pribyl, Architect.

To approve a renovation to add air conditioning louvers beneath windows on top floor of building. This is the first part of a plan to renovate the entire building, one floor at a time. Louvers are 4" X 6" and are masked behind panels, which will extend out one foot. LPC will not approve at staff level because the louvers penetrate the facade the building.

The committee asked the applicant to paint the louvers the color of the building. Whereas, the applicant agrees to paint the louvers in a color to match the facade of the existing building, the committee approved. 3-0-0-0, Public: 1-0-0-0.

## 2. 6 West 87th Street,

To approve a "pop-up" roof addition. Not a penthouse addition but to add one bedroom each to two separate, top-floor apartments. Addition will be visible from 20' (or less) on 86th and 87<sup>th</sup> Streets. Current plans are for stucco but owner is willing to do brick and block to match the existing building, even though it is more expensive. Approved with the proviso that the owner use brick and block rather than stucco. 2-0-1-0.

# 3.301 West 108th Street, Kevin Bohn, Architect

Approval for a master plan for store fronts on Broadway. Based on the original continuous storefront, the new scheme features plate glass windows and a glass transom. Signage and metal work will be painted black in keeping with the rest of the building. Store signs will be uniform and lit from below, with fixtures can not be seen from the street. Letters for store signage will be mounted on a steel bar for easy changing. There will be no awnings. The committee approved provided the sign lighting is eliminated.
