September 2007 Minutes

Full Board Meeting Sheldon Fine, Chairman September 4, 2007 American Bible Society

Mr. Fine called the meeting to order at 7:10 PM Minutes from previous full board meeting were approved: 28:0:0.

Chairman's Report: Sheldon J. Fine

- Park West Village retaining wall collapse, Mr. Fine and Ms. Ryan met with the
 Department of Buildings the stop work order on the site as well as other
 surrounding sites. The borough president held a press conference at Park
 West Village. In August, the owners of Park West Village attended a Park
 West Village Coordinating Committee meeting and apologized.
- Jewish Home and Hospital gave an informational presentation of their development plans for West 106th Street the July 17 Land Use Committee meeting. Mr. Fine requested they host an open forum meeting and form a community advisory board. A letter expressing concerns about JHH's plans was sent to Council Members Tony Avella, Chairperson of the Zoning & Franchises Committee, and Melinda Katz, Chairperson of the Land Use Committee. Negotiations continue with JHH. The basis for the negotiation will be CB7's work re-zoning of West 97th-100th Streets and concerns of Manhattan Valley residents. Mr. Fine recognized people who have dedicated time to protect their neighborhood over the issue.
- Mr. Fine welcomed Rosa Gonzalez, the newest community board member, to the Board.

Helen Rosenthal:

• The community board reviews the city budget and submits CB7's priorities. Each year the Strategy & Budget Committee meets with the board committees to understand what their budget requests are. The Committee will present the proposed priorities to the full Board in November.

Nominations of Board Officers for 2007-2008, Dan Zweig, Chairman, Elections Committee

Barbara Adler, Elections Committee member, conducted the nominations. Each candidate must be nominated and seconded. Nominations will be closed at this meeting, unless there are not enough nominations for an office. Candidates are asked to write up to a 250-word statement that will be distributed to Board members. They will have an opportunity to speak for up to 3 minutes and respond to questions before the elections.

Board offices are: Chairperson, 3 vice-chairpersons, and 2 co-secretaries. For chairperson, the following were nominated and seconded, and they accepted: Helen Rosenthal, Jeff Siegel, and Sheldon Fine.

For vice-chairpersons, the following were nominated and seconded, and they accepted: Luis O. Reyes, Michelle Parker, Charles Simon, and Melanie Wymore.

For co-secretary, the following were nominated and declined: Miki Fiegel, Benjamin Howard-Cooper, Johnette Murray. The co-secretary nomination will be revisited next month during the elections.

Public Session

- 1. Phillip Kay, 160 West 106th Street Tenants' Association: Called the community board in June about the plans for the Jewish Home and Hospital, and is very concerned over the plans.
- 2. Manny Segarra, 147 West 105th Street: Lives right next door to the buildings slated for demolition for the JHH construction plan and is concerned over plans due to public safety, including driveways near school buildings.
- 3. Jean Jaworek, Duke Ellington Boulevard Neighborhood Association: Does not feel that JHH has been committed to the community and appreciates the work CB7 has put into the issue.
- 4. Carlos Solomanra, P.S. 145: Disagrees with the JHH trying to circumvent the new zoning rules.
- 5. Jose Lopez, 109 West 105th Street: Hopes JHH has to adhere to the zoning law; does not feel that they should be exempted.
- 6. David Fried: Outraged that JHH is trying to get there plans passed without community input; hopes that CB7 will take a hard line on this assault of the democratic process.
- 7. Glory Ann Kerstein, DEBNA: Does not disagree with JHH trying to do work on their building, but does not agree with their plan that will ruin the neighborhood.
- 8. Luis O. Reyes, CB7 Board Member: Spoke to the issue of JHH development in regards to PS. 145. 150 students at the school have asthma related problems, and the traffic caused by JHH will only be a further detriment.
- 9. Manuel Figarela, District Librarian for Manhattan North District: St. Agnes Branch will receive a full renovation, scheduled to begin September 24th; branch scheduled to reopen Spring of 2009.
- 10. Nevil W. Bird: Concerned about JHH's effect on air quality especially with such high asthma rates.
- 11. Blanca Vazquez, 145-147 West 105th Street: JHH included Ms. Vazquez's building in the plans without consulting residents. Wishes to preserve Manhattan Valley for its beauty however, believes JHH is taking that away.
- 12. Aaron Biller: Concerned about over saturation. The Upper West Side has the second highest concentration of supportive housing. A map was circulated showing that the Upper West Side holds 21% of supportive housing in Manhattan. Asked CB7 and elected officials to protect the Upper West Side from the high number of supportive housing units.
- 13. Marty Katz: Concerned about the increase crime rates when numbers of supportive housing units are raised.
- 14. Don Berger, Congressman Charles Rangel's Office: Next week there is a post office renaming for Tito Puente on 124th and Lexington. Many important votes coming up for in Congress.
- 15. Micha Lasher, Congressman Jerrold Nadler's office: Against the warrant-less wire tapping and is fighting for the reinforcement of civil liberties.
- 16. Matt Bitz, Council Member Dicken's office: Co-sponsoring legislation that will allow more council oversight in demolition to prevent issues like Park West Village. Allocated an \$5000 to the Broadway Community Food Pantry.
- 17. Michael Meade, State Senator Schneiderman's office: A DHCR day will be hosted on the Upper West Side.

- 18. Michael Kaplan, State Assembly Member Richard Gottfried's office: Meeting will be held to discuss environmental concerns. A panel on illegal hotels will be convened.
- 19. Kaytrne Ting, State Assembly Member Linda Rosenthal's office: Consumer labeling law, a protection law for domestic violence victims, an important clarification on health proxies in regards to end of life care were passed.
- 20. David Chang: Announced two financial aid forums high school and college students at PS. 199.

Manhattan Borough President's Report

Jessica Silver: The borough president has been very involved with CB7 and other elected officials representing the area in the aftermath of the retaining wall collapse at 808 Columbus Avenue, and sent a letter questioning the legality of certain construction plans on the site. As part of the Go Green East Harlem initiative the borough president has opened a farmers market on East 106th Street. DOT will be installing a left turn signal on West 79th Street and Amsterdam Avenue.

Legislators' Reports

Council Member Melissa Mark Viverito: Happy about the ongoing dialogue with JHH and the community and is optimistic about a balanced negotiation being reached.

Council Member Gale Brewer: Big issue on the Upper West Side is the loss of small business. In Ms. Brewer's district, there are 63 bank branches. The West Side Campaign against hunger is having a talk on September 6th from 9-2. On Friday September 7th, there will be a mobile dental van on 87th and Columbus Avenue. On September 24th at John Jay College from 6-9:30, a listening forum will be held about transportation and traffic on the west side. September 10th at 9:00 A.M., there will be a community advisory a meeting Harmony Atrium. Ms. Brewer supports the community board's position on St. Louis Hall and supportive housing for the working poor and mentally ill.

319 West 94th Street (West End Avenue-Riverside Drive.) The resolution to approve the application by the Lantern Group to the Board of Standards & Appeals for variance allowing addition of 2 ½ as-of-right floors without the rear-yard setback requirement to allow the conversion of the 149-unit commercial SRO into 140-units of permanent, affordable housing was returned to committee.

1. Christopher Santee, 319 West 94th Street Tenants' Association: Feels that the Lantern Group is incompetent and is upset by lack of action on the community

board and elected officials. Wants the Lantern Group removed from management of the building.

- 2. Jessica Katz, Department of Housing Preservation & Development: Wishes to show the community real supportive housing. HPD is confident in the Lantern Group's ability to manage a building due to prior experience. Ms. Katz believes that the 319 needs a complete renovation before the pest problem can be completely eradicated.
- 3. Paula Bassoff: Supports the concept of supportive housing, however does not believe it is being handled correctly; does not believe the Lantern Group's proposal to have staff from 9-5 is sufficient.
- 4. Bonnie Epstein: Has lived in the neighborhood for 29 years. Currently lives in the only building on the block without supportive housing. Concerned about reconstruction of 319 and the structural issues attached.
- 5. Aaron Biller: Concerned about reconstruction plans and the safety.
- 6. June Muller: Neighborhood has improved; supportive housing threatens to bring it back down. There have been fights in front of her home.
- 7. Cynthia Stuart: There are 22,000 supportive housing apartments in the 5 boroughs. They are permanent and rent stabilized. Does not believe supportive housing is a threat .
- **8.** James Tagger, Phoenix House: Supports of Lantern Group and supportive housing.
- 9. Yitzchach Epstein: On principal is in favor of the proposal, however practically is against it. Has concerns over safety and construction. The neighborhood has been gentrifying and is no longer the same diverse neighborhood it once was.
- 10. Mavis Bayrd: The Upper West Side is a liberal, tolerant, inclusive neighborhood. Community should have been more involved in the issue and should have been given notification of meetings.
- 11. Rolande Cutner, 319 West 94th Street: Against the Lantern Group; claims that they have treated her unfairly and plans on suing the Lantern Group.
- 12. Nicolas Learnard, 319 W. 94th Street: Upset that Lantern group has maintained the building in such a poor manner; claims they have been harassing tenants.
- 13. David Harrington: Supportive housing is important, but this project at 319 is to risky for the neighborhood.
- 14. Ken Doodack, President of Fountain House: Staffing at this building will be the same as many other buildings; there will be 24/7 coverage. 319 will be Fountain House's largest with 60 residents, their next largest is 25.
- 15. Rafael Markwat, Lantern Group: Aware of the bedbug problem and working to eradicate it. Extermination is done on the request of the tenant. Broken boiler is old boiler and needs to be fixed. The floor heights being change will only affect the new floors; new floors will be 8 feet instead of 10.

The meeting was called to order by Andrew Albert and Dan Zweig, Co-Chairs at 7:05pm.

1. Broadway, W.58th – 68th Sts., "Winter's Eve at Lincoln Square" – Monday, Nov. 26, 2007 – various street closures from 8am - Midnight - Richard Juliano from the Lincoln Square BID spoke. No changes from prior year operation. A resolution to approve this proposal was made and passed.

2. 2463 Broadway (W.100th St) – Renewal application #B01743 to NYC Taxi and Limousine Commission by Two-Way Black Cars and Radio Group Transportation, Inc for a For-Hire base station license. John Mazzia from Two-Way Black Cars spoke. With a fleet of 13 cars, there are no changes in operation. CB7 has not received any complaints regarding this group. Mr. Ramana from Mughlai indicated that there were no changes in the café as part of this renewal. A resolution to approve this proposal was made and passed.

6. 2161 Broadway (W.76th St) – Renewal application by Broadway 76 LTD dba Niko's Mediterranean Grill & Bistro for a two year consent to operate an enclosed sidewalk café with 15 tables and 30 seats. Sherrie from Niko's indicated that there were no changes in the café as part of this renewal. A resolution to approve this proposal was made and passed.

7. 2191 Broadway (W.108th St) – Renewal application by India Food International Inc dba Indian Cafe for a two year consent to operate an enclosed sidewalk café with 15 tables and 52 seats. Chander Malik from Indian Cafe indicated that there were no changes in the café as part of this renewal. A resolution to approve this proposal was made and passed.

Modified unenclosed café...

8. 2418 Broadway (W.89th St) – Petition to Modify Consent by Three Friends LLC dba Georgia's Bake Shop for a two year consent to operate an unenclosed sidewalk café with 11 tables and 26 seats – Georgia from the Bake Shop appeared explaining that having acquired the next door storefront, they were looking to expand the café to include the area in front of the new store – increasing the tables and seats from 5 tables and 14 seats. A tenant (JEM) in the building where Georgia's Bake shop is situated opposed the application on the grounds that the Bake Shop is not respectful of pedestrian's and neighbor's needs and comfort. Complaint included continued noise from the A/C system and customers' dogs tied to the café sides and meters blocking the remaining right of way for pedestrians. There was also a question whether sufficient notice of this hearing had been posted by the restaurant for

affected neighbors. After considerable discussion a motion to table this issue was made and passed by the committee. Hoping for an opportunity for clear notice to be posted and for some attempted discussion and resolution on the part of the Bake Shop and the complaining tenants, this item will be heard at the October Transportation meeting.

New Unenclosed cafes...

9. 2186 Broadway (W.77th-78th St) – New application by Cosi, Inc daba Cosi for a two year consent to operate an unenclosed sidewalk café with 4 tables and 10 seats – the applicant was not present to answer questions about the café. A resolution to **disapprove** this proposal was made and passed.

10. 427 Amsterdam Ave (W.80th-81th St) – New application by J of K Corp for a two year consent to operate an unenclosed sidewalk café with 9 tables and 17 seats – the applicant was not present to answer questions about the café. A resolution to **disapprove** this proposal was made and passed.

New business...

John Paluso appeared mentioning that he had previously sent a letter to the Transportation Committee and had two items of concern.

- a. Atria on W. 86th St a space 46 to 48 feet long had been reserved for their dropoff and pickup these are much too long for what is needed and these spaces are almost always empty. The committee agreed that this length of parking appeared to be greater than what had been approved. There have been other complaints regarding this issue and the whole issue would need to be heard at a subsequent meeting.
- b. On Riverside Dr. where the cross streets intersect there are a number of areas where parking is not permitted where it would do no harm to allow it. Josh from DOT will review sign orders in this area to determine the reasoning behind the parking prohibitions in question.

Josh Orzeck from DOT provided information on a number of items

- a. List of approved bike rack locations
- b. Milling for West End Ave 66th to 75th St will take place the week of Oct 1-5 night time.
- c. Muni meter installations reaching completion we requested a map of muni and meter installations for the district
- d. Left turn signal for East bound traffic on 79th St turning on to Amsterdam Ave will be installed.
- e. Pooling water problem on Broadway between 82nd -83rd St will be corrected when street is milled soon.
- f. No idling signs on W.72nd St between Central Park West and Columbus Avenue.

Peter Jenkins insisted that DOT should be able to provide better notice regarding advanced notice for milling streets to the community. Josh mentioned that the list of streets to be done is provided in spring and fall to CB7. Actual dates are only known about 1 week ahead. The committee will ask the board office to see if the dates can be posted on the CB7 website promptly when known.

Dan Zweig brought two issues to the committee -

- a. At W.105th St and West End Ave there are complaints of late night traffic by large trucks traveling on West End Ave where commercial traffic is prohibited. It was said that complaints should be called directly into the Police Precinct. There was also mention of an Office of Freight Mobility with DOT. It was asked at the meeting if a specialized red light camera couldn't be used to photograph and ticket commercial vehicle violators on West End Avenue.
- b. Zipcar.com is a rental provider of car sharing vehicles. The question of the safety of Zipcar vehicles was raised due to the reliance on self reporting for problems and recent experience with the vendor. Other consumer reservation and pricing issues were also raised. It was thought that despite the transportation elements of vehicle safety, this item should be heard to the Consumer Affairs Committee of the Board.

Old business – Josh Orzeck for DOT said stop signs on Freedom Place will be installed.

REVIEW OF APPPLICATIONS TO THE NYS LIQUOR AUTHORITY:

- 1. 1. Further clarification by the Lantern Group on operation and future plans for St. Louis Hall, located at 319 West 94th Street.

The meeting was called to order by the committee chairs. Eric Galloway, Rafal Markwat and Harriet Cohen from The Lantern Group and Kenneth Dudek,, President of Fountain House, were present to address the questions from the many neighbors and concerned community members about the proposed plans for St. Louis Hall. New concerns about the current operation of St. Louis Hall and its future plans to renovate and operate St. Louis Hall as an SRO with supportive services for 141 tenants had been voiced at the full board meeting of CB7 on Sept. 4, 2007 and the Board determined that further committee meetings, of both Health and Human Services and Land Use committees, should be held to address these concerns prior to a Board vote on the project. A site-visit by the two committees took place prior to the committee meetings. Written questions were submitted to the Lantern Group by the Health and Human Services committee in preparation for the committee meeting. The questions and Lantern Group's responses are attached to these minutes as part of the record of the meeting. The 15 attachments to Lantern's responses are available for review at the Board office.

Mr. Galloway briefly described the Lantern Group's six other facilities in the Bronx, Brooklyn and East Harlem, including the number of residents housed in each. He also updated the community on the two other Lantern Group facilities on the UWS, the Bilander at 260 West 98th St. and Hunter Moon Hall at Broadway and 99th St.

Kenneth Dudek responded to questions from the committee members and community members about the criteria for admission to St. Louis Hall and the services to be provided to tenants, both on-site and at Fountain House. The criteria for admission are listed in Lantern's responses to the committee's questions. The screening process for new tenants begins with DHS referrals followed by interviews with each prospective tenant. The process will be conducted by the St. Louis Hall Housing Placement Team, under the joint supervision of Fountain House and Lantern Group mental health and social work professionals. DHS will refer three prospective tenants for placement, with the understanding that one of the three will be accepted if they meet the criteria. Psycho-social testing is part of the pre-screening process. No violent offenders or sex offenders or people with acute health needs will be Mr. Dudek emphasized that St. Louis Hall was not a "half-way house" but a permanent residence for those who are capable of living with an adequate degree of independence. Emergency crisis intervention will be assured, but the program is designed to avoid the need for emergency crisis intervention by providing adequate staffing by professional mental health workers to ensure early intervention. A detailed staffing schedule was discussed (Attachment No. 2). Tenants will be evicted for abusive/violent behavior, illegal activities and chronic non-payment of rent. The eviction policy was attached as Exhibit 12. Tenant conflicts will be handled by appropriate building staff, pursuant to the Tenant Conflict Policy There is already a system in place for handling tenants' (Attachment No. 4). building service complaints (Attachment No. 5). Tenants are asked to fill out a Work Order Form and the necessary work is supposed to be completed within 10 days. Emergency complaints are to be completed as soon as possible. A maintenance and repair log is kept at the building.

The proposed reconstruction of the building is expected to take 24 mos. to complete, with the existing tenants to be relocated within the building. A small number may be able to relocate to Hunter's Moon. Reconstruction will be complete before new tenants move into the building.

There have been complaints from current tenants about lack of responsiveness on the part of Lantern Group to their needs. The building was previously operated as an illegal hotel and tenants enjoyed hotel-related services, such as package handling, until Lantern Group took over the operation of the building. Lantern Group is in the process of setting up a policy which will permit management to accept and hold for a limited time deliveries for the tenants. At the suggestion of the Health and Human Services Committee, Lantern Group organized a Community Advisory Board. However, only one meeting of the CAB was held. Instead, Lantern Group met with the buildings tenants, only. Lantern Group will resume meetings of the CAB in November, 2007.

Complaints from community members included inadequate staffing for nights and week-ends, lack of police protection, concentration of special needs population on UWS, emergency placing of homeless in the community with no notice and no services. Other community members expressed support for the project which promised to provide adequate support services to a needy population.

After discussion, the committee voted to approve the programmatic aspects of the Lantern Groups' proposal to renovate St. Louis Hall in order to provide permanent affordable housing with on-site supportive services in partnership with Fountain House.

CB7 Report on Municipal Services Penny Ryan, District Manager September 27, 2007

Updates

Goddard-Riverside's Outreach Program – Agency's goal is to achieve a 2/3 reduction in homelessness by 2009 in Manhattan.

- The Goddard registered 1,800 homeless individuals in August; 1000 of which were determined to be chronic.
- The program officially started 9/1/2007 and as of today, 60 individuals are in the process of getting permanent housing; 37 are off the streets.
- Goddard is providing 24/7 coverage for the homeless.
- · Call 311 to report homeless.
- Another agency, BRC, covers the homeless in subways.

Homeless issue:

PSA 6 – There is a persistent homeless problem inside NYCHA buildings and roofs. PD is requesting assistance to bring social services to them. (Goddard does not handle this type of situation.)

Outcome: CB7 will set up a meeting with Goddard and the City agencies involved with homeless issues.

DEP Status of Implementation of New Noise Code Rules

- Construction: Doing outreach to construction industry to teach mitigation plans. Enforcement has begun. The Community Board would like to have information on what DEP advises the construction industry on noise mitigation, i.e. for jack-hammering and temporary muffling.
- 311 calls Responding to noise complaints within five days to make an appointment.
- Complaints about music from bars and restaurants go to PD first. Will conduct joint inspections with PD.
- · CB7 would like PD bar noise results for next meeting.

Conversion of SROs and Residential Apartments to Illegal Hotels

- The Mayor's Special Enforcement Office issued a temporary injunction, as of 9/20/07, against transient housing for three SRO buildings on 94th & 95th Streets. The injunction does not affect the permanent residents. More recently, the judge in the case dropped the injunction the court found that renting rooms to tourists does not constitute a community nuisance.
- FDNY: Illegal SRO hotels on 94th and 95th Street continue to have a 24 hour Firewatch status (must have four full time workers on shifts 24 hours, 7 days a week).
- Owners who are illegally using buildings as hotels must change method of operation to conform to NYC hotel fire codes.
- CAU will get official status of illegal hotels on 94th & 95th Streets.

Agency Updates

NYPD PSA 6 – Crime is down 76% in District 7. At 33 West 90th Street, man was shot in leg, made one arrest, shooter still at large. Recovered 5 firearms in 24th Pct Housing.

DOHMH

- Calls to 311 for pest control are getting a two to three week response time.
- Flu campaign starting in October Call 311 for information on locations.
- CB7 requested that DOHMH contact the DOE agency representative who heads the pest control program and garbage maintenance in order to set up a meeting with CB7. There are serious pest control problems on blocks that have schools.

Dept. of Parks and Recreation

- The sidewalk project is finished in and around Theodore Roosevelt Park.
- · Sal Trento is the new District 7 Parks manager.

Riverside Park: Two projects in Riverside Park will commence on October 15:

- Riverwalk, a 14' wide path that will extend into the river from 83rd to 91st Street, will take 18 months to construct. One of the parking lots at the tennis courts at 96th Street will be used as a staging ground, the other one is already closed to the public.
- Soldiers' and Sailors' Monument the asphalt area to the south of the monument, not the marble plaza, will be reconstructed with a new design and more green space.

DCA

DOB and FDNY officials have established the new outdoor café heater regulations. DCA will forward a copy of the regulations to CB7 as they become available.

DOB

- The collapse of the retaining wall at the 808 Columbus construction site is still under investigation. A copy of the findings will be sent to CB7 upon its completion.
- Community Boards will be given less after work / weekend variances. Issued variances will be emailed Fridays $4-5~\rm p.m.$
- \cdot Every construction site on the UWS is being inspected to ensure construction falls within new zoning laws between 97th and 110th Street.

NYPD 20th Precinct – crime is down 4%, arrest activity is up. Spiking is grand larceny, unattended property.

DOT

- DOT conducted a very successful Westside (57 86th Street) traffic study forum, where the public participated in group sessions to discuss major traffic concerns.
- Gave CB7 lists of approved bike rack locations and the bus shelter install schedule.
- There will be milling on West End Avenue from 66th to 76th Street starting Thursday night/Friday morning, 10/04/2007, probably continuing to Sunday night/Monday morning..

DSNY – Garbage haul tonnage remained constant over last month...

NYPL – Library staff requested police officers visit the library on 100th Street after school. 24th Precinct Community Affairs to meet with library staff to determine needs.
