Richard Asche and Page Cowley, Co-Chairpersons

1. Letter to the Board of Standards and Appeals regarding 200 Amsterdam Avenue.

Presentation by Richard Asche & Page:

- Great presentation at committee meeting about super talls
- As a result of that meeting, we decided to write a letter to BoS about our opinion about Supertalls in our neighborhood.
- Resolution address affordability
- High ceiling heights does not increase living space in NYC
- Get attention of City Planning to look at areas where there is height and no destiny

H.Yaruss: How do you define supertall? Ans: express coined that reflects the current technology that allows for increase in height. Fast track construction as concrete is piped to high levels.

- E. Sheffer: Term Super Tall is a descriptive political word that has been given to describe a handful of buildings built on 57th Street. Three reasons for this: Style of building and technology, voids in the buildings that are not livable space, and no regulation of max for floor to floor heights. There is no street scape because of the high setting of livable space.
- P. Samton: High time that City Planning deal with bulk of these buildings. It is outlandish and there has to be a beginning of some regulation
- I. Mitchneck: There are devices that are used to limit height. Many areas within the community where there are height factor districts. Second Resolution: last bullet- build a bigger building where they can. Find a better way to phrase this or understand it will not work the way we want it.
- M. Diller: Support the letter. Technical: we defer to the parties on this decision
- S. Fine: Take it further bring it to Borough Boards so it become a city issue: An. Part of the plan.
- L. Craddock: Real problems that happen- as of right they don't come before us. Technically it is difficult for us to address them. Above a certain height you would need a special permit that would involve CB, Borough President, and others.

- R. Reich: We need public hearings to discuss this. Massive money that could be used for structural repairs. There is no plan for more buses. We need to back Rosenthal and we should support them.
- K. Coughlin: Adding benches and they are leaning. Spending all this money on cosmetics when we cannot get trains to run on time.
- H. Yaruss: Inconvenience for the community. The service will be just as bad even though it will look better.
- E. Caputo: We need to be realistic about MTA. We are doing a Town Hall Meeting next week. Inform the public of the repairs.

Community Board 7/ Manhattan

- A. Albert: Different funding than service funds. Enhanced Station Initiative is where this money is coming from. Subway Action Plan (service) has been funded by the State and not the City- slowed down unless the City comes up with their half.
- I. Booker: There will be upgraded and down in 6 months. It was presented in the newspaper a few weeks ago. Lighting will help improve the stations and a good investment.
- R. Asche: Community Board seeing an issue and calling it to the City's attention. Notices will be posted in the stations.
- E. Sheffer: Do agree that this can be a good thing. Enhanced stations for safety. People further north suffer every weekend with the changes. Set agenda for the meeting and have MTA tell us what is happening and discuss how money is spent.
- R. Robbins: Resolution Suggestion: EMAIL
- M. Diller: Good to call on the MTA to rethink some of this. Funding between Governor and Mayor- about funding- maybe it time for this board to consider budget priority that calls on the Mayor and City to do its share of additional capital funding to create better service.
- A. Rigie: 100 million station upgrades are important- CB resolution should not change the way funding is allocated. We need to get out there to inform the public.
- S. Reddy: if we pass this resolution do we lose funding. Ans: no but we could lose the meeting
- S. Schwartz: M66/72 reduced bus service- loop it in.
- S. Robotti: Stations are scary and dark. Avoid stations due to what it current looks like. If not here, then somewhere else.
- J. Rausch: Is there phase two of this? Resolution should focus on public outreach.

Public Speaker:

Dan Cohen: Head of Valley Restoration, 1/2/3 is fully ADA accessible. There is no elevator on B/C between 59th to 125th Street. We need one of these stations to be ADA accessible. 110th Street could be a place for an elevator.

- K. Neuwelt: No master plan, what has LPC been doing on this? Ans: we have nothing. They came to us for guidance. Setting a president in the building longer than me. All the windows were changed the year before it was landmarked. (20 years) Believe it is a value to the building to have the casements.
- Micky: Slippery Slope- real obligation to have windows look today and in the future- historic façade needs to stay the same.
- Paul: old replacement windows be repaired. Can be restored and not energy consist.
- H. Yaruss: will you replace or leave as? Ans: we would have to decide.

Michael (applicant): Been very aware of the windows and have been careful to find windows that are closest to the original windows. The building has many windows that are different. Encasements cost \$11,000 more than the windows that were selected. Match the number of the windows that have been replaced. Looking to enhance the windows to give a better visual.

PARKS & ENVIRONMENT COMMITTEE

Klari Neuwelt and Ken Coughlin, Co-Chairs Committee Members Present: Steven Brown, Ken Coughlin, Klari Neuwelt, and Susan Schwartz. Absent: Natasha Kazmi.

Meeting was called to order at 7 p.m.

Prior to the hearing of the first agenda item, co-chair Klari Neuwelt welcomed Dorothy Rowan, who has replaced Ben Kramer as Riverside Park Manager (Kramer has been promoted to Deputy Administrator for Riverside Park), and Matt Genrich, who is now the DPR Manager for Districts 7 and 9, to the meeting. Neuwelt then asked Rowan about the fencing off of a portion of the plaza surrounding Soldiers' and Sailors' Memorial Monument. At the committee's February 2017 meeting, representatives of the Department of Parks and Recreation (DPR) presented to the committee the results of a conditions survey and restoration treatment study of the Monument area. The investigation found that the overall condition of the monument and plazas ranges from "fair" to "poor," with poor meaning a one-year life expectancy and fair meaning five years. The study's recommendation is for a comprehensive rehabilitation of the Monument and surrounding plazas at an estimated cost of \$30 million, the funds for which are not currently available.

Rowan said that the upper portion of the plaza and the two upper staircases have been closed off for an "indefinite" period of time due to concerns about potential injuries from stones falling from the Monument. However, theatrical performances near the Monument should not be affected, nor will the Memorial Day and Veterans Day observances. [Note: Margaret Bracken, Riverside Park Landscape Architect, advised after the meeting that the observances would have to be modified somewhat.]

Neuwelt also noted with approval the beginning of construction by DOT to install lighting on the Cherry Walk section of the Hudson River Greenway, which was the committee's top capital budget priority last year. Rowan

informed the committee that a total of 87 lights will be installed. Neuwelt questioned where lights would be installed on the northern-most section of the Cherry Walk, where it is enclosed by a concrete barrier wall. Rowan did not know how that section will be lit.

1.. Presentation by The Broadway Mall Association on an upcoming public art exhibition scheduled for installation mid-April.

Deborah Foord, a board member of the Broadway Mall Association, presented plans for the installation next month of six figurative sculptures by artist Kathy Ruttenberg, four of which will be located in CB7 – in Dante Park at 64th Street and on the Broadway Malls at 72nd Street, 79th Street, and 96th Street. The sculptures, made of cast silicon and bronze, will be exhibited through February 2019. Installation begins April 15 starting at 72nd Street, with the ribbon cutting for the entire exhibition on April 27 at 11 am at the south entrance of the 72nd Street IRT station.

The artist describes her art as a combination of "human, animal, and plant forms," although the sculptures in the exhibition are something of a departure for Ruttenberg, who typically creates pieces for indoor exhibition. Some of the sculptures will incorporate LED lights, a first for a Broadway Malls art installation.

These are the Ruttenberg sculptures in CB7:

- 64th Street "All the World's a Stage," 189.5" high x 52" diameter
- 72nd Street "In Sync," 96" high x 52" diameter
- 79th Street "Ms. Mighty Mouse," 120" high x 48" wide x 32" diameter
- 96th Street "Snail's Pace," 74" high x 114" long x 48" wide

Questions:

Susan Schwartz: What is the weight of the sculptures?

Foord: Doesn't know, but they will be on bases and will not be so heavy that they cannot be well supported. Schwartz: Notes unrelated Department of Design and Construction street work beginning soon at 71st Street bowtie and asks whether this will pose a conflict with the installation at 72nd Street.

Foord: Even if the work goes on simultaneously, vehicular access to area should not be compromised.

Neuwelt: In past years the sculpture exhibitions have typically been paid for by the artist's gallery. Is this the case this year?

Foord: No, the artist arranged her own financing.

Ken Coughlin: The limbs of the figure at 72nd Street are low enough for someone to swing on. Can they withstand the weight?

Foord: In past years some sculptures have looked like inviting jungle gyms (cites the exhibition of artist Don Gummer's work in 2015-2016 in particular) but there have been no reports of people using them to climb on. This is not a concern.

Resolution to approve the Broadway Mall Association's exhibition of the Kathy Ruttenberg sculptures in CB7: Committee: 4-0-0-0.

2. Discussion with the NYC Department of Environmental Protection (DEP) on the upgrades to facilities at the Central Park Reservoir.

Humberto Galarza of the DEP's public relations department, assisted by DEP staff members David Yung and Shibly Shadeque, described the work involved in upgrades to Gate House No. 1 on the north side of the Jacqueline Kennedy Onassis Reservoir. The Gate House was built in 1864, and the reservoir provided drinking water to the city until it was decommissioned in the early 1940s. The Gate House controlled the inflow of water to the reservoir from the Croton Aqueduct.

The water control valves beneath the Gate House now require rehabilitation to prevent cross-contamination of the current city water supply. In addition, a reinforced concrete bulkhead will be installed and the Gate House's roof replaced.

Accomplishing this work will require temporarily lowering the reservoir's water level by approximately 8 feet (the water level has already been lowered to about 7 feet). (When filled, the Reservoir is about 30 feet deep.) The construction work will also necessitate temporarily closing the section in front of the Gate House of the running track that circles the reservoir. Instead, the path will detour around the Gate House to the north, joining the bridle path for a short distance before rejoining the existing path. All of the work and the temporary closure of the running path, including signs directing pedestrians to a detour along the bridle path, will be coordinated with the Central Park Conservancy.

Work on the gatehouse will begin April 1, 2018, and be completed by July 15, 2018, after which the reservoir will be refilled to its customary level, a process that takes about 50 days. The project's total cost will be \$326,000. Procon is the contractor for the work.

Questions:

Neuwelt: Where does the water go and from where is it refilled when it is partially drained, as in this project? Answer: The water goes to the sewers and will be refilled from the NYC drinking water supply.

Neuwelt: Is the reservoir a static body of water, no inflow or outflow? Answer: Basically, yes, except for inflow of rainwater, and the fountain in the center of the reservoir aerates the water.

Neuwelt asked about the possibility of swimming ever being allowed in the reservoir. Answer: That's a question for DPR and/or the Conservancy. There are safety issues.

Neuwelt: Have you found anything of interest as the water level has been lowered? Answer: Dead raccoons. Schwartz: Do you plan to similarly renovate the south Gate House? Answer: Probably, but we are focusing on No. 1 now.

Coughlin: Concerned that the running track detour will be an adequate running surface that will not pose hazards to runners. Answer: The Conservancy will be doing the work and following their standards. Community member Ira Gershenhorn: Why rehabilitate the valves in light of the fact that they are no longer used? Why not just block them off? Answer: The valves are still used to refill the reservoir. We still need access to them.

Gershenhorn: Does lowering the water level place an extra burden on the city's often overburdened waste treatment system? Answer: No, because the water is removed so gradually.

New Business:

Neuwelt: She will forward to committee members a recent email from Kaitlin Peterson of Manhattan Community Boathouse regarding an upcoming kayaking event. Matt Genrich of DPR: Tecumseh Playground is temporarily closed due to electrical work.

The meeting was adjourned at 8:25 p.m.

PRESERVATION COMMITTEE

Jay Adolph and Gabrielle Palitz, Co-Chairpersons March 8, 2018

Present: Gabrielle Palitz, Mark Diller, Miki Fiegel and Peter Samton. **Absent:** Jay Adolf and Susan Schwartz.

1. **250 West 71**st **Street,** located between West End Ave. and Broadway. Application to LPC for a rooftop addition replacement windows throughout and front façade restoration work, for this 4 story townhouse.

Presented by Juan Carlos Matiz, Architecture and Design

Proposal is to extend rooftop with extra story penthouse, and rooftop mechanical. New chimney, new elevator and bulkhead, new wood windows throughout, adjust location of entrance door, and larger windows proposed at ground floor. Otherwise façade in generally good shape. New decorative railings to replace existing railings. West elevation has new windows, and there are new windows proposed on rear façade.

Questions:

A neighbor is concerned about cellar work and new elevator pit. While the new elevator doesn't go to the cellar, it goes up to roof creating a new large bulkhead. Further questions ensued relating to proposed rooftop construction.

Discussion:

Mr. Samton questioned the need for a full 20' additional height for the penthouse. (Equivalent of 2 new floors as well as 2 new flues) Applicant responded that one was for the neighbor. Mark Diller asked about lack of window details. Architect responded that the details were there, but didn't show well. Miki Fiegel also thought there was too much roof top construction, but didn't think it was a 'deal-breaker'. Gabby Palitz questioned lack of coping detail at the proposed penthouse.

Resolution to Approve passed: 3-1-0-0.

2. 110-118 Riverside Drive Application for Window Replacement

Presented for Walter B. Melvin, Architects, LLC by Kevin R. Daly

This is a large, 1929 apartment building running from West 83rd Street to West 84th Street along Riverside Drive. The larger leg of this big apartment building fronts on West 83rd Street. Over the years a large percentage of the original windows have been replaced in an ad hoc way throughout the building.

The proposal is for ultimately replacing all the windows with similar double hung windows as part of a replacement Master Plan. There are 2 manufacturers being considered, Marvin and Skyline Windows.

The proposal is for nearly all windows facing Riverside Avenue and 83rd and 84th Street to be 6 over 1 double hung, (with some 4 over 1 and a few 2 over 1 for the smaller windows. On the rear façade, 1 over 1 double hung are being proposed. There are a few large glass window that had replaced the 3 windows, that will be returned to 3 units in the Master Plan. Only the very small bathroom windows will have single or double panes.

After brief discussion and comment the Committee voted.

Resolution: To approve the proposal passed 4-0-0-0.

3. 210 Columbus Avenue, between West 69th Street and West 70th Street. Application to install a new ADA ramp for access to a wide storefront.

Presented by Chipman Design Architecture.

Proposal is for a new ADA ramp to deal with an existing step into the store from the sidewalk. The proposed ramp has a railing and risise from the sidewalk to the store level. The ramp is approximately 5 ft long with 9 ft landing to facilitate access to the storefront.

No major comments ensued.

Resolution: To approve the proposal passed 4-0-0-0.

Shelly welcomed the panelists, the HHS committee members, Board Members and the community members who came to the meeting

He explained the background to how the topic of **Mental Health issues in our Community by Agencies and Programs that Provide Support and Services** was developed from a discussion at our January Health and Human Services Committee.

Audrey and Shelly alternated asking questions appropriate to each of the the panelists

- · Which populations does your agency serve regarding mental health issues?
- Which services does your agency provide to support those populations?
- · How do members of the community access the services provided by your agency?
- From your experience, what are the most serious mental health issues the Community District 7 community is experiencing?
- How effective have the services you provide been? How do you measure that effectiveness?
- How can CB7's Health & Human Services Committee's advocacy assist your agency's ability to provide mental health services to the Community District 7 community.

Gibaldi, Outreach Coordinator, Thrive NYC, Office of the Mayor of the City of NY Amy Hyman, Director of the Frederick Douglass Community Center at Children's Aid Henry Lopez, Neighborhood Coordination Officer, Manhattan's 24th Precinct

SHERRI BRENNER - GODDARD RIVERSIDE MENTAL HEALTH PROGRAM

- GODDARD helps families remain stable by connecting them to community.
- The Top Club House builds relationships and job opportunities, helps with obstacles to employment, offers job coaching and such supports as job retention training.
- Club House has relationships with local employers such as Zaros Bakery and the Lincoln Square BID.

- Mental health diagnosis are offered for clients in need.
- Mental health and jobs programs are funded by the city and state and are audited twice a year. Goddard captures data measured by ACT team.
- They have shown fewer hospitalizations. Green Keepers participants working outdoors show improved health. These are measures of Top Club House success.
- LACK OF HOUSING AND OPIODS ARE THE MOST SERIOUS PROBLEMS IN THE NEIGHBORHOOD.

JAMES GARIBALDI - THRIVE NYC

- THRIVE is part of the Mayor's Office with 54 mental health initiatives that let us help each other.
- They are trying to reach everyone where they are, such as social workers in community centers.
- THRIVE trains New Yorkers in Mental Health First Aid.
- · Programs are offered around the city free of charge
- They participate in Naloxon training with DHS to reverse overdoses.

SHELLY CRANMER WSFFSSH

- West Side Federation for Senior and Supportive Housing provides housing and deals holistically with issues related to trauma and mental health.
- All employees have a mission to contribute to a sense of well being and hope.
- All interactions are potential mental health interactions. There is no limit on the time to work together; sometimes dealing with challenges goes on forever. We work to make clients make friends and be part of the community. We try to offer hope and a path toward stability.
- We have psychiatric services for more serious problems. Care is completely coordinated.
- We are saving and building 200 units of affordable housing.
- STIGMA AND FEAR ARE THE BIGGEST PROBLEMS. We need to listen to anxiety over immigration.

MANUEL CASANOVA CEC3 MANHATTAN

- As housing goes, so goes stability. Homelessness sends kids to different schools, but schools try to help kids in shelters, help with laundry needs and social service support.
- When schools near shelters are closed, possibly Wadleigh or P.S. 49, children lose sense of security. School is most stable time of day with lunch and security guards. A special team is needed to go in for extra support when a school closes. Students from shelter population need extra mental health support.
- Schools with low income and minority populations do not have strong PTA's and money for after school programs.
- According to Shelly Fine an effective caseload is 25 students to one social worker.
 Now schools have 250 students to each social worker.

HAROLD MAURAN and HENRY LOPEZ - 24TH PRECINCT NEIGHBORHOOD COORDINATION OFFICERS

- Neighborhood Coordination Officers know people having problems. We serve anyone
 in the precinct if they are hurting themselves, regardless of immigration status, gender
 orientation. Each case is different.
- Neighborhood Coordination program is a bridge to the right city agency. We are here to help families help themselves.
- In some cases of teens shoplifting, etc, we find out the kids problems, talk to youth intervention officers that know the kids problems in school.
- We try to get teenagers to join Police Explorers' Program that helps police help community.

AMY HYMAN - CHILDREN'S AID SOCIETY

- Community Center has a 1 to 10 ratio for therapy.
- We advocate for parents when schools do not understand parental or environmental problems.
- The National Standardize Test to check socio-emotional development: can a person plan and follow a plan, or is one day sunshine and the next day rain.
- Reading benchmark to assess kid predicts that the 85% reading below grade level in early grades have much greater chance of dropping out of high school. Many families do not want to know about problems.
- STIGMA IS MOST IMPORTANT ISSUE mental health needs to become comfortable to allay fear of diagnosis.

FERN FLECKMAN - RYAN CENTER

- Mental health sufferers die 25 years younger and have more diabities & hypertension
- Nurse care managers help deal with problems of substance abuse and mental before patients go to the emergency room.
- We screen people dealing with depression who don't take good care of themselve. Identify depression and anxiety early by asking, "Have you been feeling down, depressed or lonely in last two weeks? "Have you had happiness in the last few weeks. Not everyone with a symptom has a disorder. It matters how it effects their day to day activities? How do you deal with problems? We want to help people function, to help parents with their children?
- We set goals and look at the objectives every 3 months. Are we stuck? Is this the rights program, setting, therapist? Are support services needed?
- Social Determinants of Health: money, housing, relationships, getting to services.
- 212 769-7200 is the direct to mental health services
- From schools children come through doctors, counselors
- Don't over promise & under-deliver.

LARRY BRYANT - NATIONAL ALLIANCE ON MENTAL ILLNESS

Interim Voice program - takes mental illness as a scary concept and makes it human.
 We talk to the communit about mental illness and its stigma in public. We put information in people's hands.

- We measure the number of people in peer to peer classes & count how many graduate.
- We teach how to ask for help and how to provide help.
- With educators we advocate for funding programs.
- NAMI connects with housing agencies, legal advocates, community partnerships to add strands to their safety net and works to change policies.
- Having housing applications on hold elevates the sense of anxiety in the community, threatens stability.
- VERY IMPORTANT IS ACCESS TO SERVICES AND ENDING STIGMA.
