The following facts and concerns were taken into account in arriving at our conclusions:

Community Board 7/Manhattan has reviewed the resolutions of Manhattan Community Boards 11 and 8 which recommend disapproval of variances requested by Mt. Sinai Hospital in connection with the proposed construction of a research facility and attached residential tower between 101st and 102nd Streets on Madison Avenue and in the midblock between 5th Avenue and Madison Avenue on 102nd Street.

Community Board 7/Manhattan is in agreement with the conclusions reached by the other community boards that Mt. Sinai has not provided sufficient evidence to satisfy the findings required by the Zoning Resolution. While we are sympathetic with the need of Mt. Sinai to finance construction of its laboratory building by maximizing the value of development rights transferred to a developer of the residential tower, we do not believe that it is an appropriate use of the variance provisions of the Zoning Resolution for a not-for-profit owner to seek to exceed as of right limits for the sole purpose of funding its non-profit activity, particularly where the proposed variance would result of the construction of an intrusive structure out of all proportion to the buildings in the surrounding neighborhood.

Community Board 7/Manhattan has been presented with several similar variance requests over the years, and expects to review others in the future. We would not wish to encourage future applicants to solve their own financial needs by proposing structures which are oversized or otherwise objectionable where they are unable to satisfy the findings required by the Zoning Resolution.

Community Board 7/Manhattan also objects to the proposed variance insofar as it will lead to a building visible not only in the community board in which it is located, but from a significant portion of our Board area. The presence of the proposed structure on the skyline will be visually jarring and will cast shadows on Central Park as far West as the West Drive.

THEREFORE, BE IT RESOLVED THAT Community Board 7/ Manhattan **disapproves** the request for variances by the Mt. Sinai Hospital for the reasons set forth in the resolutions of Community Boards 11 and 8, and for the further reason that the proposed residential tower would have a negative visual impact on the skyline visible from the upper west side, and will cast unwanted shadows more than halfway across Central Park.

This design also includes the placement of bicycle racks on the Broadway Malls over the existing gratings, and includes the placement of curved benches to accommodate wheelchair users.

The Broadway Mall Association has and continues to be opposed to the placement of bike racks and the curved benches, believing that the design does not complement the Malls, but rather, stands out as not in keeping with the traditional design.

Many community residents have expressed similar opinions.

The enlarged grate areas will result in less room at the intersections for the traditional benches.

The MTA is mandated to make ADA accessible any improvements or changes it makes to existing facilities.

THEREFORE, BE IT RESOLVED THAT Community Board 7/Manhattan has no opposition to the raising of the grates at West 79th Street, West 86th Street, and West 91st Street in the Broadway Malls; and

BE IT FURTHER RESOLVED THAT Community Board 7 **disapproves** the design and placement of the bicycle racks and the curved benches for these locations; and

BE IT FURTHER RESOLVED THAT Community Board 7/ Manhattan urges the MTA & the Department of Parks to work out a formula for straight benches at these three locations, incorporating the area encroached upon by the enlarged grates and curved benches into a formula whereby this area's square footage can be re-distributed at the end of the malls to allow for straight benches, allowing room for a wheelchair, if necessary.

The proposed changes to the front façade of the building were too vaguely described, and too preliminary, and the drawings presented contained too many errors, for the Committee to reach a conclusion as to the appropriateness of the proposed façade changes.

The Committee believes that the proposed fenestration on the new rear extension, consisting largely of double and triple casement windows with transom-type glass panels above, all in wood frames, bears no relationship to the historic character of the building or of the Historic District, and consists of undistinguished architecture at best, but can be considered minimally appropriate solely because the rear façade is not visible from any public way.

BE IT FURTHER RESOLVED THAT Community Board 7/ Manhattan **disapproves** the proposed renovation of the front façade of 116 West 71st Street, but **approves** the proposed rearvard extension.

Several neighbors who attended the July, 2008 meeting of the Parks & Preservation Committee of Community Board 7/Manhattan at which the applicant presented its plans advised the Committee that 163 West 78th Street is one of eight townhouses that were originally built as a harmonious group, and that the front doors of four of those houses are intact, and the same as the pair of front doors currently in place at 163 West 78th Street.

The applicant represented to the Committee that if it could reasonably confirm that its current front doors match those used in the original design of the four neighboring houses, it would change the proposal for its front doors as presented to the Committee to provide that the front doors would be restored rather than replaced.

The Committee also requested that in such circumstances the applicant also replace the recently-installed front doors at its two contiguous buildings at 165 and 167 West 78th Street with matching historically accurate doors.

The Committee believes that the other proposed changes to the front façade, which are restorative, are appropriate to the historic character of the building and of the Historic District.

The Committee believes that the proposed rear-yard extension, which is not visible from any public way, including its fenestration and its "green wall", while different from the historical rear-yard architecture of the building and of the Historic District, is well-designed and under the circumstances is reasonably appropriate to the building and to the Historic District.

BE IT FURTHER RESOLVED THAT Community Board 7/ Manhattan **approves** (except, consistent with the above, it approves restoration rather than replacement of the front door) the restoration of the front façade, replacement of front door, enlargement of existing penthouse addition to accommodate an indoor play space, enlargement of existing footprint of existing one-story gymnasium at 163 West 78th Street.
