Columbus House, located at 95 West 95<sup>th</sup> Street (The "Building"), currently contains two unattended accessory parking garages on West 96<sup>th</sup> Street, with separate entrances and curb cuts, each with a capacity of 49 cars.

Under the applicant's proposed project, the eastern garage, in the R9 district, will remain an accessory parking garage and become an attended accessory parking garage with 55 spaces. A pedestrian access route will provide direct access from the Building to this accessory garage.

The Special Permit (C070381 ZSM Cal. No. 8), which lapsed on October 29, 2011, will allow the western garage, located in the C1-9 portion of the site, to be converted to a public parking garage with 100 spaces, 43 of which will remain for accessory parking.

THEREFORE, BE IT RESOLVED THAT Community Board 7/Manhattan **approves** application N 120092CMM to the Department of City Planning by Columbus 95<sup>th</sup> Street LLC for the renewal of the Special Permit that allows the conversion of an existing 49-car accessory garage to a public parking garage with 100 spaces, 43 of which will remain as accessory.

Re: PCBs in public schools.

Full Board Vote: 35 In favor 0 Against 0 Abstentions 0 Present

The following facts and concerns were taken into account in arriving at our conclusions:

On November 16th 2011 the Youth Education and Libraries Committee held a public Hearing on PCBs and heard from officials from the School Construction Authority (SCA), the Environmental Protection Agency, the Dept. of Health, UFT, Assemblyperson Linda Rosenthal and parents. The previous month, there was a presentation to the committee from the New York Lawyers for the Public Interest regarding their lawsuit on behalf of NYC school parents on PCB remediation and notification efforts.

We fully support two recently passed city council legislation: Local Law <u>68/2011</u> which requires the DOE to inform parents no later than April 15, 2012, and annually thereafter on November 15, whether their child is attending a school with PCB lights. In addition, if the DOE tests a school for PCBs, it now must notify parents within 7 days of the test results. Local Law <u>69/2011</u> which requires the DOE to provide detailed annual reporting to City Council regarding the progress of its citywide PCB remediation plan.

The Environmental Protection Agency in a letter dated December 2011 to local private and parochial schools stipulates that:

- "Polychlorinated biphenyls (PCBs) are classified as suspected carcinogens, PCBs have been demonstrated to cause a variety of adverse health effects, including cancer in animals, and can damage the immune, reproductive, nervous, and endocrine systems. The different health effects of PCBs may also be interrelated. Effects on children and pregnant women are the greatest concern."
- "If lighting fixtures and other products manufactured prior to 1979, they should be assumed to be PCB containing and must be properly disposed of as hazardous material. If leaking PCB containing equipment is found in a building, federal law requires that steps be taken to decrease any potential exposure and to remove and dispose of the PCBs in accordance with the law."
- "Numerous school buildings across the state have undergone lighting retrofits since 1979 in an effort to conserve energy and PCB containing lighting fixtures may have been removed as a result. Those facilities may no longer have PCBs in electrical lighting components in the school, but this should be verified."
- "By removing fixtures that contain PCBs, school districts will not only prevent potential exposure to PCBs, but also can significantly improve energy efficiency at schools, save on electricity bills and reduce green house gas emissions."

At the 11/16/11 YEL meeting, the EPA indicated their recommendation that the SCA complete the remediation of PCB containing lighting within a 2 -3 year timeline.

The SCA has developed a 10-year remediation plan that does not include follow-up testing or testing in schools that are not considered potentially contaminated.

A ten-year timeframe is far too long and potentially exposes children to dangerous levels of long- term exposure to PCB contamination.

The SCA is governed by New York State.

**THEREFORE, BE IT RESOLVED THAT** Community Board 7/Manhattan requests that John King of the NY State Department of Education instruct the SCA to expeditiously inspect all schools constructed before 1978 for PCB contamination in lighting fixtures; and that the SCA lighting fixture remediation program be completed within the EPA recommended 2-3 year timeframe.
