NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION

No. 1: **IN THE MATTER** of the intent to award as a concession a license agreement to Busters Marine Bronx Marina for the Renovation, Operation, and Maintenance of a full-service marina at Bayside Marina, in the borough of Queens. The license will provide for one (1) twenty (20) year term.

NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION

No. 2: **IN THE MATTER** of the intent to award as a concession a license agreement to NY Tennis at Central Park, LLC for the Renovation, Operation, and Maintenance of the Central Park Tennis Center, including a Tennis Professional Concession, a Pro Shop Concession, and a Snack Bar Concession in Central Park, in the borough of Manhattan. The license will provide for one (1) twenty (20) year term.

NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION

No. 3: **IN THE MATTER** of the intent to award as a concession a license agreement to Douglaston GC LLC for the Renovation, Operation, and Maintenance of the Douglaston Golf Course, in the borough of Queens. The license will provide for one (1) twenty (20) year term.

NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION

No. 4: **IN THE MATTER** of the intent to award as a concession a license agreement to Clearview Golf LLC for the Renovation, Operation, and Maintenance of an 18-Hole Golf Course and Clubhouse at Clearview Golf Course in the borough of Queens. The license will provide for one (1) twenty (20) year term.

NEW YORK CITY DEPARTMENT OF SMALL BUSINESS SERVICES

No. 5: **IN THE MATTER** of the intent to seek Franchise and Concession Review Committee approval pursuant to Section 1-16 of the Concession Rules of the City of New York, to allow New York City Tourism + Conventions, on behalf of the NYC Department of Small Business Services, to utilize a different procedure, to enter into a Sole Source License Agreement with New York Popular, Inc for the non-exclusive use of city-owned trademarks on merchandise. The Agreement shall commence on January 1, 2024, and shall continue through December 31, 2026, with an optional renewal period commencing on January 1, 2027 and continuing through December 31, 2028, exercisable at the sole discretion of SBS.

NEW YORK CITY DEPARTMENT OF SANITATION

No. 6: **IN THE MATTER** of the intent to award as a concession a license agreement to Duramax Holdings LLC, d/b/a Otto Environmental Systems, for the sole rights to manufacture and sell NYC-branded individual refuse and recycling bins to NYC residents. The agreement will provide for one (1) ten (10) year term with two (2) five (5) year renewal options, exercisable at the sole discretion of DSNY.
