#### NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION

**No. 1: IN THE MATTER** of the intent to award as a concession a license agreement to Nandita, Inc. for the renovation, operation and maintenance of a Snack Bar at Harlem Meer, Central Park, Manhattan. The license will provide for one (1) twelve (12) year term.

## **NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION**

**No. 2: IN THE MATTER** of the intent to award as a concession a license agreement to Central Amusement International Inc. for the operation and maintenance of the Coney Island Carousel and Food Service Facility at Steeplechase Park, Brooklyn. The License will commence upon written Notice to Proceed and shall terminate on May 24, 2037, with up to one (1) sixmonth renewal option, exercisable at Parks' sole discretion.

## NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION

**No. 3: IN THE MATTER** of the intent to award as a concession a license agreement to Cirque du Soleil America Newco, Inc. for the operation and maintenance of Seasonal Programming and other services at Randall's Island Park, Manhattan. The License will commence upon written Notice to Proceed and shall terminate on May 18, 2025, with four (4) one-year renewal options, exercisable at Parks' sole discretion.

### NEW YORK CITY DEPARTMENT OF PARKS AND RECREATION

**No. 4: IN THE MATTER** of the intent to award as a concession a license agreement to SSC&R LLC for the renovation, operation, and maintenance of a food service facility and special event concession at the South Shore Golf Course, Staten Island. The License will commence upon Notice to Proceed and end no later than January 15, 2044.

#### NEW YORK CITY DEPARTMENT OF TRANSPORTATION

**No. 5: IN THE MATTER** of the intent to seek Franchise and Concession Review Committee approval to utilize a different procedure, pursuant to Section 1-16 of the Concession Rules of the City of New York, to enter into a Sole Source License Agreement with the Times Square District Management Association, Inc. d/b/a/ Times Square Alliance for the operation and management of a pedestrian plaza located at Broadway and 7<sup>th</sup> Avenue between 41<sup>st</sup> Street and West 53<sup>rd</sup> Street in the Borough of Manhattan. The License provides for (1) one (5) five year initial term, commencing upon written Notice to Proceed, which may be renewed for up to two (2) additional five-year terms, exercisable at DOT's sole discretion.
