# Notice of Public Hearing and Opportunity to Comment on Proposed Rules

**What are we proposing?** The Procurement Policy Board (PPB) is proposing changes to the PPB Rules to update the language for agency purchasing of subscriptions, both electronic and paper.

**When and where is the hearing?** The PPB will hold a public hearing on the proposed rule. The public hearing will take place June 7, 2023, at 11:00am. The hearing will be at 255 Greenwich St, 9<sup>th</sup> Floor in the Borough of Manhattan.

• **By speaking at the hearing (in person).** Anyone who wants to comment on the proposed rule at the public hearing must sign up to speak. **Is there a deadline to submit comments?** The deadline to submit written comments will be June 7, 2023.

**What authorizes the PPB to make these rules?** Sections 1043 and 311 of the New York City Charter authorize the PPB to make the proposed rules. This proposed rule was not included in the PPB's regulatory agenda for this Fiscal Year because it was not contemplated when the PPB published its agenda.

Where can I find the PPB's rules? The PPB's rules are in Title 9 of the Rules of the City of New York.

**What laws govern the rulemaking process?** The PPB must meet the requirements of Section 1043 of the New York City Charter when creating or changing rules. This notice is made according to the requirements of Section 1043 of the New York City Charter.

### Statement of Basis and Purpose of Proposed Rule

This proposed Procurement Policy Board Rule (PPB) amendment would update the provisions of the PPB Rules relating to subscription purchasing to account for modern technologies and changes in industry practices.

The PPB is proposing an amendment to PPB Rule 1-02(f)(5) that would streamline the process for agencies to purchase physical and electronic subscriptions, by clarifying and broadening the definition of subscriptions, thereby allowing agencies to purchase necessary books, periodicals, training, and training materials outside of the procedures set forth in the PPB Rules.

The PPB's authority to promulgate these rules is found in section 311 of the New York City Charter. On April 27, 2023, the PPB voted to initiate the rulemaking process under the Citywide Administrative Procedure Act for this rule amendment.

"Shall" and "must" denote mandatory requirements and may be used interchangeably in the rules of this department, unless otherwise specified or unless the context clearly indicates otherwise.

# SECTION 1. PARAGRAPH (5) OF SUBDIVISION (f) OF SECTION 1-02 OF TITLE 9 OF THE RULES OF THE CITY OF NEW YORK IS AMENDED TO READ AS FOLLOWS:

(5) subscriptions[, including] <u>to research databases; paper or</u> electronic subscriptions[,] for magazines, [and] <u>newspapers, other</u> periodicals, [orders for] <u>or</u> books [and "] <u>;</u> off-the-shelf["] training [videotapes,] <u>materials including, but not limited to, webcasts, courses,</u> <u>programs, videos, and assessments;</u> and attendance at standard commercially-available training seminars<u>or subscriptions to organizations providing such seminars</u>.
