



NYC Hazard Mitigation Plan (HMP)


Local and State jurisdictions must have a FEMA-approved mitigation plan to receive FEMA Hazard Mitigation funds.

Eligible for FEMA Funds – approximately \$250M+ million HMGP is being pursued by NYC. Current plan expires on April 17, 2019.














New Approach: 2019 Hazard Mitigation Plan






New York City worked with the **New York City Panel on Climate Change (NPCC)** to develop a series of "future" flood maps to guide local resiliency and mitigation efforts. These forward-looking maps were created by using a simplified bathtub model approach that combined the NPCC's "high end" sea-level-rise projections with FEMA's Flood Insurance Rate Maps (FIRMs).

These future flood maps use high-end projections of sea level rise to illustrate how the 1 percent annual chance floodplain could increase over the next several decades. The accuracy of these flood projections is limited, because they were not developed with advanced coastal modeling. Although these maps are not suitable for evaluating individual-property risks, they are extremely useful for public education about the extent of future flood risks.

In 2016, FEMA announced that it would begin a new process to revise New York City's flood maps, following the City's appeal of the FEMA's 2015 FIRMs. In addition, FEMA and New York City will work together to incorporate the growing risks of climate change and sea level rise in an innovative future flood hazard map product. 


- Database of historic severe weather events and associated consequences







Total Projects in 2018




Completed Projects Since 2014





During Winter Storm or Extreme Cold







Following a Winter Storm or Extreme Cold

Assess and Report Needs

- Call 311 to report dangerous conditions, downed trees, electricity or heat loss, or if you see someone in need of assistance.
- Check on your neighbors.
- Clear snow and dangling ice from roofs, sidewalks, curb cuts, and hydrants.

NYC Snow Removal Fact Sheet

NYC Snow Removal Fact Sheet

- Property and Business owners must clear the snow as follows:
- If snow ends between 7 AM and before 5 AM snow must be cleared within 4 hours
- If snow ends between 5 PM and before 9 PM snow must be cleared within 14 hours
- If snow ends between 9 PM and before 7 AM snow must be cleared by 11 AM





Visor Cards

- Sent to over 11,000 people who are registered with the DMV as deaf or hard of hearing
- Received a cover letter, instructions, and a laminated card
- Distributed at NYPD Resource Fairs
- Available on NYPD website
- All Radio Cars have a Visor Card available for use if necessary





THE POLICE COMMISSIONER

Dear New York City Driver,

We are writing to tell you about a new tool to make communication between you and the police easier. You are receiving this because you have a driver's license with a class F1 restriction. The NYPD collaborated with service providers and advocacy organizations to create the enclosed Visor Card for people who are deaf or hard of hearing. We believe the card will improve communication if the police stop you for a traffic violation.

We have enclosed a copy of the Visor Card and a set of instructions. The Visor Card should be attached to the driver's side sun visor. If the card is lost or damaged, you can download and print a copy from the NYPD's website: nyc.gov/nypd.

While no one wants to be pulled over, we hope you find the Visor Card and instructions a useful tool in the event that you are.

IF THE POLICE STOP YOU, FOLLOW THESE STEPS:

- Your Visor Card should be attached to the driver's side sun visor.
- Open your driver's side window. If it is dark, turn on your vehicle's dome light.
- Place both of your hands near the top of the steering wheel.
- When the officer is at your window, point to your Visor Card and remove it from the sun visor. Hand it to the officer.
- The officer can use the Visor Card to instruct you on what to do next. The pictures on the card can help both of you communicate better.




