### Provider Spotlight: Special NOFO Series

In the sixth installment of our ongoing Provider Spotlight: Special NOFO Series, this month the CoC would like to spotlight **Safe Horizon** who was recently awarded funding from HUD's [Special NOFO](#) for their project **Safe Horizon Streetwork Project - Street outreach and homelessness prevention for unsheltered youth up to age 25**.

For 40 years Safe Horizon has been helping move victims of all crime and abuse from crisis to confidence. Safe Horizon was founded in 1978 as a pioneering pilot program in New York City's court system to support witnesses who had been intimidated or felt too threatened to testify. Today they are the largest victim services organization in the country, touching the lives of more than 250,000 individuals each year. 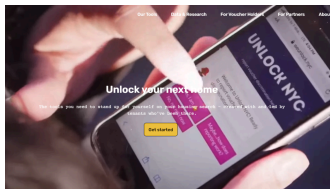
