Description: Individuals experiencing homelessness often have complex medical and behavioral health needs. For those who end up hospitalized, their lack of stable housing can be a barrier to safe discharge. When these patients no longer require inpatient-level care, they need a safe place to recuperate. Medical respite is a coordinated system of care that provides patients experiencing homelessness with a safe place to recover coupled with short-term supports.

The Mayor's Office of Community Mental Health (OCMH) is launching a pilot Behavioral Health Community Health Worker (BH-CHW) apprenticeship in early 2025. Developed in collaboration with CUNY, Hostos Community College, the Healthcare Career Advancement Program, and nonprofit health and human service organizations, this will be the first nationally recognized apprenticeship of its kind.

NLIHC Releases The Gap: A Shortage of Affordable Homes

NLIHC released its annual report, [The Gap: A Shortage of Affordable Homes](#), which finds that the lowest-income renters in the U.S. face a shortage of 7.1 million affordable and available rental homes. Findings also show that three-quarters of renters with extremely low incomes are severely housing cost-burdened, spending more than half of their income on rent.
