2019 NOFA

Martha Kenton (DSS) gave the following updates on the 2019 NOFA:

- 13 new project applications were submitted this year. All applications were reviewed by the Review Committee, and 10 applications will be put forward in the NOFA. Scores are now being finalized. There are a few new organizations who submitted new project applications this year.
- The Domestic Violence Bonus is available again in this NOFA. NYC CCoC is able to apply for up to \$5million in funding.
- NOFA Renewal application review is almost complete. DSS FHPR is providing feedback and answering provider questions.
- The Independent Review Team (IRT) met and has decided to continue prioritizing renewal
 projects over new projects in Tier II. The IRT still has some decisions left to make, but DSS
 will be sure to share all IRT decisions with the Steering Committee for discussion.
- The CoC website has been redone and will be live for everyone to see in the coming weeks.
 An announcement will be sent with a link to the new website, but you will still be able to access it by visiting www.nychomeless.com. The new website has been rebranded and reorganized, and is fully accessible.
