Annual Meeting

Appointment of Continuum of Care Co-Chairs

Martha Kenton (DSS) explained the process for appointing Co-Chairs of the Continuum. There is a permanent seat for the Collaborative Applicant, DSS. There were no new nominations for Co-Chair. William Lang made a motion to appoint Laura Mascuch (The Network) and Jeannette Ruffins (West



End Residences) as Co-Chairs of the NYC Coalition on the Continuum of Care. The motion was seconded by Rob Robinson and passed by unanimous voice vote.

HOPE Count

Martha Kenton (DSS) announced that the 2019 HOPE Count will take place on January 28th from 10pm-4am. All CoC funded organizations should plan to send at least 10 volunteers. Martha is District Captain, and her site will be at PS 191. The site is not full yet if anyone wants to sign up to volunteer. Cameron Craig requested that the Bus Shelter by the George Washington Bridge be included in the HOPE count next year.

Evaluation

Charlie Winkler (DSS) announced that the preliminary evaluation scores were distributed on Friday, 01/04/2019. The Data Adjustment Period will last through January 25th. There were five de-brief sessions held to discuss the process and scoring this year. Please do not wait until the 25th to send in your data adjustment requests. The next round of adjusted scores are scheduled to be released on Friday, February 1st. Appeals will be accepted until February 15th. Appeals are for policy based adjustments needed to scores, not based on data adjustments. An Ad Hoc Appeals committee will be convened following 02/15 to discuss the appeals received. Final scores are scheduled to be released on March 1st. If you have suggestions or comments on the Evaluation process, Survey, or Automated Tool, please plan to attend the March Evaluation Committee meeting. The Evaluation Committee will meet throughout March, April, and May to make adjustments to the Survey and Tool, with the goal of having the Steering Committee adopt all Evaluation Components in June.

HMIS and HIC-PIT Updates

Michael Brydges (DSS) announced that the HMIS Team has been working on HMIS alignment with the HIC-PIT. He announced that HUD now requires that everything in the HIC has to be in HMIS. The HMIS Team will reach out if you need to create a program in HMIS in order to meet this HUD requirement. HUD is moving towards the HIC being run out of HMIS. HUD is also now requiring that a program be 100% dedicated in HMIS, that you must either upload all clients, or none, you cannot upload a portion of clients in a program. The Survey will be sent out after HOPE. The HMIS Team is talking with Foothold about 2019 HMIS Trainings, and dates will be announced when details have been finalized.
