





## What is a NOFO?



A **Notice of Funding Opportunity (NOFO)** is HUD's formal announcement of available federal funding for the CoC Program.

The **Collaborative Applicant** is the entity responsible for overseeing, preparing, and submitting the **Consolidated Application** to HUD.

Release Date: November 13th, 2025 Due Date: January 14th, 2026

Total Funding: \$3.918 billion

#### **Funding Tiers:**

- Tier 1 is set at 30% of a CoC's ARD (\$52,851,190). This is a stark departure from previous years (always above 90%).
- Tier 1 is a priority funding line above which projects are considered likely to be funded.
- Tier 2 is competitive and there is a greater risk of losing funding.

#### Cap on Permanent Housing:

- No more than 30% of a CoC's ARD will fund Permanent Housing Projects (PSH and RRH)
- 93% of the NYC CoC's total portfolio consists of PSH and RRH (\$162,233,248)
- This means a potential loss of \$109,387,057 in Permanent Housing (PH) for the NYC CoC


#### **Funding Focus:**

 HUD has new focus on funding Transitional Housing (TH) and Supportive Services Only (SSO) projects including street outreach.

2025 Breakdown:

Tier One (30% ARD) \$52,851,190

Tier Two (70% ARD) \$123,319,443

Cap on PH (30% ARD) \$52,851,190

**Note:** Decisions regarding Tier 1 and Tier 2 prioritization will be made by the NYC CoC Steering Committee and carried out by the Independent Review Team (IRT) at a later date.

#### **New HUD Priorities**

- "Ending Crisis of Homelessness on Our Streets" direct resources toward outreach and regaining self-sufficiency, working with law enforcement to reduce encampments
- "Prioritizing Treatment & Recovery" TH and SSO to improve health and long-term independence, treatment and services, behavioral health, robust wraparound services and participation requirements.
- "Advancing Public Safety" cooperate with law enforcement on keeping street safe – funding priority toward jurisdictions that prohibit public illicit drug use and public camping
- "Promoting Self Sufficiency" partner with workforce development and other supportive services
- "Improve Outcomes" expanding pool of providers through reallocation and include faith-based providers
- "Minimize trauma" provide trauma informed care and ensure safety with single-sex spaces





**GOAL One:** To minimize the impact on our program participants

**GOAL Two:** Optimize a plan for retaining CoC funding in NYC.

#### U.S. District Court of Rhode Island v. HUD

 November 25, 2025 – A coalition of 19 states (including New York) and two governors filed a lawsuit against HUD over new policy changes to the CoC program.

#### National Alliance to End Homelessness (NAEH) v. HUD

 December 1, 2025 - NAEH and several partner organizations filed new litigation challenging HUD's FY 2025 CoC NOFO.

**Update:** The courts have combined these two lawsuits for the preliminary injunction hearing. The next hearing is scheduled for Friday, December  $19^{\text{th}}$  at 10am.

### Existing Project Action Items 🔄



**GOAL:** Ensure you and your organization's leadership is aware of the risk to existing CoC project funding

- **1. Understand CoC Funding Usage:** Review how CoC dollars are allocated and spent within your CoC-funded projects.
- **2. Plan for Reductions:** Engage your finance team and develop a contingency plan to prepare for potential funding cuts.
- **3. Assess and Strategize:** Identify critical priorities, consider project right-sizing, and explore alternative funding sources.
- **4. Coordinate with Other Funders:** If your project receives multiple funding streams, notify your partners or contract agencies about the potential loss or delay of CoC funds.

### **New Project Action Items**



#### **Transitional Housing (TH):**

- CoC funded TH provides time-limited housing (typically up to 24 months) for individuals and families experiencing homelessness.
- TH includes robust supportive services and is designed as a bridge to permanent housing.
- TH can be effective for populations with higher service needs (youth, survivors of domestic violence, substance use, etc.). It can assist those with high barriers to housing placement and facilitate the placement by covering furniture, utilities, and related initial housing costs.

#### **Supportive Services Only (SSO):**

- CoC funded SSO projects allow recipients to provide supportive services to families and individuals experiencing homelessness.
- Examples include street outreach, housing navigation, street medicine, and care coordination.
- Programs should take a holistic, multi-disciplinary approach that maximizes use of community partnerships and resources to help move people quickly to a housing solution.
