 - % Placed Rapidly
 - % Increasing or Maintaining Income
 - Data Quality
 - Target # Served compared with 2023 E-Snaps
- Posted on CoC Website by Grant #
- No action on your part just complete Local Priorities Survey (LPS)

LPS

New York City Department of Social Services

May 30, 2024

- Completed for each CoC-funded project. (i.e., 1 project = 1 survey; 5 projects = 5 individual surveys
- Based on <u>Contract Year</u>, that ended in 2023
- No documentation to upload
- Approximately 15-30 minutes to complete a Survey
- Do it in a single sitting: *SurveyMonkey* results cannot be saved!
