City Council Updates Bill Giving Housing Groups First Dibs in Purchasing Troubled Apartment Buildings

The NYC Council recently made changes to the Community Opportunity to Purchase Act (COPA). A bill which allows housing preservation groups the chance to make an offer on a property before it goes to market when an owner notifies the city of the intent to sell. The update to the bill alters the range of buildings that would have to be offered for preservation group purchase, expand the types of buyers and truncate the transaction timeline.
