### NYC Continuum of Care's (CoC) June 2023 Public Meeting Recap

Thank you for attending the NYC Continuum of Care's (CoC) June 2023 Public Meeting! After almost three years, it was great getting to connect with so many new and returning members of the Continuum. Save the date for the next public meeting **Friday, September 8th from 9:00am -12:00pm**

#### Opening Remarks & Special Remarks

The Public Meeting was kicked off by Howard Charton (Breaking Ground), who gave opening remarks, followed by a moment of silence for Mary Hall. HUD Regional Administrator for Region II, Alicka Ampry-Samuel issued special remarks during the meeting.

#### NYC CoC Updates

NYC CoC team delivered updates on NOFO 2023, including an overview of the Grant Inventory Worksheet (GIW), which was submitted to the HUD field office. The SNAPS office will post the revised GIW to HUD.gov on **July 28th**.

### Other Funding Opportunities

#### SAMHSA Portable Clinical Care Pilot Project

This project aims to pilot an approach to comprehensive healthcare for racial and ethnic medically underserved people experiencing unsheltered homelessness through the delivery of portable clinical care delivered outside, with focus on the integration of behavioral health and HIV treatment and prevention services. Up to \$2 Million in total, up to **\$666,666 per year each award**.
