CoC Speaker Series: Point Source Youth and Henry Street Settlement

The CoC presents the first installment in our Speaker Series. Please join staff from Point Source Youth and Henry Street Settlement to learn more about their Targeted Housing Assistance Program pilot, where 46 youth received an average of \$3,945 after one month, including 100% of youth remain stably housed. During the webinar, PSY and HSS will share more about the model, research, and plans for potential expansion in New York City.

The program was designed with the understanding that every young person's challenges and needs are unique, and each participant works with a local service provider to develop a housing plan to meet their particular needs and to help stabilize their housing crisis.

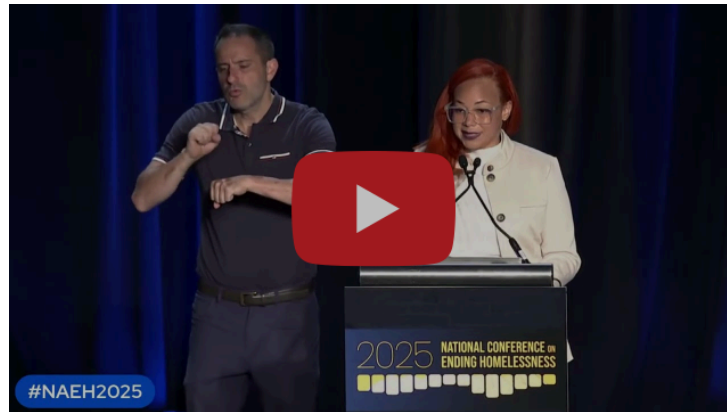

The Fairness in Apartment Rental Expenses (FARE) Act is Live!

The Fairness in Apartment Rental Expenses (FARE) Act took effect on June 11, 2025. "This law prohibits brokers who represent landlords from charging broker fees to tenants. This includes brokers who publish listings with the landlord's permission. Landlords or their agents must disclose other fees that the tenant must pay in their listings and rental agreements".

Governor Hochul Announces \$1 Billion for nearly 3,000 Homes in New York

Governor Kathy Hochul recently announced that New York State received \$1 billion in housing bonds and subsidies to create or preserve nearly 3,000 affordable, modern, energy-efficient homes. This initiative, which is a part of the Governor's five-year, \$25 billion comprehensive Housing Plan that will create or preserve 100,000 affordable homes across New York States. Seeking to increase the housing supply, making the State more affordable.

Nevada Passes Bill to Secure Permanent Supportive Housing Funds

CSH shared that in June, the Nevada state legislature passed Assembly Bill 366 (AB366) with unanimous bipartisan support. This bill was a major state-level policy win that permanently embeds funding for supportive housing into the Governor's state budget.

What makes **AB366** a model for other states?

- **Permanent funding:** Supportive housing is now a recurring line item in the Governor's budget.
- **Substantial appropriation for supportive housing:** The \$21 million appropriation builds upon the \$32 million allocated through AB 310 in 2023.
- **Accountability and impact:** It establishes that the Nevada Housing Division evaluates outcomes and scales efforts.
- **A policymaker champion for bipartisan support:** A testament to Assemblywoman Monroe-Moreno's effective policymaking and cross-aisle leadership.
- **Strong advocacy and private-public collaboration:** CSH's local, regional, and national staff worked tirelessly to establish and build relationships with state lawmakers.

The collaborative efforts by the Los Angeles Homeless Services Authority (LAHSA), its partners at the City and County, and service providers have led to a decline in homelessness for the second straight year across Los Angeles County, **falling 4% to 72,308**. The City of Los Angeles also saw a downward trend, **falling by 3.4% to 43,699**.
